- Improve administration




## 2. Knowledge preservation



## **Training**

- All of the employee should be trained and retrained.
- Every new employee will has one skilled mentor.
- The training course should consist all internal knowledge and necessary external knowledge.
- The new employee should make a report to his/her job skill to show if he/she has master enough knowledge to the job.





## **Working process**

- Identify two kinds of process: administration process and technical process.
- The employee with high level skill are asked to create or improve the process.
- The experts group is asked to make the checklist to all main work.

- Standardization
- System establishment
- Performance assessment
- Continuously improve

- Collect all of the data about FR activities;
- The data of CEFR is real time;

- Keep the interface to accept external data.




# The China FR data base system






## Structure of China fast reactor information database (preliminary)




## Topological graph






