Associations are the sole mechanism by which customer success, performance, and skilling subcategory points are acknowledged and calculated towards achieving Solutions Partner designation(s).



Without these associations in place, partner capability score points are not recognized.

Claiming Partner of Record (CPOR) partner association

How does CPOR work and what are the benefits?

What is CPOR?

Claiming Partner of Record (CPOR) allows a partner to be recognized for servicing a customer's Microsoft cloud environment.

CPOR allows only one partner of record per workload or product. However, multiple partners can be associated to the same customer for different subscriptions or workloads.

Counts toward partner capability scores for Modern Work, Business Applications and Security net customer adds, deployments and usage growth.

What is it used for?

Some types of CPOR are used to allocate incentives, while other types of CPOR are used to recognize partner associated or influenced revenue or usage but are not eligible for incentives.

Associate with your customer via the "usage" option if you drive their adoption and usage of an eligible product/workload.

Associate with your customer via the "pre-sales" option if you influenced their selection of an eligible product.

Associate with your customer via the "revenue association" option if you influenced their selection of an eligible product as a Business Influencer.

Process

Partners initiate the claim process and submit a claim within the Incentives workspace in [Partner Center](#).

Make CPOR claim associations at the subscription or workload level.

Provide required Proof of Execution (POE) for each incentive claim (if required by type of CPOR).

Your claim will be validated by both Microsoft and customer.

Types of CPOR

Online Services Usage M365

Allows incentive associations, and usage associations (non compensable) per workload and is licensing agnostic.

Online Services Advisor (OSA Sell)

Allows incentive associations and revenue associations per subscription (non compensable) under Enterprise Agreement, CASA/EES, and Web Direct (MOSA).

Online Services Usage Business Applications

Allows incentive associations only per subscription under Enterprise Agreement and CASA/EES licensing.

RevRec

Allows revenue associations per subscription (non compensable) under Enterprise Agreement, CASA/EES, and Web Direct (MOSA).

CPOR: Usage vs. Revenue recognition

Why claim Revenue Association?



Revenue association available for Business Applications partners is the primary way in which partners achieve revenue recognition and contribute to demonstrating impact with their customers.

Revenue recognition for non-incentivized workloads gets recognized automatically and you will not have to submit Proof of Execution (POE). Available under Enterprise Agreement, legacy CSP, CASA/EES, and Web Direct (MOSA) licensing models only. Please note POE is not required for revenue association at this time.

Why claim for Usage Recognition?



Usage recognition available under M365 (Modern Work & Security) and Biz Apps allows you to claim for the work that you are driving with your customer and be recognized as their partner of record by Microsoft. Please note some usage associations may earn incentives.

Usage recognition for non-incentivized workloads get recognized automatically and you will not have to submit Proof of Execution (POE).

CPOR association types

The CPOR claiming platform allows for CPOR association claims related to Business Applications and Microsoft 365 solution areas as well as recognition outside of these programs (see non compensable associations below). Select the correct activity based on the descriptions to avoid having to reclaim in the future. Claiming with an incorrect activity may result in missed eligibility, Solutions Partner attainment, and incentive earnings.

How to complete a Claiming Partner of Record (CPOR) association

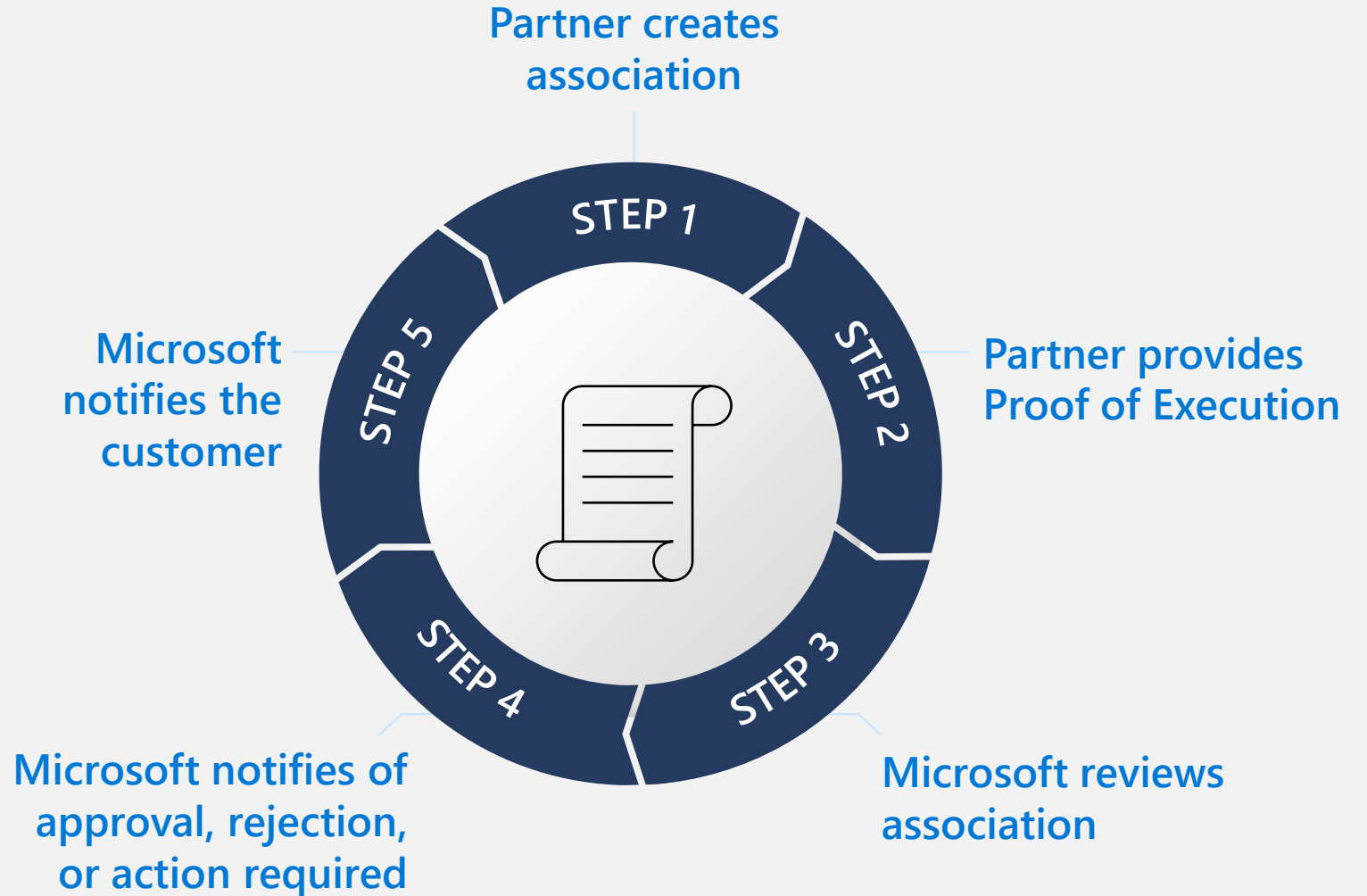
Customer association process

After you create a new customer association, Microsoft will verify the details of the association and proof of execution provided to ensure its accuracy.

If you and another partner claim for the same customer and product/workload, Microsoft will review each partner's proof of execution documentation to determine which partner to approve.

Additional information might be requested from both partners which could cause delays in processing your association request.

If your association is approved Microsoft will notify the customer.



Creating an association

Partner/customer CPOR FAQ

How do I explain CPOR to a customer?

- CPOR enables Microsoft to identify and recognize those partners who are helping customers achieve business objectives and realize value in the cloud. Once an advisory partner associates to a workload or subscription they will only obtain access to the usage and/or sold seats data for the products/workloads they have claimed. This enables partners to monitor active usage and utilization while providing customers with recommendations of how to maximize usage. Partners will only have access to the daily usage and seats/sold feed for workload/products they are associated to in the period in which they are attached as partner of record. Partners will not have access to any other transactional or usage data.
- Additionally, this association helps Microsoft understand the ecosystem of our service providers and to refine the tools and programs needed to best support our common customers.
- There is no action required for the customer, we allow customers the opportunity to opt out. Customers will receive a notification informing them of the association request for partners. If a customer denies association to a partner, they will not be able to be recognized as the partner of record. When you engage with your customer, Please ensure that the customers tenant administrator (this is the person receiving the notification) is aware of the engagement so that they do not decline the consent request.



Partner/customer CPOR FAQ

Can more than one partner have CPOR for the same workload?

CPOR allows only one partner of record per workload or product. However, multiple partners can be associated to the same customer for different subscriptions or workloads.

I was disassociated, why? How do I fix this? I was expecting incentives, how do I escalate?

If you were disassociated, it is due to another partner claiming for the same subscription/workload. If you believe you are the right POR, we ask you to re-claim via CPOR providing updated POE that proves you are the partner driving the most influence to the customer's environment.

We have many PartnerIDs. Which one should we use for OSUM365? I claimed for the wrong PartnerID, how do I fix it?

You should claim with your partner location ID only, and one rolls up to the partner global account (PGA) you want to get the partner capability score credit for the association. If you have claimed with the wrong PartnerID, you will need to submit a new claim.

At what point is our eligibility determined, upon submission of the claim or the approved date of the claim?

Our systems look at the claim submission date for incentive eligibility. Incentives are however not earned until a milestone has been reached.

What happens if there is an existing partner of record on a claim that I've submitted?

Partners should claim and provide detailed proof of execution documentation as called out in the incentives guide. Microsoft will then review the documentation and determine which partner exerted the greatest influence in driving usage of the customer's workloads.

I'm being asked for more POE, why? It should be sufficient?

If you're being required to submit POE it is due to another partner claiming for the same subscription/workload. Microsoft assesses partner of record adjudications based on the quality of POE. We recommend that you follow the POE guidelines outlined in this deck and in the Incentive Policy Guide for guidance on how to submit quality POE.

Digital Partner of Record (DPOR) partner association

How does DPOR work and what are the benefits?

What is DPOR?

- **Digital Partner of Record (DPOR)** associates servicing partners to a Microsoft cloud subscription. It is an online capability to attach a partner to a customer's Microsoft online subscription.
- Allows only one partner of record per customer.
- Counts toward partner capability scores for Data & AI (Azure), Digital & App Innovation (Azure), Infrastructure (Azure), Modern Work, and Business Applications net customer adds, deployments and usage growth.

What is it used for?

- DPOR is intended to associate a consulting (Systems Integrator) or management (Managed Service Provider) partner with a customer's relevant Azure footprint for the time while the partner is engaged with the customer.
- DPOR is attached at subscription level for each cloud product. Active usage is also calculated at subscription level, except Office 365, which is at customer tenant level. Partners must be added as the DPOR each time a new subscription is established, regardless of whether their customer is new or existing.

Process

- Only a customer can designate a DPOR for their subscriptions. To recognize the partner for that work, the customer adds the partner ID to the subscription via the customer's service portal.

Who is a Digital Partner of Record (DPOR)?

The Digital Partner of Record for Office 365, Microsoft Dynamics CRM Online, Windows Intune, Enterprise Mobility Suite, and Microsoft Azure subscriptions is the partner who is helping the customer *design, build, deploy or manage* a solution that they've built on the service. It is not the partner who sold the subscription.

When should customers add their DPOR?

Encourage your customers to attach a Digital Partner of Record to their subscriptions immediately to make sure you have access to business-critical reporting and support capabilities, and to enable you to qualify for incentives. DPOR is also one way to ensure that you receive credit toward Solutions Partner designations.

Digital Partner of Record (DPOR) automates how partners are attached as the Partner of Record for the subscriptions you are actively managing for customers for Microsoft Office 365, Microsoft Dynamics CRM Online, Microsoft Intune, Enterprise Mobility Suite (EMS), and Microsoft Azure.

DPOR registration



We have enabled online capability to automate how partners are attached as the Partner of Record for Microsoft Office 365, Microsoft Dynamics CRM Online, Microsoft Intune, Enterprise Mobility Suite (EMS), and Azure subscriptions. Customers can designate you as their Partner of Record for subscriptions you are helping them deploy, or for solutions you are helping them design, build or manage.

DPOR improves the partner and customer experience, reduces your cost of doing business with us, and enables automated tracking of cloud performance levels. For Solutions partners, DPOR is one of the ways to register your role in cloud subscriptions to earn points for customer related partner capability score metrics.

Benefits



Partners benefit because it allows them to qualify for solutions partner designations and enables reporting that provides a single view into the revenue, usage, and consumption driven by you. This insight can also be leveraged for cross-sell/upsell opportunities and allows partners to proactively engage customers at risk for non-renewal.

When a partner is registered as the DPOR, it signals to Microsoft's Fast Track services to defer to the DPOR for customer assistance to ensure partner attach.

Customers benefit because it provides their partner with access to performance and usage data so you can provide better service and support to them and help optimize their usage for the desired business outcome.

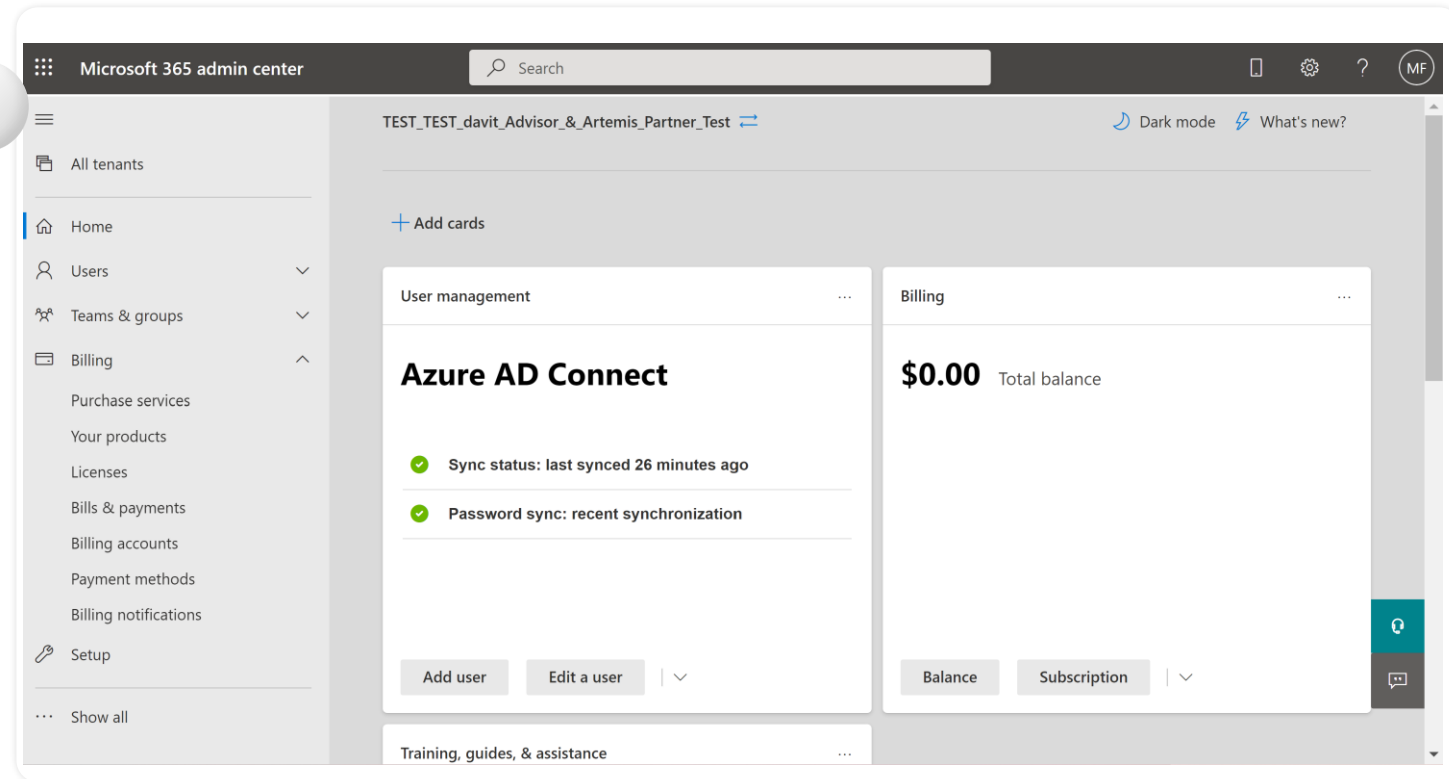



Digital Partner of Record (DPOR) Partner/customer FAQ

Why designate your partner as DPOR?

You have taken the first step to invest in a Microsoft Cloud Service. The next step is to ensure you get the full value of your investment. The partner who sells you the cloud service, and those who may help you deploy or manage it already earn recognition from Microsoft for working with you, but you can additionally benefit by designating your lead Deployment or Management partner as the Digital Partner of Record (DPOR). By designating your partner as your Digital Partner of Record, they can proactively help monitor and manage your service to ensure you are maximizing your investment, helping you achieve your business outcomes, and supporting you throughout the lifecycle of the service. These partners are deeply committed to ensuring the services they provide are customized to your organization and aligned to your business outcomes. Microsoft will also look to this partner first if any issues arise with your service, helping you get back up to speed quickly. Assigning your partner as Digital Partner of Record allows them to:

Provide proactive advice on the right plan based on your desired business outcomes and usage, including when you could save money by using a different Microsoft offering (SKU)

Accelerate your path to realizing value by making sure you successfully activate all required seats/users, and proactively recognizing when a user is unable to access the service

Monitor your system uptime and ensure that everything runs smoothly, meets your business needs, and that your users get the support they need

Provide integrated Cloud Support to support your business outcomes and advise you of planned service outages

Who can attach a Partner of Record?

The administrator role, also known as the owner, is the only role within your tenant or account that can attach a Partner of Record. Service admins, co-admins, and partners who you've designated as delegated admins do not have the ability to change the Partner of Record.

When should I add a Partner of Record to my Azure subscriptions?

We recommend you assign a Partner of Record to your subscriptions immediately. This capability is also enabled for Office 365, CRM Online, AX7, D365, Intune and Enterprise Mobility Suite subscriptions in the admin portal for those services.

Once a DPOR has been assigned can it be changed? Is there a limit to the number of changes possible?

Yes, DPOR designation can be changed, added, removed as many times as customers wish.



When a new subscription is purchased and provisioned (in case of a product upgrade/migration/etc.) will the DPOR designation of the old customer subscription be automatically added to the new customer subscription?

No. In all cases where a new subscription is created, either by necessity (in case of new services being provisioned) or by customer volition, the new subscription will be created and no DPOR will be initially Digital Partner of Record FAQ present until there is one added by the global administrator (owner). This gives the end-customer the control of this designation, and it takes a specific designation step to attach the DPOR.

Can there be more than one DPOR assigned to a subscription at the same time?

No, there can be only one DPOR designated on any single subscription at a point in time.

I am a CSP partner, how do I get DPOR recognition?

There is no DPOR functionality per-se on CSP subscriptions. By being a customer's CSP partner you will automatically get recognition for the consumption and usage that occurs. CSP consumption and usage will count towards a partner's solutions partner designation attainment. CSP partners may also be eligible to earn incentives on CSP usage and consumption. More details on the specific partner incentives are available on the Partner Incentives page.

Once a DPOR has been assigned can it be changed? Is there a limit to the number of changes possible?

Yes, DPOR designation can be changed, added, removed as many times as a customer wishes.

If a customer decides to change their assigned DPOR, will any notification be sent to the old and/or new partner?

Yes, an automatic notification will be sent to the old partner informing them they are no longer the DPOR for that specific subscription. The partner who has been added to the subscription as the DPOR will also receive an email notification to that effect.

Who can attach a Partner of Record?

The administrator role, also known as the owner, is the only role within your tenant or account that can attach a Partner of Record. Service admins, co-admins, and partners who you've designated as delegated admins do not have the ability to change the Partner of Record.

When should I add a Partner of Record to my Azure subscriptions?

We recommend you assign a Partner of Record to your subscriptions immediately. This capability is also enabled for Office 365, CRM Online, AX7, D365, Intune and Enterprise Mobility Suite subscriptions in the admin portal for those services.

How does PAL association work

How does PAL work and what are the benefits?

Using Partner Admin Link (PAL), partners can associate their PartnerID with the credentials used for service delivery whenever they act on behalf of the customer to manage, configure and support Azure and Business Application services (Power Platform and Customer Insights). Unique to PAL is that it allows for different partners to get recognized for the same customer engagement. Partners can be associated to the same workloads and both get 'credit'.

PAL is used for both modern commerce platform (Azure plan) subscriptions & Power Platform and Dynamics 365 Customer Insights services.

Azure Plan

It enables Microsoft to identify and recognize partners who drive Azure customer success. Microsoft can attribute influenced and Azure consumed revenue to your organization based on the account's permissions (Azure role) and scope (subscription, resource group, resource). PAL tracking capabilities are automated and don't require partner input.

Power Platform and Dynamics 365 Customer Insights services

To get credit for the services, you can associate your partner network ID with the Azure credential used for service delivery that's in your customers' production environments using the Partner Admin Link (PAL).

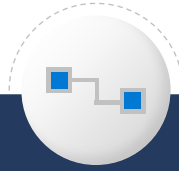
PAL allows Microsoft to identify and recognize partners that have Power Platform and Customer Insights customers. Microsoft attributes usage to a partner's organization based on the account's permissions (user role) and scope (tenant, resource, and so on).

Managed services focus

PAL is optimized to track services delivered by a partner within a customer's Azure, Power Platform, and/or Customer Insights environments.

PAL enables multiple partners to earn recognition for influence within the same customer environment.

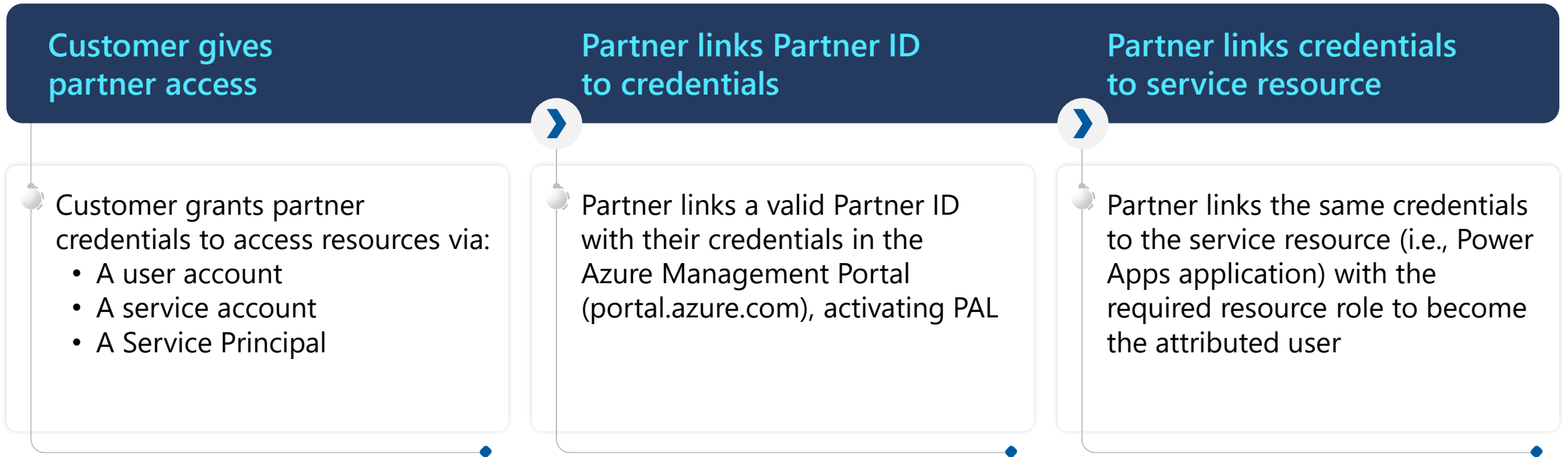

We recommend taking these actions in the sequence on the left.

The attribution step is critical and typically happens automatically, as the partner user is the one creating, editing, and updating the resource (i.e., the Power App application, the Power Automate flow, etc.).

To ensure success, we strongly recommend that you use Solutions where available to import your deliverables into the customer's Production Environment via a Managed Solution. When you use Solutions, the account used to import the Solution becomes the owner of each deliverable inside the Solution. Linking the account to your partner ID ensures all deliverables inside the Solution are associated to your partner ID, automatically handling step #3 on the left.



Get access accounts from your customer

Before you link your Partner ID, your customer must give you access to their Power Platform or Customer Insights resources. They use one of the following options:

Directory account

Your customer can create a dedicated user account, or a user account to act as a service account, in their own directory, and provide access to the product(s) you're working on in production.

Service principal

Your customer can add an app or script from your organization in their directory and provide access to the product you're working on in production.

Link your access account to your partner ID

Linking your access account to your partner ID is also called *PAL association*. When you have access to a Production Environment access account, you can use PAL to link the account to your Microsoft Partner Network ID (Location PartnerID)

For directory accounts (user or service), use the graphical web-based Azure portal, PowerShell, or the Azure CLI to link to your Microsoft Partner Network ID (Location Account PartnerID).

For service principal, use PowerShell or the Azure CLI to provide the link your Microsoft Partner Network ID (Location Account PartnerID). Link the partner ID to each customer resource.

To use the Azure portal to link to a new partner ID:

Sign into the [Azure portal](#).

Go to [Link to a partner ID](#) in the Azure portal.

Enter the Microsoft Partner Network ID for your organization.

- Be sure to use the **Associated Partner ID** shown on your partner center profile.
- It's typically known as your [Partner Location Account PartnerID](#).

Note

To link your partner ID to another customer, switch the directory. Under **Switch directory**, select the appropriate directory.

Attribute your access account to product resource



To count the usage of a specific resource, the partner user or guest account needs to be attributed to that resource for Power Platform or Dynamics Customer Insights. The resource and user requirements vary by product. The access account is the one that you received from your customer. It's the same account that was linked through the Partner Admin Link (PAL).

To ensure success, we strongly recommend that you use Solutions where available to import your deliverables into the customer's Production Environment via a Managed Solution. When you use Solutions, the account used to import the Solution becomes the owner of each deliverable inside the Solution. Linking the account to your partner ID ensures all deliverables inside the Solution are associated to your Partner ID, automatically handling this step.

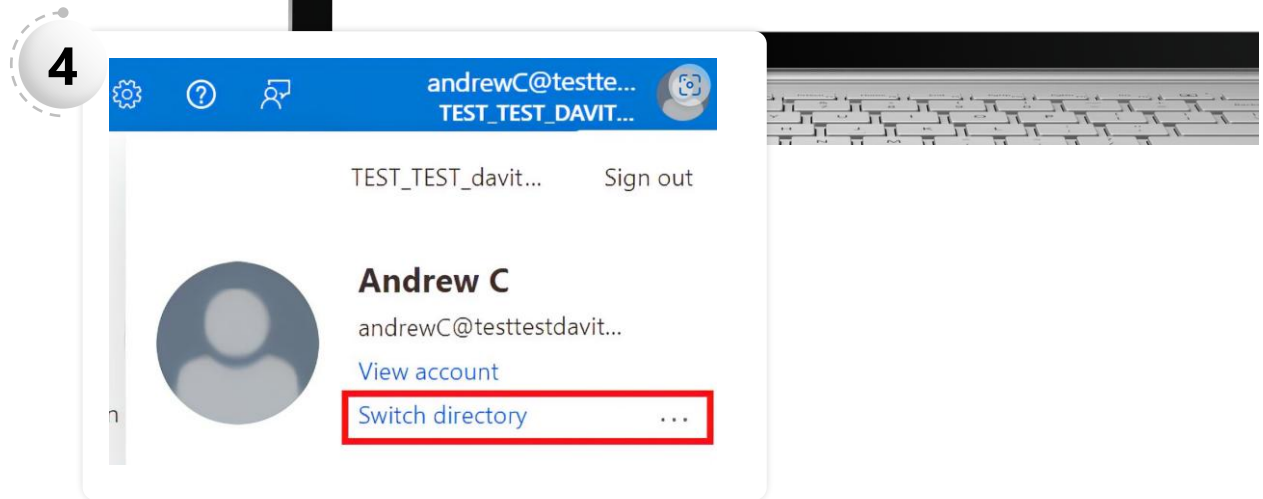
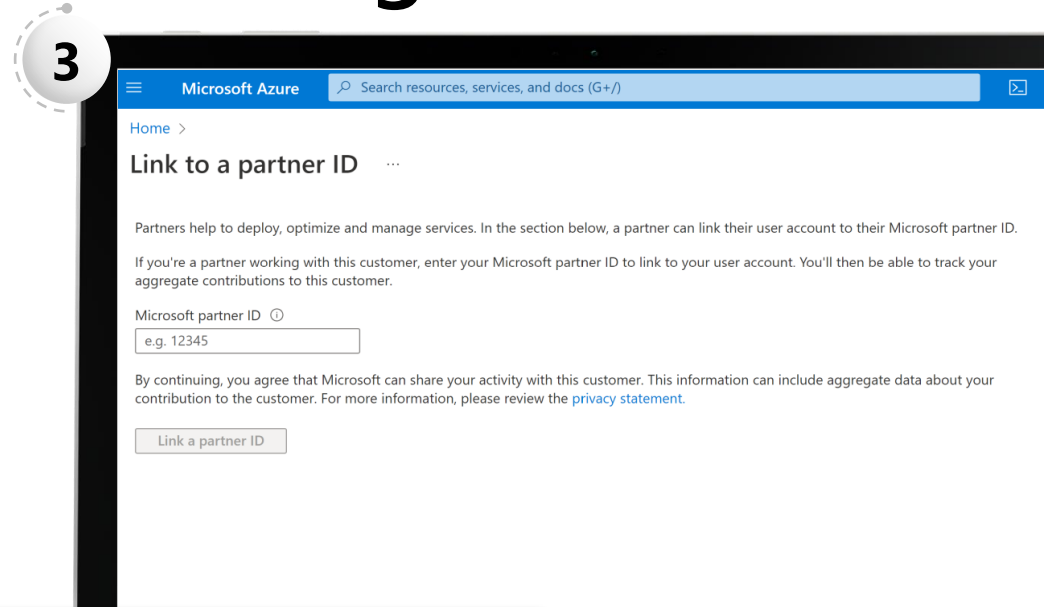
Creating a PAL Link in the Azure Management Portal

1 Go to [Link to a partner ID](#) in the Azure portal.

2 Sign in to the Azure portal.

3 Enter the Microsoft partner ID. The partner ID is the [Microsoft Partner Network](#) ID for your organization. Be sure to use the **Associated PartnerID** shown on your partner profile.

4 To link a partner ID for another customer, select **Switch directory**. Under Switch directory, select your directory or use Advanced filter.

PAL Partner/customer FAQ

How do I explain Partner Admin Link (PAL) to my Customer?

Partner Admin Link (PAL) enables Microsoft to identify and recognize those partners who are helping customers achieve business objectives and realize value in the cloud. Customers must first provide a partner access to their resource. Once access is granted, the partner's PartnerID is associated. This association helps Microsoft understand the ecosystem of IT service providers and to refine the tools and programs needed to best support our common customers.

Is the PAL client information shared outside of Microsoft? What does Microsoft do with partner association? Some clients have a policy of not endorsing vendors.

PAL client and partner association information is not shared outside of Microsoft.

Does this impact security of customer's environment?

PAL association only adds partner's PartnerID to the access already provisioned and does not alter any permissions or provide additional data to partner or Microsoft. What data does PAL collect?

No new data is collected when with PAL. PAL is a new type of association between a partner's PartnerID and a customer's environment. The PAL association provides no new customer data to Microsoft. It simply tells us when a partner is active within a customer environment, so we can recognize the partner's influence for the service(s) they are providing.

Who can create a PAL link?

Any user from a partner organization who is managing a customer's resources can link a partner's PartnerID to the customer's environment. The PartnerID can be added, changed, or removed only by the partner organization that created the link. The customer, or another partner, cannot change PartnerID associated via PAL. However, a customer can revoke PAL access at any time.



Does a partner need to have an edit role or an admin role within a customer's Azure environment to link their PartnerID to PAL?

If a partner would like to attain a designation via PAL, any Azure role is eligible. However, any role assigned needs to have the right resource(s) access for ACR to be calculated. To learn more about Azure roles, please go [here](#).

How do partners get usage credit for Power Platform and Customer Insights through PAL?

When a partner connects the account that was PAL associated to a specific Power Platform and Customer Insights resource, the usage (such as monthly active users or monthly active profiles) of that specific resource is credited towards that partner's PartnerID. The account requirements and the resource details vary by product and it's recommended to use managed solutions where possible, see the documentation for more details, [Link a partner ID to your Power Platform and Dynamics Customer Insights accounts with your Azure credentials | Microsoft Docs](#).

Do I need to create a PAL association for every customer?

Yes. Partners must link an PartnerID to their Azure credentials for every customer tenant in which they are delivering services. PAL associations are generated on a per-customer tenant basis and are not inherited by other customer environments serviced by the same partner. If more than one contact from a partner organization has credentials in a single customer environment, the PartnerID should be associated to each set of credentials in order to enable full credit for influence on that customer's Azure consumption.

Is customer participation required to enable PAL?

Partners activate PAL by linking a valid PartnerID to the credentials they have been granted by a customer to perform services in the customer's Azure environment.

- An authorized representative of the customer has consented to providing the partner access
- The customer understands that they may revoke access for the partner at any time

Partners may not assign or use their administrative access to add additional parties without customer consent.

Will Azure consumed revenue (ACR) driven by PAL association be calculated retroactively, or will PAL association only be calculated from the date that date PAL association becomes/became eligible for solutions partner designation?

ACR is tracked over trailing 12 months. Therefore, if a partner had already associated their PartnerID to PAL when PAL becomes/became eligible for solutions partner designation, their ACR will be calculated retroactively, up to a period of 12 months.

What if customers do not want to give you guest user access on their Azure Portal?

This is usually the case if the partner is providing training or project management services and does not actually do any deployment using Azure, Power Platform, and Customer Insights environments, in this case, such a service will not count towards attributing usage towards your organization.

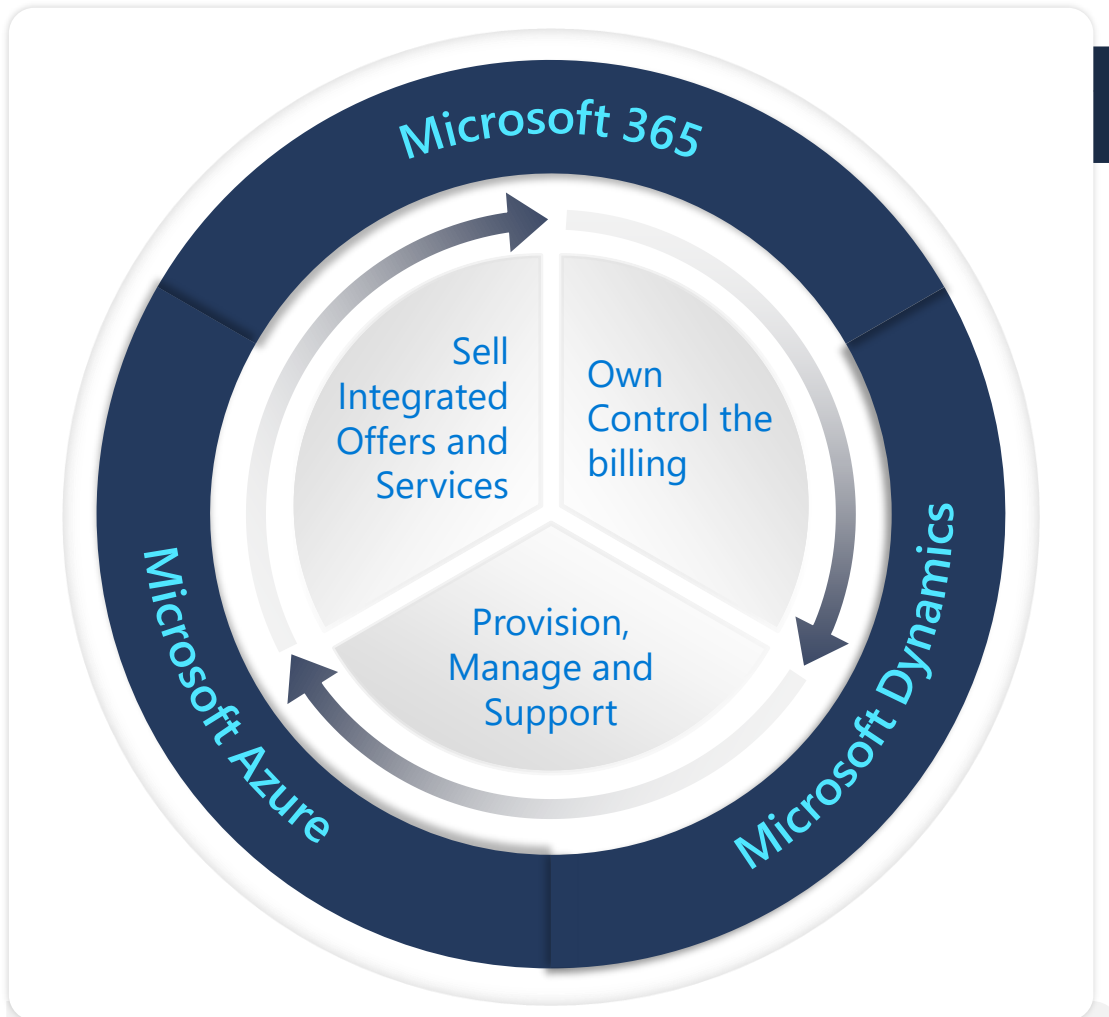

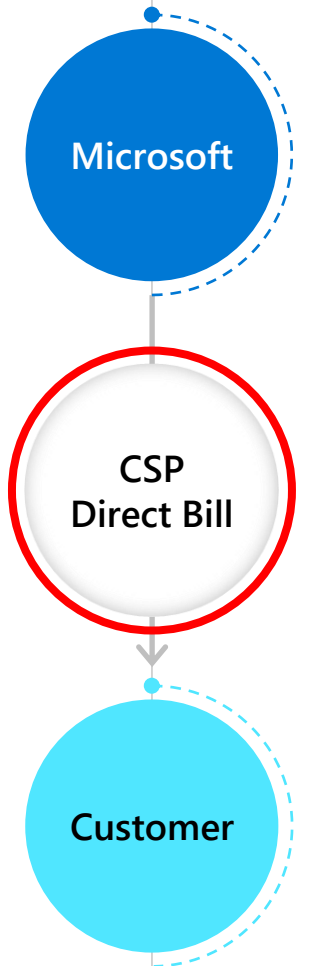




Two CSP models based on partner's business model

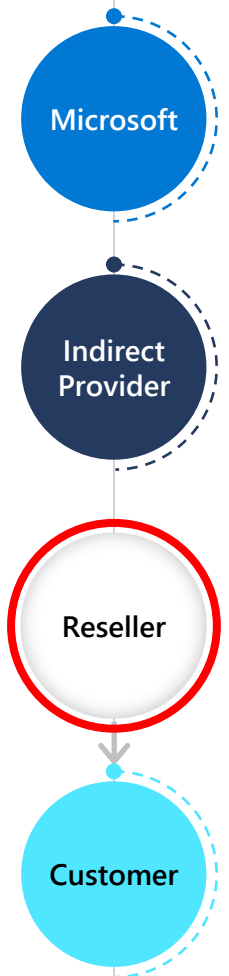
Direct bill model

- For partners who want to own the end-to-end lifecycle of the customer relationship
- Sells directly to the customer and is able to own all sales, billing, provisioning, and support of customers
- Credit approval required; minimum \$300K trailing-12-months indirect CSP reseller revenue threshold across all partner tenants
- Must have premium support plan (ASfP or PSfP) for company
- Discounts on cloud seat-based offers sold, based on offer type; partner earned credit (PEC) for Azure plan
- Billed revenue incentives rebate (requires solutions partner designation; accelerators may also apply per location)



Indirect reseller model

- For partners who want to leverage the support of an Indirect Provider who can provide technical training and assistance, help market your solutions, and assist with credit & financing
- Able to deliver solutions sales, billing, and support to customers backed by the Indirect Provider(s)
- Minimum trailing 12 month revenue of USD1000 required for CSP participation. Resellers purchase from the Indirect Provider(s) for provisioning customers
- Margin on sales varies depending on agreement with Indirect Provider and product
- Incentives rebates based on billed CSP revenue (requires solutions partner designation; accelerators may also apply per location)





How to enroll in CSP

To complete the CSP application, you'll need your company's PartnerID, complete business address, bank information, and the work email for the employee who will act as the admin for the Partner Center.

1 Sign into the [Partner Center dashboard](#) with your work email (that is, your Azure AD tenant credentials).

2 Associate your PartnerID to your profile.

- If you're already enrolled in the program, select the location Partner ID, which is linked to your incentive's enrollments. The location PartnerID must be active and located in the same country as your CSP account.
- If you have not enrolled in the program, [enroll today](#).

3 Create your partner profile. You can either look up your company profile or enter company information manually. If your company is registered with [Dun & Bradstreet](#), use the DUNS ID to look up your company information. If you want to provide your company details yourself, select **Enter manually**.

4 For some countries, when you enter your address manually, we'll validate your address for you. If the address you enter differs from the validated one, we suggest you use the validated address. This ensures that the elements of the address are standardized as defined by the country's postal authority, are correctly formatted, and are shippable.

5 During verification, Microsoft may ask you for another document, or request that you complete a questionnaire. It can take several days to review and verify the information provided; once verified, an email will be after review is complete.

6 After Microsoft has verified your information, accept the Microsoft indirect reseller terms agreement. Go to [Home page](#) and select [CSP](#) from the Pending actions view on the right-hand side to sign Microsoft Partner Agreement.

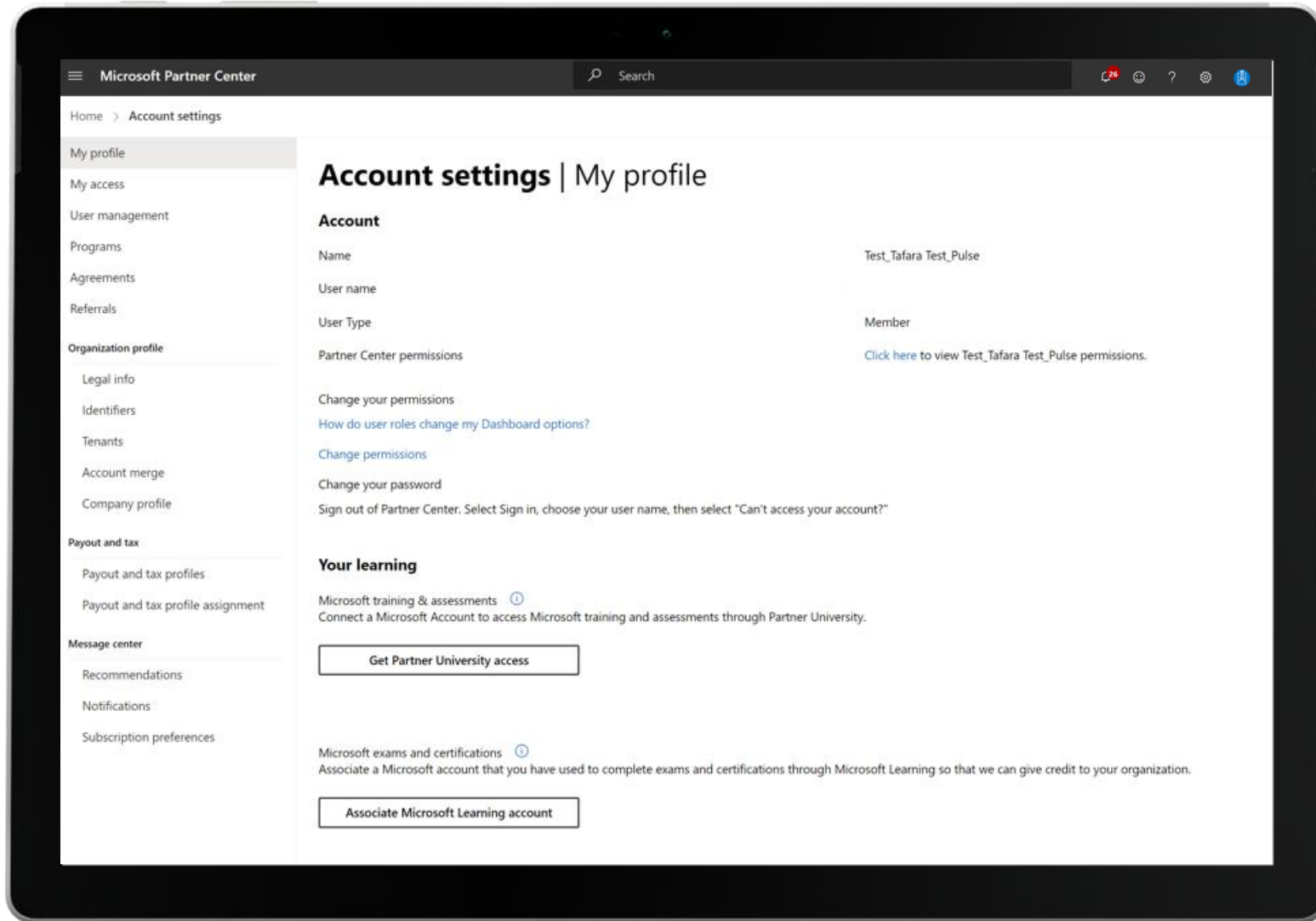

Certified professional association



- Microsoft certifications are linked to an individual's learning account. To ensure your organization is benefiting from relevant certifications earned by employees, it's important to link the individual's certification to their organization's account in Partner Center.
- Once you've associated an employee with your Partner Center account, have your employees take the following steps:
