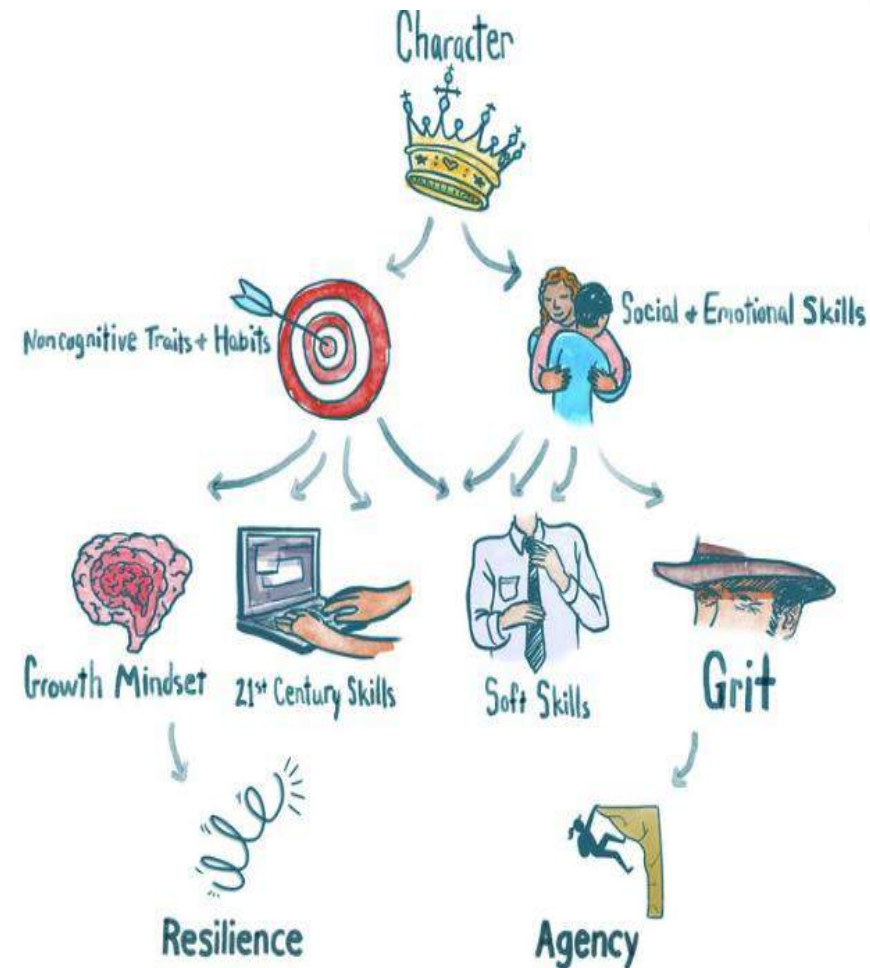

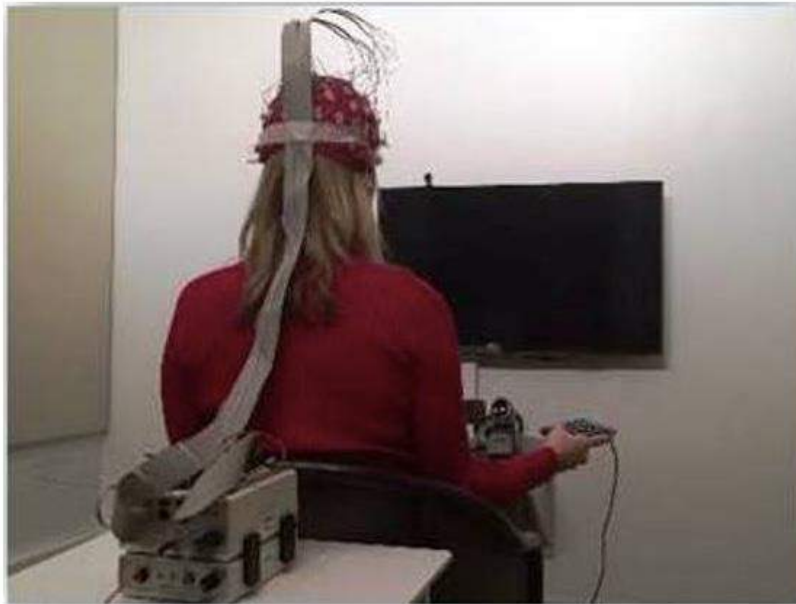

# SEL – No One Can Define It

- “Social Emotional Skills: Everyone Loves Them, But Still Can’t Define Them” (NPR 8/14/17)
- “To create SEL standards and assess progress toward those standards presupposes that we agree about what SEL is. Yet neither researchers nor practitioners nor policymakers have come to such a consensus.” (Brookings – *Future of Children* – Spring 2017)



## SEL – No One Can Assess It



- “We have few usable, feasible, and scalable tools to assess children’s SEL.” (Brookings – *Future of Children* – Spring 2017)
- “The measurements that psychologists like me have are so awful! I mean they are fakeable, imprecise, they have a thousand biases.” (“Grit Guru” Angela Duckworth at ExcelinEd.org [Jeb Bush] conference 2016)

# SEL – No One Can Explain Study Results

“We know these skills are essential for children, *but there's still a lot we don't know about ways to enhance them,*’ said [Professor] Megan McClelland... *‘The results to date have been mixed’* ... There's also a *general lack of long-term studies* that might give researchers a clearer picture of the programs' effectiveness” - 2017 CASEL Meta-analysis



# Pre-K SEL Skills NOT Predictive

“Early math skills have the greatest predictive power, followed by reading and then attention skills. By contrast, ***measures of socioemotional behaviors...were generally insignificant predictors of later academic performance, even among children with relatively high levels of problem behavior.***”

# Federal Government Pushing SEL

- ESSA allows measures of SEL in school accountability (§ 1111(c)(4)(B)(v)) and provides grants for SEL (§ 4107(a)).
- NAEP & state assessments starting to include SEL surveys
- Proposed reauthorization of ESRA [SETRA] would have allowed federal research and data-collection on children's SEL.
- Head Start
- Fund CASEL via IES

(Former USED Secretary Arne Duncan House testimony, April 29, 2014).

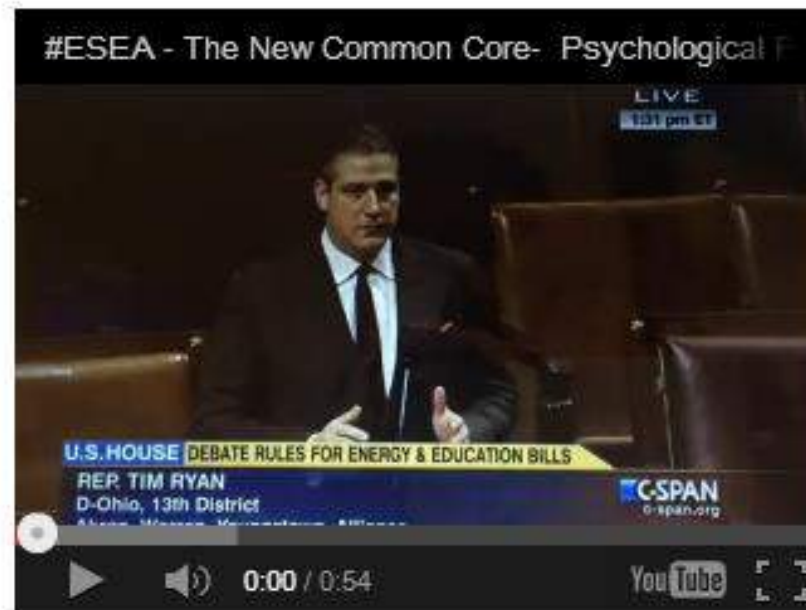


# SEL Clearly Linked to Common Core

# RHODE ISLAND

## SEL Assessment and Data Tracking

“Rhode Island’s proposed early learning data system ***will be linked to both the state’s K-12 data system and to the state’s universal newborn screening and health data system***, helping to identify children with high needs, track participation in programs, and track children’s development and learning.”



# Newborn Screening Samples Used for Research without Consent

“Newborn screening is the most widely performed type of genetic testing in the United States today. . . . Most states, including New York, do not require parental consent. . . . Most newborn screening programs, including New York's program, store residual newborn blood samples (bloodspots) and use them for research.” (“Genetic Testing and Screening in the Age of Genomic Medicine” [Exec. Summary], NY Dept. of Health)

# Treating Genetic Susceptibility

“General pediatricians don’t have to be behavioral health specialists, but they can still intervene.

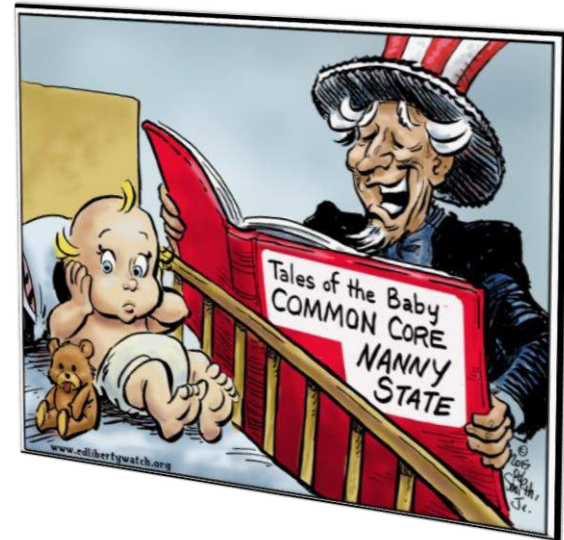
Psychopharmacology is on the horizon as ***preventive therapy for children with genetic susceptibility to mental health problems.***” — (Emphasis added.) David W.

# Preschool SEL

- ESSA pre-K program requires alignment with Head Start statute, which requires federal Head Start pre-K “baby Common Core” content standards in 11 places.
- Content standards include subjective & controversial SEL standards for children.
- State pre-K standards must align with Head Start standards & coordinate data-sharing with Head Start



# Head Start SEL Standards



## INDICATORS

### By 36 Months

- ▲ Recognizes own name.
- ▲ Identifies some physical characteristics of self, such as hair color, age gender, or size.
- ▲ Recognizes some similarities and differences between self and others.



# Gender Identity

“Refers to a person’s internal, deeply felt sense of being either *male or female, or something other or in between*. Because gender identity is internal and personally defined, it is not visible to others.” (Emphasis added.)

# USED Continuing to Promote Transgenderism Despite Removal of “Dear Colleague” Letter

USED’s Office of Civil Rights can still intervene if there is:

- “Failure to promptly and equitably resolve a transgender student’s complaint of sex discrimination”
- “Refusing to use a transgender student’s preferred name or pronouns when the school uses preferred names for gender-conforming students” and other issues creating a “hostile environment”
- different treatment based on sex stereotyping (e.g., based on a student’s failure to conform to stereotyped notions of masculinity or femininity)

# Federally Funded Islamic Curriculum



1. Explain to students that you will be looking at each pillar in detail beginning with the first pillar, which is Shahadah or belief. To begin, go to the BBC website

Have students read about what it means to proclaim faith or belief as a Muslim. Have students, individually, silently read the Shahadah. Ask the students to think about what the Shahadah means. Why do they think that this statement is a significant part of being a Muslim? Record their thoughts on their [Student Response Sheet 2: The Five Pillars of Islam](#) handout, and discuss these questions as a class.

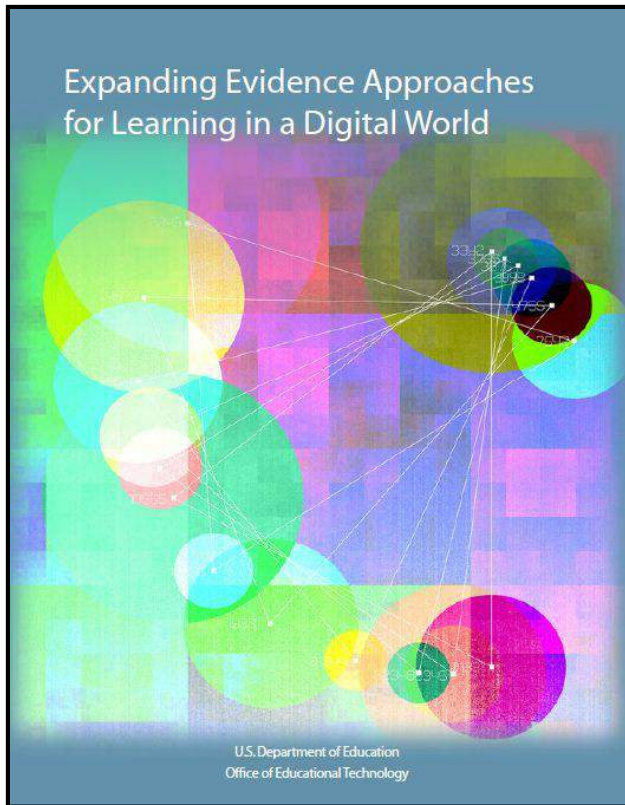

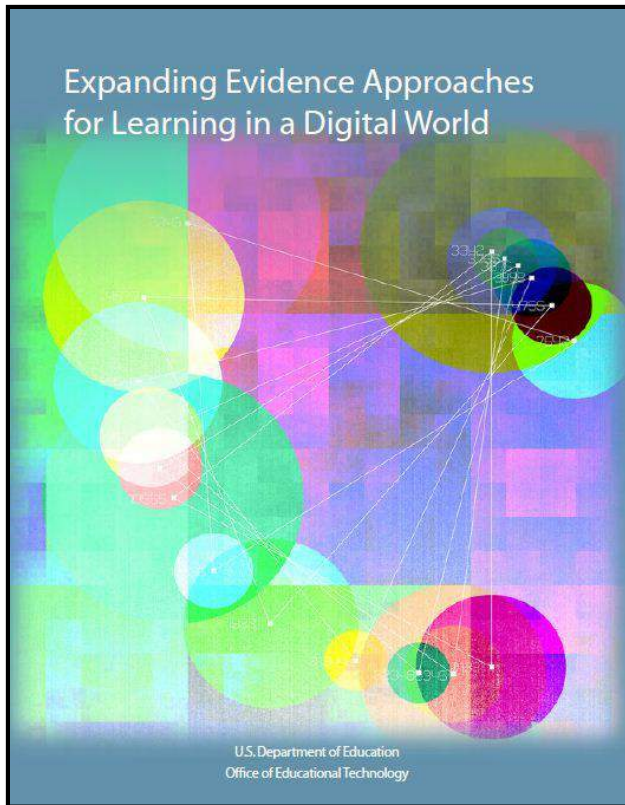
# Digital Learning



Can measure ***“noncognitive” aspects such as collaboration, persistence, leadership***, by capturing “micro-level data on [students’] problem-solving sequences, knowledge, and strategy use, including each student’s selections or inputs, the number of attempts a student makes, the number of hints and feedback given, and the time allocated across each part of the problem.”



# Digital Learning



“Some of these new digital learning resources are sophisticated systems capable of collecting large amounts of fine-grained data as users interact with them . . . ***[L]earners will generate vast quantities of data . . . .***”

CEO of Knewton bragged about software that mines ***“5-10 million actionable data [points] per user per day.”***



# Intrusive Data Mining

Common Core is part of a larger scheme that encourages states to collect over 400 data points on each student, including SEL. The data will go into state databases – which are identically built, and therefore sharable & can be used for predictive testing.

The **Family Educational Rights and Privacy Act** was gutted in 2012 to allow almost unlimited data-sharing, without parental consent.

“These high-fidelity data are in the form of log files from mouse clicks within the digital learning environment. They also **measure and monitor things like students’ saccadic eye patterns as students learn from visual and textual information sources, data from sensors tracking facial expressions and posture, and more.** These data are all fine-grained, reflecting students’ learning processes, knowledge, **affective states . . . .**”

## Workforce Data Quality Initiative Grant Program



Government will track students into the workforce by combining education, including SEL data, and labor data.

Fulfills vision of Marc Tucker, who recommended to Hillary Clinton (1992) a government-managed education/workforce structure coordinated by “a system of labor market boards at the local, state and federal levels” with integrated curriculum and “job matching” via the “computer-based system.”

# Some Good News

- Parent activists able to stop the funding of SEL research in federal research/data bill for an entire two year session of Congress
- Congress & data commission seem to be listening to concerns about collecting college/workforce data
- Trump administration may revoke some more egregious fed ed regulations



## What Congress Can Do

- Support two-parent family formation in welfare reform
- Deny funding for SEL standards, assessments, data collection –
  - No SEL research in ESRA reauthorization
  - Enforce current law regarding attitude/mindset testing in state tests and plans and NAEP
  - Demand elimination of revamp of the SEL standards in Head Start
- Demand revocation of 2012 FERPA regulation & update it legislatively
- Oppose proposed expansion of data collection
- Return local/state control of standards/tests & state plans





# What You Can Do

- Pray for our children, schools, families and leaders
- Contemplate removing children from public school
- Opt out of any testing and data requests
- Regularly review and update your child's data profile
- Fight at the local level to remind officials that these bad ideas have been rejected and withdrawn
- Talk to state and local officials and urge them not to accept SEL and other problematic federal grants
- Talk to your members of Congress about these issues
