**Steps and Timing**

- 1 Set Up Your Account and Profile**

Create an account and profile, including company and/or individual information, permissions, and payment options. This is where you'll submit all the information you'll need to become a publisher.
- 2 Enter and then Submit Your App Info**

Provide basic information like your app's Title, Type (web-based or desktop-based) and/or Program (Add-on, Extension, Plugin), OS, as well as your Forge API Client ID or your cloud product URL, and assets (description, photos, video etc...). Then click submit and we'll get back to you within 24 hours with next steps.
- 3 App Review**

App Store team will perform initial review on your submission to determine suitability to be included in Autodesk App Store. We will communicate via email to provide feedback and/or request for missing items as soon as possible. If your submission is accepted, Autodesk will create the final “package file” that customers will download from Autodesk App Store and contact you to review the final package file.
- 4 Manage Your App**

After the app is published, you can adjust the version, language, title, or assets. And, you can even base those changes on insights gleaned from you personalized dashboard.

**Publisher Privacy Policy**  
 Each and every App must include a link to the applicable privacy policy in the [App description page] and within the App in an easily accessible manner. In addition, Publisher must include the text of the applicable privacy policy within the App itself.

- The privacy policy must clearly and expressly do the following:
1. Identify and describe the data, if any, that the App collects, how that data is collected, and all uses of that data.
  2. Confirm that any third party with whom an App shares that data will provide the same protection of that data as stated in the App’s privacy policy. Examples of such third parties are analytics tools, advertising networks and third-party SDKs, as well as legal affiliates of the Publisher (parent, subsidiary, related entities).
  3. Explain Publisher’s data retention and deletion policies.
  4. Describe how end users can revoke consent and/or request deletion of their data.
