### Guidelines for completing the application form for public health emergencies

These guidelines are intended to help with the completion of the application form for financial assistance from the EU Solidarity Fund (EUSF) **for public health emergencies**. They do not give an exhaustive presentation of the obligations of the EUSF Regulation, and do not consider legal questions in detail. The information provided is therefore without prejudice to the position the Commission will take on the basis of the information received.

Reference numbers correspond with those in the application form.

Please verify on the EUSF website whether you are using the latest version of the form and guidelines (see top right of this page).

Guideline Reference number		<i>Information to be provided by the applicant</i>
1	<b>State applying</b>	Name of Member State or of country involved in accession negotiations making the application.  Applications must be submitted by the competent national authorities of the affected state. Regional or other authorities may not apply.
2	<b>Date of first occurrence of infection</b>	Please give the date on which the first human infection was officially diagnosed in your country
3	<b>Date of first official action against the emergency</b>	The same rules apply as for <b>progressively unfolding natural disasters</b> (Art. 4 (1c) EUSF Regulation) whereby the 12 week application deadline is counted from the date one on which the public authorities of the affected state took official action for the first time against the effects of the emergency or from the date they declared a state of emergency (or similar).  This date is the starting date of the 12-week application deadline within which a formal application must be received at the Commission. Electronic submission is accepted in order to meet the deadline if the authenticity of the applications is guaranteed (e.g. by including a scan of the signed cover letter).  This date is also the starting date of the eligibility for (retroactive) EUSF funding of emergency operations.  In order to ensure an equitable treatment of all applications from eligible countries affected by <b>Covid-19</b> before the entry into force of the amending Regulation extending the scope of the EUSF to health emergencies, those countries may <b>submit a first summary application</b> within the deadline (e.g. by way of a letter containing basic information.) <b>The Commission will accept</b> (in application of

		Art. 4 (1a) of the EUSF Regulation) <b>receiving updates/full information as requested in the application form within 12 weeks of the entry into force of the amended Regulation i.e. by 24 June 2020.</b> After that date the Commission will assess all applications jointly. There will be no “first come first served”.
4	<b>Type of public health emergency</b> Please specify	Short description e.g. pandemic, disease outbreak, biohazard, chemical, other (please explain)
5	<b>Major public health emergency threshold</b>	The threshold is either <b>0.3% of Gross National Income (GNI) or EUR 1.5 billion</b> in prices of year n-2 (based on EUROSTAT data). Accordingly, for 2020, the applicable threshold would be EUR 1 792.639 million (reference year 2018). <b>The lower of the two amounts applies.</b>  Please use the annual thresholds per country published on the EUSF website.
6	<b>Total public expenditure for emergency response measures</b> (total amount in million EUR)	Sum of the estimated expenditure for emergency operations to support the population and limiting the spread of the disease <b>during the four months following the starting date declared in reference number 3.</b>  This amount should be equal to the total for eligible operations <b>detailed under reference numbers 14 and 15 below.</b>  The total amount given here may include expenditure that has received/will receive a contribution from other EU instruments. However, the same operation may not be financed from several EU instruments, i.e. <b>double financing is not permitted</b>
7	<b>Request of advance payment<sup>1</sup></b>	Indicate whether you apply for an advance payment.  Subject to the availability of budget resources, the advance payment may amount up to 25% of the expected final EUSF contribution, depending on budget availability and limited to EUR 100 million maximum.  If the Commission considers that the application is not likely to meet the criteria of the Regulation, an advance will not be paid. Unduly paid advances will be recovered.
