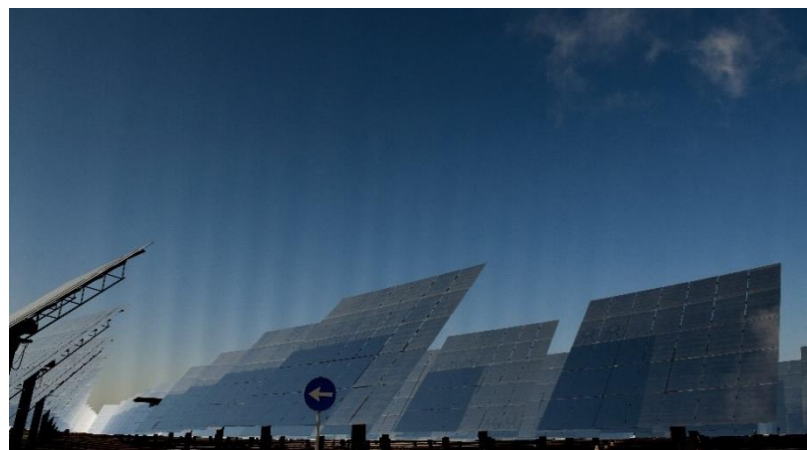
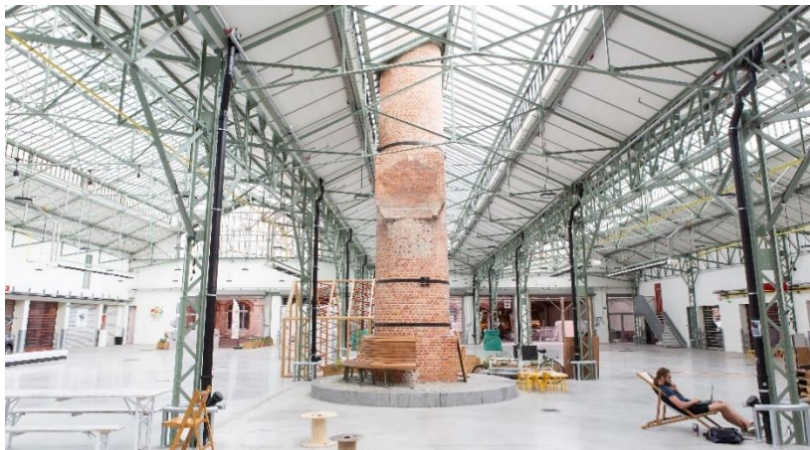

A new feature in 2021-2027

Operations of strategic importance

... will provide a significant contribution to the achievement of programme objectives.

... entail specific monitoring and communication measures.

... aim to **tell the story of a programme.**

A new challenge for communication, monitoring and involvement of EC.

Programming

- A legal requirement to have OSI's in ERDF, CF, ESF+, JTF & EMFAF programmes
- MAs to submit list of planned operations of strategic importance within Appendix 3, together with a timetable.
- Tip: find a balance in number of OSI's.

Communication & implementation

- Selecting osi's and notifying the EC.
- Keeping an eye on osi's progress within Monitoring Committee & providing info for the annual review.
- Ensuring visibility of osi's.
- Beneficiaries to organise **events or activities** that prominently feature EU support & involve EC & MA.
