The outermost regions are the most remote parts of the EU and home to 5 million EU citizens. In 2022 the European Commission adopted a strategy to further support these regions across all policies, building on their unique assets and focusing on improving citizens' lives. By 2024, the Commission has delivered on its commitments, working together with the outermost regions and their Member States. The Commission intends to continue supporting the EU outermost regions, in line with the Treaty.

The Treaty (Art. 349 TFEU) provides for specific support measures for the EU outermost regions and their people.


