## JTPeers Experts is growing – Call for experts to join the expert database of the Just Transition Platform (JTP)

The Just Transition Platform is issuing a call for more professionals to be included in the <u>JTPeers Experts Database</u>. We invite experienced professionals, researchers and practitioners working in a wide range of sectors and territories, whose expertise helps to advance the implementation of just transition in carbon-intensive and coal+ territories across the EU to join the database.

The European Commission is providing additional support for JTF territories through the JTPeers Experts Database. The digital database currently catalogues and showcases 110 expert profiles active in the just transition field in 23 countries.

The database aims to help interested parties from eligible JTF territories to find and connect with experts. These experts can provide guidance and assistance to the territories in implementing their Territorial Just Transition Plans (TJTP).

The only valid way to apply is via <u>this EU-survey questionnaire</u> for JTPeers Experts by the deadline of submission: **11 November 2024 at 23:00 CET**.

While validating the applications, the European Commission will focus primarily on strong qualifications and relevant professional experience, while striving to ensure gender balance. In particular, the JTPeers call is aimed at those experts contributing to the implementation of Territorial Just Transition Plans (TJTP), including developing project pipelines, strengthening governance/monitoring/evaluation mechanisms or similar skills.

Presence within the JTPeers Experts database may trigger multiple opportunities, possibly including requests from JTF territories to provide guidance and counselling or speaking at related events.
