

**COMMISSION REGULATION (EC) No 2337/2003**  
**of 30 December 2003**  
**correcting Regulation (EC) No 1903/2003 fixing the olive yields and oil yields for the 2002/03**  
**marketing year**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organisation of the market in oils and fats <sup>(1)</sup>, and in particular Article 5(11) thereof,

Having regard to Council Regulation (EEC) No 2261/84 of 17 July 1984 laying down general rules on the granting of aid for the production of olive oil and of aid to olive oil producer organisations <sup>(2)</sup>, and in particular the first indent of the second paragraph of Article 19 thereof,

Whereas:

- (1) An error has been found in the Annex to Commission Regulation (EC) No 1903/2003 <sup>(3)</sup>.
- (2) That Regulation should be corrected accordingly.
- (3) The measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Oils and Fats,

HAS ADOPTED THIS REGULATION:

*Article 1*

In the Annex to Regulation (EC) No 1903/2003, part D (Spain) is corrected as follows:

1. Point 6 (Extremadura) is replaced by the following:
