Prior notification of a concentration (Case COMP/M.3676 — WARBURG/PROVIDENCE/TELCORDIA) Candidate case for simplified procedure

- 1. On 20 December 2004, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 (¹) by which the undertakings Warburg Pincus LLC ('Warburg'), USA, and Providence Equity Partners Inc. ('Providence'), USA, acquire within the meaning of Article 3(1)(b) of the Council Regulation joint control of the undertaking Telcordia Technologies Inc. ('Telcordia'), USA, by way of purchase of shares.
- 2. The business activities of the undertakings concerned are:
- for undertaking Warburg: Global private equity investments,
- for undertaking Providence: Global private equity investments,
- for undertaking Telcordia: Software and services for communications networks.
- 3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of Regulation (EC) No 139/2004. However, the final decision on this point is reserved. Pursuant to the Commission Notice on a simplified procedure for treatment of certain concentrations under Council Regulation (EC) No 139/2004 (²) it should be noted that this case is a candidate for treatment under the procedure set out in the Notice.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
