COUNCIL IMPLEMENTING REGULATION (EU) 2021/1300

of 5 August 2021

implementing Regulation (EU) 2017/1509 concerning restrictive measures against the Democratic People's Republic of Korea

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) 2017/1509 of 30 August 2017 concerning restrictive measures against the Democratic People's Republic of Korea and repealing Regulation (EC) No 329/2007⁽¹⁾, and in particular Article 47(2) thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 30 August 2017, the Council adopted Regulation (EU) 2017/1509.
- (2) In accordance with Article 47a(1) of Regulation (EU) 2017/1509, the Council has reviewed the lists of designated persons and entities set out in Annexes XV, XVI, XVII and XVIII to that Regulation.
- (3) The restrictive measures against all persons and entities in the lists set out in Annexes XV and XVI to Regulation (EU) 2017/1509 should be maintained, and the statement of reasons for ten persons and one entity, and the identifying information of four persons, should be updated.
- (4) In addition, the identifying information of one person in the list set out in Annex XIII to Regulation (EU) 2017/1509 should be updated.
- (5) Annexes XIII, XV, and XVI to Regulation (EU) 2017/1509 should therefore be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes XIII, XV, and XVI to Regulation (EU) 2017/1509 are amended as set out in the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

cancelling the protection of the designation of origin [Neusiedlersee-Hügelland (PDO)]

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing a common organisation of the markets in agricultural products and repealing Council Regulations (EEC) No 922/72, (EEC) No 234/79, (EC) No 1037/2001 and (EC) No 1234/2007 ⁽¹⁾, and in particular Article 106 thereof,

Whereas:

- (1) Article 19 of Commission Delegated Regulation (EU) 2019/33 ⁽²⁾ provides that the procedure laid down in Article 94 and Articles 96 to 99 of Regulation (EU) No 1308/2013 shall apply *mutatis mutandis* to the cancellation of a protected designation of origin under Article 106 of Regulation (EU) No 1308/2013.
- (2) Pursuant to Article 19 of Delegated Regulation (EU) 2019/33, Austria's request to cancel the protected designation of origin 'Neusiedlersee-Hügelland' was published in the *Official Journal of the European Union* ⁽³⁾.
- (3) As no statement of objection under Article 98 of Regulation (EU) No 1308/2013 has been received by the Commission, the protected designation of origin 'Neusiedlersee-Hügelland' should be cancelled.
- (4) In view of the cancellation of the protection of the designation of origin 'Neusiedlersee-Hügelland', the entry should be deleted from the Union register of protected designations of origin and protected geographical indications for wine referred to in Article 104 of Regulation (EU) No 1308/2013.
- (5) The measures provided for in this Regulation are in accordance with the opinion of the Committee for the Common Organisation of Agricultural Markets,

HAS ADOPTED THIS REGULATION:

Article 1

The protection of the designation of origin 'Neusiedlersee-Hügelland' (PDO) is hereby cancelled.

Article 2

The entry for the designation of origin 'Neusiedlersee-Hügelland' (PDO) is hereby deleted from the register of protected designations of origin and protected geographical indications for wine.
