IL-KUMMISSJONI TAL-KOMUNITAJIET EWROPEJ,

Wara li kkunsidrat it-Trattat li jstabbilixxi l-Komunità Ewropea, u b'mod partikolari l-Artikoli 152 u 153 tiegħu,

Wara li kkunsidrat id-Deciżjoni tal-Kummissjoni 2004/210/KE tat-3 ta' Marzu 2004 li tistabbilixxi Kumitati Xjentifiċi fil-qasam tas-sikurezza tal-konsumatur, is-sahha pubblika u l-ambjent <sup>(1)</sup>, u b'mod partikolari l-Artikolu 3 u l-ewwel subparagrafu ta' l-Artikolu 7(1) tiegħu,

Billi:

- (1) Id-Deciżjoni tal-Kummissjoni 2004/210/KE tippredvi t-twaqqif tal-Kumitat Xjentifiku dwar Prodotti tal-Konsumatur ("l-SCCP"), il-Kumitat Xjentifiku dwar Riskji Sanitarji u Ambjentali ("l-SCHER") u l-Kumitat Xjentifiku dwar Riskji Sanitarji Emerġenti u dawk li ġew Identifikati Reċentement ("l-SCENIHR") ("il-Kumitati Xjentifiċi"). Skond l-Artikolu 3(4) ta' din id-Deciżjoni, il-Kummissjoni għandha tinnomina l-membri ta' dawn il-Kumitati Xjentifiċi.
- (2) Skond l-Artikolu 7(1) ta' din id-Deciżjoni, kif emendata bid-Deciżjoni tal-Kummissjoni 2007/263/KE, il-mandat tal-membri tal-Kumitati Xjentifiċi huwa limitat għal tliet snin, u għal tliet mandati konsekuttivi. Izda, il-Kummissjoni tista', f'ċirkustanzi eċċezzjonali, itawwal il-mandat tal-membri ta' dawn il-kumitati għal perjodu li mhux itwal minn 18-il xahar sabiex tissalvagwardja l-kontinwità ta' l-għarfien espert.
- (3) Id-Deciżjoni C(2004) 2788 dwar in-nomina tal-membri tat-tliet Kumitati Xjentifiċi stabbiliti bid-Deciżjoni 2004/210/KE tistipula li l-esperti mniżżla fl-Anness I ta' din id-Deciżjoni huma nominati bhala membri tat-tliet Kumitati Xjentifiċi stabbiliti bid-Deciżjoni 2004/210/KE.
- (4) Il-mandat tal-membri preżenti tal-Kumitati Xjentifiċi se jiskadi fl-Lulju 2007. Izda, il-kompożizzjoni tal-Kumitati

Xjentifiċi jehtieg li tiġi emendata sabiex jitqies id-dhul fis-sehh tar-Regolament (KE) Nru 1907/2006 tal-Parlament Ewropew u tal-Kunsill tat-18 ta' Ottubru li jikkonċerna r-Registrazzjoni, il-Valutazzjoni, l-Awtorizzazzjoni u r-Restrizzjoni tas-Sustanzi Kimiċi (REACH) u li jstabbilixxi l-Aġenzija Ewropea dwar is-Sustanzi Kimiċi li emenda id-direttiva 1999/45/KE u li jhassar ir-Regolament tal-Kunsill (KEE) Nru 793/93 u ir-Regolament tal-Kummissjoni (KE) Nru 1488/94 kif ukoll id-Direttiva tal-Kunsill 76/769 KEE u id-Direttivi tal-Kummissjoni 91/155/KEE, 93/67/KEE, 93/105/KE u 2000/21/KE <sup>(2)</sup>. Barra minn hekk, sabiex il-Kummissjoni theggi b'mod xieraq ir-reviżjoni tal-provvista ta' pariri xjentifiċi fid-dawl tal-hidmiet ġejjiena tal-Kumitati Xjentifiċi, minghajr ma tharbat il-kontinwità tal-pariri xjentifiċi fil-perjodu ta' tranzizzjoni sakemm titwaqqaf l-Aġenzija Ewropea dwar is-Sustanzi Kimiċi, il-mandat tal-membri għandu jiġi mtawwal sal-31 ta' Diċembru 2008.

- (5) Il-Kummissjoni għalhekk għandha tinnomina l-membri tal-Kumitati Xjentifiċi għall-perjodu li jintemm fil-31 ta' Diċembru 2008,
- (6) Xi whud mill-membri preżenti tal-Kumitati Xjentifiċi esprimew l-intenzjoni tagħhom li ma jibqgħux fil-kariga għal perjodu addizzjonali sal-31 ta' Diċembru 2008. Dawn il-membri għalhekk għandhom jiġu maqtugħa mill-lista ta' esperti nnominati bhala membri tal-Kumitati Xjentifiċi stabbiliti fl-Anness 1 tad-Deciżjoni C(2004) 2788.
