## Executive summary

In summer 2020, 1,510 applicants submitted their details to the UKFPO to ascertain their eligibility to apply for the two-year UK Foundation Programme (UKFP). Prospective UKFP applicants who graduated/were due to graduate outside the UK or graduated in the UK more than 2 years before the start of the programme were required to take part in this process. 860 applicants were deemed eligible to apply for UKFP starting in August 2021 (UKFP 2021) and 790 submitted an application in autumn 2020. This was alongside 7,434 applications received from “UK nominee” applicants (who graduated/were due to graduate from a UK medical school in 2020 or 2021). In total, there were 8,224 applications for UKFP 2021, made up of 9.6% eligibility applicants and 90.4% UK nominee applicants. Applicants had to apply for the standard FP and were able to apply for Academic Foundation Programmes (AFP), Foundation Priority Programmes (FPP) and Psychiatry Foundation Fellowships (PFF) as part of this.

As in the last few years, there were more applicants than advertised FP places. AFP and FPP places were filled using an offers process in January/February 2021. In March 2021 all applicants who were still in the process who had not accepted an AFP/FPP offer were allocated to either the primary list (as many applicants as there were FP places available at that time) or the reserve list (the remaining applicants). Applicants on the primary list were allocated to a foundation school and subsequently to a programme within that school by April 2021. Applicants on the reserve list were allocated to foundation school and programme in batches by 10 June 2021. An additional 140 FP places were created across the UK to facilitate this and all eligible applicants remaining in the process received an FP place. 8,078 applicants were allocated to an FP place at the close of the UKFP 2021 recruitment process in June 2021.

The effects of the Covid-19 pandemic continued to be felt during the UKFP 2021 recruitment process, including through the local management of deferred places (either by a whole year or starting the UKFP 2020 late) resulting in fluctuations in available post numbers and complex funding negotiations for UKFP 2021, and through backlogs in processes managed by the UK Foundation Programme Office (UKFPO). As a result of the changes made to allow the continued sustainable management of recruitment processes, this Recruitment Stats and Facts Report has been shortened (compared to previous years' reports) and published later than usual. Note that data/totals rapidly change as the recruitment process progresses; however, it is not possible to show data for every stage of the process.

## Summary of recruitment processes

To apply for the UK Foundation Programme, applicants must be nominated by a UK medical school or the UKFPO's Eligibility Office (EO). Eligibility applications to the EO were made in July/August 2020 and in October 2020 nominated applicants were invited to register on the national application system (Oriol). All eligible applicants were then invited to submit an online application form to the national FP vacancy through Oriol in October/November 2020. Applicants were required to rank Units of Application (UoAs) – also known as foundation schools – in their order of preference as part of this application.

Applicants then had the option to apply to a maximum of two AFP vacancies managed by individual Academic Units of Application (AUoAs). AFPs have a specific academic component focused on research, education and teaching or leadership and management. There were fifteen AUoAs, which were either individual foundation schools or a cluster of neighbouring foundation schools. Applicants had to rank individual programmes as part of the application form(s).

Applicants also had the option to apply to either or both Psychiatry Foundation Fellowship (PFF) Programmes and Foundation Priority Programmes (FPP) once they had submitted their main application

for FP. The PFF posts were designed in collaboration with the Royal College of Psychiatrists and offered additional exposure to Psychiatry. The FPP posts were identified by individual foundation schools as typically being hard to fill posts for a variety of reasons. These posts offer a range of local incentives, and applicants were offered individual programmes ahead of the national allocation to foundation schools.

### **UK Foundation Programme Office (UKFPO)**

The UKFPO manages the application process, issues guidance on training and promotes the consistent delivery of the programme across the UK. Working with partners, the UKFPO enables sharing of good practice to help raise the standards of training. The UKFPO is funded by and accountable to the four UK governments.

### **Foundation schools**

Foundation schools are not bricks and mortar institutions. They are a conceptual group of institutions that bring together medical schools, the local health organisation and local education providers. Foundation schools act as the “home foundation school” for the medical school(s) in their region. They work with their local medical school(s) to nominate applicants for the foundation programme and manage any issues faced by provisionally registered (foundation year 1) doctors.

They offer training to foundation doctors in a range of different settings and clinical environments. The schools are administered by local staff and supported by the local office/deanery.

Training is delivered according to national guidance developed by the UKFPO, with some acceptable local variations in some areas. There were 15 AUoAs, and 20 foundation schools across the UK Foundation Programme: 17 in England and 1 in each of the devolved nations (Northern Ireland, Scotland and Wales).

### **Educational Performance Measure (EPM)**

All applicants to the Foundation Programme, including the Academic Foundation Programme, were awarded an EPM score. This is made up of a decile score, awarded by the medical school, and a maximum of 7 points, awarded by the UKFPO, for additional educational achievements (EAs). The decile score is a measure of clinical and non-clinical skills, knowledge, and performance up to the point of application to the Foundation Programme. Applicants are assessed and ranked on their performance at medical school in relation to the graduating cohort. The graduating cohort is defined as all students in their final year at the point of application to the Foundation Programme. The process for awarding EA points is described later in this report.

## **Summary of statistics**

### **Applications**

1,510 applications were submitted to the UKFPO’s Eligibility Office in advance of the national application to the UK Foundation Programme (FP). 862 applicants were deemed eligible to apply for the FP and 790 (84.85%) submitted FP applications.

7,580 applicants were nominated by UK medical schools and 7,434 (98.01%) submitted FP applications. 8,224 applications in total were submitted to the UKFP 2021.

### **Situational Judgement Test (SJT)**

8,209 applicants sat the SJT (99.21% of eligible applicants). 45 applicants achieved an exceptionally low SJT score and were invited to attend an online panel review of their SJT performance. 32 applicants attended the review, 10 (31%) of whom were reinstated to the application process with their original SJT score. The remaining 22 applicants who attended the review and the 13 applicants who did not (35 in total)

did not meet the national person specification for the foundation programme and were withdrawn from the application process.

## **Academic, Priority and Psychiatry (AFP, FPP, PFF)**

2,426 AFP applications were received (applicants were able to submit up to two applications). 540 AFP posts were advertised in September 2020, 536 of which were included in the offers process in January 2021. 527 AFP posts were filled (98.32%).

1,074 FPP applications were received. 365 FPP posts were advertised. 537 offers were made and 237 were accepted. The fill rate was 64.93% (for UKFP 2020 this was 33.54%).

181 PFF applications were received. 40 posts were available across England, 34 of which were appointed to. The fill rate was 85%.

In most cases unfilled AFP, PFF and FPP posts were included in the main allocation for FP.

## **National allocation**

In March 2021, all applicants remaining in the process were ranked in order of score and allocated according to their UoA preferences regardless of their right to work status in the UK. 6,844 (93%) applicants were allocated to the primary list – this included 6,354 (93%) UK nominees and 490 (7%) eligibility applicants.

96% of UK nominees and 72% of eligibility applicants who were still in the process were allocated to the primary list.

94% of applicants were allocated to one of their top five preferences and 75% were placed at their first preference foundation school. 6% of primary list applicants were allocated to a preference choice lower than fifth.

A total of 494 applicants were placed on the reserve list – this included 306 (62%) UK nominees and 188 (38%) eligibility applicants. The reserve list in previous years has been 25 in 2017, 202 in 2018, 425 in 2019 and 258 in 2020.

6,553 applicants were matched to individual programmes at the beginning of April 2021. Reserve list batch allocations took place in May and June. All applicants were allocated to training places by 10 June 2021.

## **Eligibility**

### **Eligibility applications**

Overseas graduates and applicants who graduated from UK medical schools more than two years before the start of the programme were invited to apply through the eligibility application process during July and August 2020.

1,510 applications were submitted (909 in FP 2020). 1400 applications were screened for eligibility – 110 applicants withdrew before they could be screened. 984 applicants were deemed eligible to apply for FP; 221 applicants were fully eligible and 763 applicants were eligible subject to various conditions, such as passing the clinical assessment and PLAB.

In October 2020, 790 (84.58%) Eligibility Office applicants applied to the national FP vacancy.

## Clinical assessment

Applicants who graduated more than two years before the start of the UKFP 2021 were required to undertake the clinical assessment (CA). The standard format includes a 16-station clinical OSCE examination. The stations are carefully mapped to assess performance against the UKFP curriculum.

The CA was delivered by the Manchester University Foundation NHS Trust at a cost of £850 per assessment. Each applicant paid the fee directly to the CA provider.

Due to travel restrictions enforced during the Covid-19 pandemic, the CA was split into two stages. Stage 1 was held at the usual time (November) online and involved all stations of the OSCE that could be adapted to allow assessment virtually. The outcome of stage 1 was pass/fail and only those who passed remained in the allocation process. Stage 2 was held in May 2021 at the assessment centre in Manchester, when travel restrictions had been eased in many parts of the world, including the UK.

264 applicants were required to undertake the clinical assessment for 2021 (17.5% of eligibility applicants who applied to FP). 205 (78%) paid for the assessment and were therefore booked onto stage 1 (4 did not attend and were withdrawn from UKFP 2021). 183 applicants passed stage 1 and 182 were booked onto stage 2 of the CA (1 candidate who passed stage 1 had withdrawn); 24 did not to attend. Following the two stages, 66% of the applicants who attempted the CA passed (compared to 78% in FP 2020).

## Additional educational achievements (EAs)

The UKFPO awarded FP applicants up to a maximum of 7 points for EAs, which form a part of the EPM score for all applicants. Applicants could choose to submit EAs as part of their FP application. The EA score is made up of up to 5 points for additional degrees awarded by the time of application (prior to medical school or an intercalated degree) and up to 2 points for educational research papers published in a peer-reviewed journal with a PubMed ID number (1 point per paper). The UKFPO and partners verified all submitted EAs through independent panels. 441 submissions were awarded 0 points: 282 for degrees, 99 for publication 1 and 60 for publication 2.

## Situational Judgement Test (SJT)

For UKFP 2021, the SJT was delivered through a digital platform in partnership with Pearson VUE and managed by the UKFPO. This was a change from the previous process where the Medical Schools Council (MSC) managed the SJT and it was sat in paper format, conducted in university exam halls on two specific dates in the winter. Applicants could choose between sitting at a Pearson VUE test centre or a remote sitting proctored using Pearson VUE's "OnVUE" online software.

Applicants were able to request reasonable adjustments to accommodate any specific needs for their SJT sitting. All requests had to be made through an electronic form during the main FP application window. 840 applicants (10.21%) requested reasonable adjustments and 826 applicants (10.04%) received these.

105 applications were approved for a re-booking.

39 applicants failed to attend the SJT and were subsequently withdrawn from the application process: 21 applicants from UK medical schools and 18 eligibility office applicants.

### Exceptionally low-scoring SJT reviews

45 applicants were identified as having an SJT score of 3.5 or more standard deviations below the mean: 10 from UK medical schools and 35 eligibility office applicants. For UK students, their medical schools were informed prior to the applicants being notified of their exceptionally low SJT score.

Applicants were invited to attend an online (Teams) review of their SJT outcome on Thursday 25 February 2021. 32 applicants attended their review meeting (23 (72%) of these were Eligibility Office applicants). One UK graduate did not attend the review.

10 (31% of those reviewed; 22% of those with an exceptionally low score) were successful at the review and were included in the allocation process to FP with their original SJT score. 7 were Eligibility Office applicants, 3 were UK graduates. The remaining 22 applicants who attended the review and the 13 applicants who did not (35 in total) did not meet the national person specification for the foundation programme and were withdrawn from the application process.

## Preferences

## Primary list

In addition to the 528 AFP and 237 FPP posts that were filled, there were 6,844 standard FP places available at the time of the national allocation in March 2021 (including any unfilled FPP places converted to standard FP places). The highest scoring applicants were placed on the primary allocation list. At the time of the primary list allocation, 100% of places were filled.

A total of 7,338 applicants remained in the application process at the time of the primary list allocation: 6,661 UK nominees and 677 Eligibility Office applicants. A total of 6,844 (93%) applicants were allocated to the primary list, 94% of whom were allocated to one of their top five foundation schools. In line with previous years, 75% of applicants allocated to the primary list were allocated to their first preference, with 83% of applicants being placed at one of their top two foundation schools. Slightly over 6% of primary list applicants were allocated to a preference choice lower than five.

Of the 6,844 applicants allocated to the primary list, 6,453 (94%) were nominated by UK medical schools and 391 (6%) applied through the eligibility process.

## Linked applications

Applicants were able to link their FP application to another applicant, so they are placed in the same foundation school. This link is honoured providing neither accepts an SFP or FPP offer, they both score highly enough to be allocated to the primary list and they rank all foundation schools in the same order. Linked applicants were allocated to foundation school using the score of the lower scoring applicant.

436 applicants allocated to the primary list were linked: 218 linked pairs. A total of 27 linked pairs were broken as part of the allocation process.

## Special circumstances

152 applicants were pre-allocated to a particular foundation school on the grounds of special circumstances as part of the primary list allocation – 2.07% of those applicants allocated as part of the primary list.

26 Eligibility Office applicants approved for pre-allocation remained in the process at the time of national allocation and 18 of these were allocated as part of the primary list (17 were granted criterion 1, one was granted criterion 3).

## Match to programme results

Applicants who had been allocated to foundation schools who employ a two-stage matching process received notifications of their match to group results on Monday 22 March 2021. Following this, 6,829 applicants were matched to programmes on Thursday 8 April 2021. 15 applicants withdrew their application after the release of primary list allocation results and before local matching processes were carried out.

## Reserve list batch allocations

At the end of April 2021 there were 60 unfilled foundation training places across the programme and 484 applicants remained on the reserve list. 140 additional training places were identified in May 2021, as well as further vacancies due to applicant withdrawals. The first group of applicants on the reserve list were allocated to foundation school on 20 May 2021. 150 additional training places were identified in June 2021, as well as further vacancies due to applicant withdrawals. The 249 applicants remaining on the reserve list were allocated to foundation school on Thursday 10 June 2021. 468 applicants were allocated as part of the reserve list and all applicants still in the process received an allocation.

### Second reserve list batch allocation

249 applicants were allocated in the second reserve list batch: 150 UK nominees and 99 Eligibility Office applicants.

Each nation supported the proposal to create additional places and were allocated additional funding where necessary by the relevant statutory education body (SEB). Additional places were identified across the four nations based on the number of home students remaining on the reserve list and with a proportionate distribution of the number of eligibility applicants who were still awaiting allocations. Where possible, foundation schools allocated additional reserve list applicants to established posts where deferrals were expected due to COVID-19 and/or where late notifications of withdrawals were received.

## Academic Foundation Programme (AFP)

A separate vacancy was set up on Oriel for each Academic unit of application (AUoA). The content of the vacancies was standardised. Individual programmes were advertised as part of each AUoA vacancy, which applicants had to preference as part of the application form.

Each AUoA had the option to include a maximum of 6 white space questions (WSQs) as part of the 'supporting' section of the application form; 11 opted to include between 1 and 6 WSQs.

The AFP match ranking score comprised of the EPM decile score + AUoA score. The AUoA score was determined locally, as in previous years.

### Applications to AFP

A total of 534 AFP places were advertised across the UK for 2021; 462 in England, 9 in Northern Ireland, 51 in Scotland and 12 in Wales. Vacancies were advertised by 15 AUoAs.

2,426 applications were submitted (each FP applicant was able to submit applications to up to two AUoAs).

### AFP offers

There was a single national offers date, followed by three cascade offer dates where applicants were able to accept or decline offers. After the third cascade, AUoAs could choose to contact applicants directly to try to fill any outstanding places; this is referred to as the 'mop-up' process. 760 AFP offers were made for the 540 AFP places. 529 offers were accepted, with 11 out of the 15 AUoAs filling all their posts. The overall fill rate for AFP was 98.32% across the UK.

There was the option for AFP programmes that were left unfilled to be converted to FP programmes for inclusion in the FP allocation process.

## Foundation Priority Programmes (FPP)

Foundation Priority Programmes (FPP) have been developed to support specific areas of the UK that have historically found it difficult to attract and retain doctors through the foundation and specialty recruitment and training processes. FPPs are specifically designed to attract and retain doctors in remote, rural and coastal geographies, under-doctored geographies and shortage specialties, including psychiatry. These programmes offer a range of incentives. FPP places were available in 14 of the 20 foundation schools, including the devolved nations. 350 priority programme places were initially advertised for UKFP 2021. Successful applicants were offered specific programmes before national allocation to foundation schools.

### FPP applications

All eligible applicants had the option to apply for FPP once they had submitted their FP application:

- 1,517 (18.45% of all FP applicants) applicants applied for FPP

- 1,274 were UK nominees (17.14% of UK nominees who applied to FP)
- 243 were applicants who applied through the eligibility process (30.76% of eligibility FP applicants).

Applicants who had applied for FPP were asked to rank all the available FPP places they were interested in receiving an offer for in their order of preference. Applicants were able to preference places in any foundation school in any order.

## FPP offers

At the time of offers, there were 350 posts available. The cut-off score for the primary list as 70.54. Applicants with a score of 70.54 or above were therefore considered in the offers matching process for FPP. Of the 1,517 applicants who applied for FPP, 537 applicants received offers over three rounds (any declined/expired offers were recycled into the next round).

## Psychiatry Foundation Fellowships (PFF)

Since FP2020, the Royal College of Psychiatrists (RCPsych) appoint 40 psychiatry foundation fellows, in collaboration with the UKFPO, through a competitive process. The posts are located across England only but applicants from all four nations are eligible to apply. The scheme aims to identify FP applicants with an interest in psychiatry as a potential career choice and to support them through to application for specialty training.

As well as having access to educational opportunities relevant to psychiatry, foundation doctors also access funded weekly supervision by a senior psychiatrist and attend reflective Balint groups. This is to introduce a strong emphasis on the psychological aspects of medicine to enhance the educational opportunities afforded in non-psychiatric placements. Fellows may also choose to be linked to RCPsych faculties for additional mentoring in a potential subspecialty of interest.

Applicants with a keen interest in psychiatry were encouraged to submit a separate application for PFF. The RCPsych scored all applications and provided a shortlist of applicants who were eligible to receive an offer. No interviews were held. Offers for these posts were made after AFP and FPP offers and national allocation to foundation schools. Offers were made based on the RCPsych PFF application score, not on total FP score, to applicants who were still in the process at the time (that is, to those who had not accepted an AFP/FPP offer, opted out of PFF or withdrawn by then). PFF applicants allocated to a foundation school that did not have PFF posts did not receive any PFF offers.

### PFF applications

40 PFF places were advertised. All nominated and eligible applicants had the option to apply for PFF once they had submitted their FP application. 181 (2.20%) applicants applied for PFF; 148 UK nominees (1.99% of UK nominees) and 33 applicants (4.18% of eligibility applicants) who applied through the eligibility process.

## PFF appointments

At the time of the offers process, 74 applicants were not eligible to receive an offer for the following reasons:

- accepted an AFP/FPP offer
- withdrawn from the FP/PFF process
- placed on the reserve list
- allocated to a UoA with no PFF places

For the remaining 100 applicants, offers were managed offline in PFF score order. 36 applicants accepted their PFF offer – the lowest rank (based on PFF score, not FP total score) of an applicant who accepted their offer was 133. 4 PFF places were not filled with PFF applicants and were converted to standard FP places.

## Final position in August 2021

At the start of the programme in August 2021, foundation doctors commenced in over 97% of foundation training places across the UK.

A total of 8078 applicants were matched to foundation training places for the 2021 Foundation Programme. This is comprised of

- 529 accepted offers for AFP (/536 posts)
- 237 accepted offers for FPP (/346 posts)
- 6844 primary list allocations
- 468 reserve list allocations

### Academic Foundation Programmes

529 academic foundation training posts were filled before national allocation to standard FP places. Six unfilled places were included in the standard national allocation to foundation schools and one place was left vacant.

### Foundation Priority Programmes

237 foundation training posts were filled through the priority programmes initiative before national allocation to standard FP places. In most cases, any unfilled priority programmes were included in the national allocation to foundation schools.

### Primary list

The primary list allocation results were released shortly after midnight on Thursday 11 March 2021. 6,844 applicants were matched to foundation school. The primary list comprised 6,354 (93%) UK nominees and 490 (7%) applicants who applied through the UKFPO's Eligibility Office. Of the total number of UK medical school graduates included in the allocation, 95% were allocated to the primary list.

### Reserve list

494 applicants were placed on the reserve list – 306 (62%) were UK medical school nominees and 188 (38%) were eligibility applicants.

Following applicant withdrawals from both the primary list and reserve list, plus the creation of 140 additional training places, 219 reserve list applicants were allocated to foundation training places across the UK on Thursday 20 May 2021. Of these, 146 (67%) were UK nominees and 73 (33%) Eligibility Office applicants. 264 applicants remained on the reserve list.

Following further withdrawals and the creation of a further 150 additional training places, the remaining 249 applicants on the reserve list were allocated to foundation training places across the UK on Thursday 10 June 2021. Of these, 150 (60%) were UK nominees and 99 (40%) were Eligibility Office applicants.

A further number of allocated applicants withdrew/were withdrawn before the start of the UKFP 2021, for a variety of reasons, such as failing language/clinical skills exams and medical school finals and personal circumstances. Due to this, some foundation schools had vacancies at the start of the training year. Efforts were made to fill the maximum possible number of established foundation training posts.
