



“ERIAKOS” Scam Website Campaign Screens Victims Based on Mobile and Ad Access, Likely to Evade Detection

A new scam campaign disseminated scam websites imitating popular brands via social media ads. Spanning 608 domains and linked merchant accounts, the campaign was designed to steal victim funds and data.

The scam websites only targeted mobile users accessing the scam websites via ad lures. This is our first observation of the tactic, which likely helped scam websites avoid detection by automated scanners.

Financial institutions face a financial fraud risk from this scam campaign and others like it. Businesses whose brands are impersonated by the scam websites also face risks of brand impairment.

Executive Summary

As of April 17, 2024, Recorded Future's Payment Fraud Intelligence team identified a network of 608 scam e-commerce websites, listed in the [Appendix](#) of this report, that a single threat actor/group likely coordinated as part of the "ERIAKOS" scam e-commerce campaign targeting Facebook users. We named this campaign after the content delivery network (CDN) *oss[.]eriakos[.]com* used for each scam website in the campaign. The scam websites used brand impersonation and malvertising tactics, techniques, and procedures (TTPs) to lure victims before stealing their financial and personal data via fraudulent transactions. Notably, the scam website domains only presented their fraudulently branded scam websites when accessed via a mobile device and ad lure — likely a strategic move to avoid detection by automated scanners and our first direct observation of such a TTP. We identified merchant accounts directly linked to a portion of scam websites in the campaign and business information indirectly linked to the scam websites via their merchant accounts. These merchant accounts accepted payments from major card networks, and Chinese payment service providers (PSPs) processed transactions for the scam websites.

For financial institutions, this scam campaign presents a risk of financial fraud, specifically through chargeback disputes and irrecoverable financial losses. For impersonated businesses, the brand impersonation tactic employed in this campaign presents a reputational risk, especially among affected victims. To reduce the threat posed by scam websites, blocklist the suspicious merchant accounts we enumerate in this report and block all associated customer transactions or authorizations. Additionally, monitoring for customer transactions with likely scam merchant accounts using [Payment Fraud Intelligence](#) can reduce the risk of brand impairment and financial fraud, respectively. We detail more mitigation strategies in this report's [Mitigations](#) section.

Looking forward, the expanded use of the screening TTPs we observed for this campaign among other scam campaigns would likely indicate a broader trend toward the use of those TTPs. By extension, the increased adoption of these screening TTPs would likely create detection gaps for current scanning technology designed to detect brand abuse, which could prolong the lifespan of scam websites, increase victim exposure to the websites, and delay takedown operations.

Key Findings

- We identified a scam e-commerce website campaign consisting of 608 domains and associated merchant accounts designed to steal victim funds, payment card data, and personal data.
- The scam campaign used previously identified fraud-malvertising TTPs to disseminate its scam websites via Facebook Ads, also known as Meta Ads. In many cases, more than 100 ads related to a single scam website were disseminated in a single day.
- The scam campaign's scam websites and ad lures primarily impersonated two popular brands, including a major online e-commerce platform and a power tools manufacturer, and also targeted victims with bogus sales offers for products from various well-known brands.
- The scam campaign exclusively targeted victims with mobile devices who accessed the scam websites via their ad lures, likely to avoid detection by automated scanning technology and prolong each scam website's lifespan.
- All of the scam websites share three key indicators:
 - Content delivery network: *oss[.]eriakos[.]com*
 - Domain registrar: Alibaba Cloud Computing Ltd. d/b/a HiChina (www[.]net[.]cn)
 - IP addresses: *47[.]251[.]50[.]19* and *47[.]251[.]129[.]84*
- Many of the scam domains are misconfigured, with their *www* subdomain under Cloudflare and their primary domain under the domain registrar listed above.
- We identified two unique merchant names and five unique merchant identification numbers (MIDs) in use across seven unique scam website domains, which will likely allow financial institutions to blacklist transactions for scam websites in this campaign.
- Business information indirectly linked to this scam campaign may enable financial institutions and PSPs to surface additional merchant accounts used by this scam campaign.

Background

Scam e-commerce website campaigns — including those that exploit reputable brand names to attract victims — are an established fraud threat. In November 2020, the Payment Fraud Intelligence team (then known as [Gemini Advisory](#)) identified a China-based scam e-commerce campaign and documented the campaign's use of fraudulent merchant accounts to compromise and sell victim card data and personally identifiable information (PII). In November 2023, we [reported](#) three key trends in threat actors' scam e-commerce campaigns. Most recently, [The Guardian](#) reported the discovery of a China-based scam shopping campaign consisting of over 76,000 scam websites that targeted over 800,000 victims in May 2024.

Generally, our analysis indicates that threat actors operate related networks of scam e-commerce websites alongside merchant accounts that they can pivot to multiple active scam website domains. These linked merchant accounts allow threat actors to simultaneously monetize and compromise victims' card data, which they later post for sale on dark web carding shops and similar sources.

Threat Analysis

In April 2024, we identified a scam e-commerce campaign spanning 608 fraudulent e-commerce domains that imitated popular brands to attract victims. The scam campaign was designed to steal victims' funds, card data, and PII through transactions with linked merchant accounts. The scam e-commerce websites we identified combined brand exploitation with time-sensitive offers, likely to create a sense of urgency among victims. As indicated by a brand trust [survey](#), these tactics almost certainly present a risk of brand impairment to imitated businesses.

Our initial identification was based on the detection of a scam ad campaign. Although the scam ads featured user testimonials in comments, our analysis indicated these comments were likely generated as part of an effort to boost victim engagement. The scam ad campaign explicitly targeted victims on mobile devices.

Merchant accounts and related domains linked to the scam websites are registered in China, indicating that the threat actors operating this campaign likely established the business they use to manage the scam merchant accounts in China. Since transactions on the scam websites were processed through merchant accounts with names that were distinct from the scam websites, victims would likely be unable to recognize the original scam website in their transaction history, potentially deterring them from seeking recourse through chargebacks or other means.

During our analysis of the identified scam websites, we identified no disclosed addresses or legal entities associated with them. Legitimate websites often list details of the legal entities under which they operate and the address where the business that owns the website is registered. The absence of such information is often — but not always — a key indicator of a scam website. We have previously identified scam websites both with and without such information, which were typically located in China.

We describe our findings in greater detail in the sections below.

Online Ads and Limited Time Offers Lured Potential Victims to Scam Websites

The operators of this scam e-commerce campaign used online advertising campaigns to attract potential victims to their scam e-commerce websites. Attracting victim traffic is the first major hurdle threat actors must overcome to operate scam website campaigns. Online advertising campaigns allow threat actors to disseminate their scam lures at scale. This campaign used Facebook Ads (also known as Meta Ads) to attract victims.

The use of online advertising to disseminate fraud lures to victims is not novel. In September 2023, we [identified](#) a sophisticated malvertising ecosystem that sees fraudsters abuse victim-funded ad campaigns to ultimately steal and monetize card data, among other things.

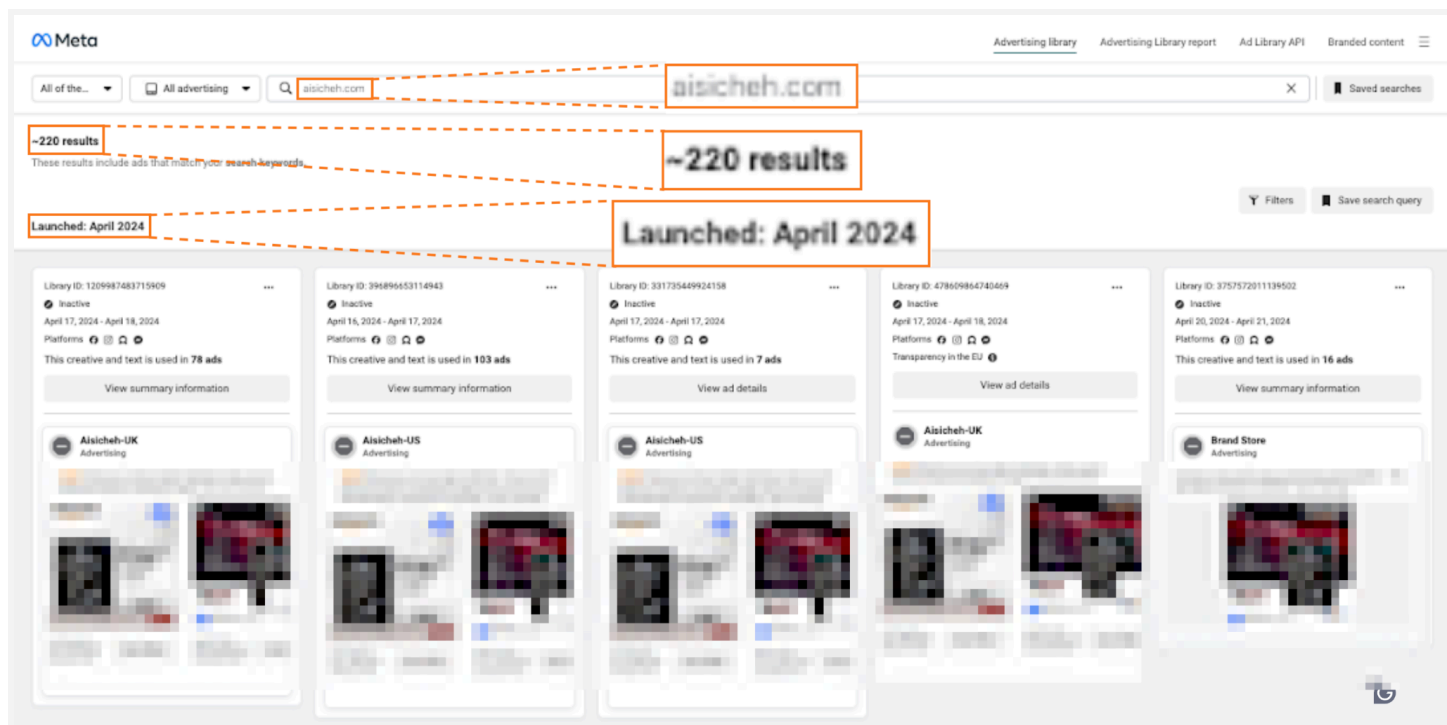
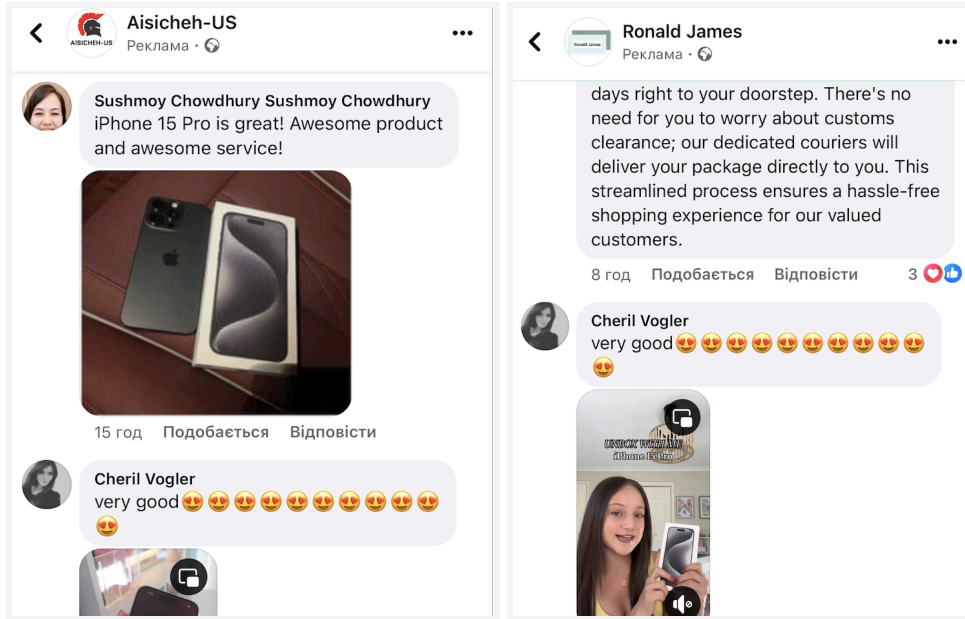


Figure 1: The advertising campaign for the *aisicheh[.]com* scam website included 220 ads (Source: facebook[.]com)

Our investigation of this scam e-commerce campaign began after we identified an increase in suspicious advertisements for a major e-commerce platform on Facebook. We examined one of the domains associated with these scam advertisements (*aisicheh[.]com*) and identified the related advertising campaign, which included 220 ads for the domain (**Figure 1**). The advertising campaign ran from April 15, 2024, to April 21, 2024.

Facebook Ads occasionally blocked the scam advertisements and ultimately blocked the account responsible for the ad campaign, indicating that the service's fraud-detection algorithms are at least partially effective. However, the short life of the actual scam domains suggests the ad campaigns were likely also designed to be short-lived, indicating their operators' intention to attract and defraud their victims quickly. This tactic is more likely to be effective when scam advertising campaigns are operated at scale, as was the case for this campaign. The concurrent presence of over 100 ads for a single scam website domain on the same platform is likely to attract victims to the linked domains whether or not the ads are detected and blocked in a timely manner.

The operators of this scam campaign likely used fake user comments to attract potential victims from across the globe. We identified duplicate comments for ads linked to *aisicheh[.]com* and for those linked to *debutied[.]com* (**Figures 2 and 3**), indicating the scam domains were likely being operated and disseminated as part of a single scam e-commerce campaign. The campaign operators duplicated identical comments for various ads within the same scam campaign, indicating a concerted effort to promote the scam websites through social media marketing tactics.

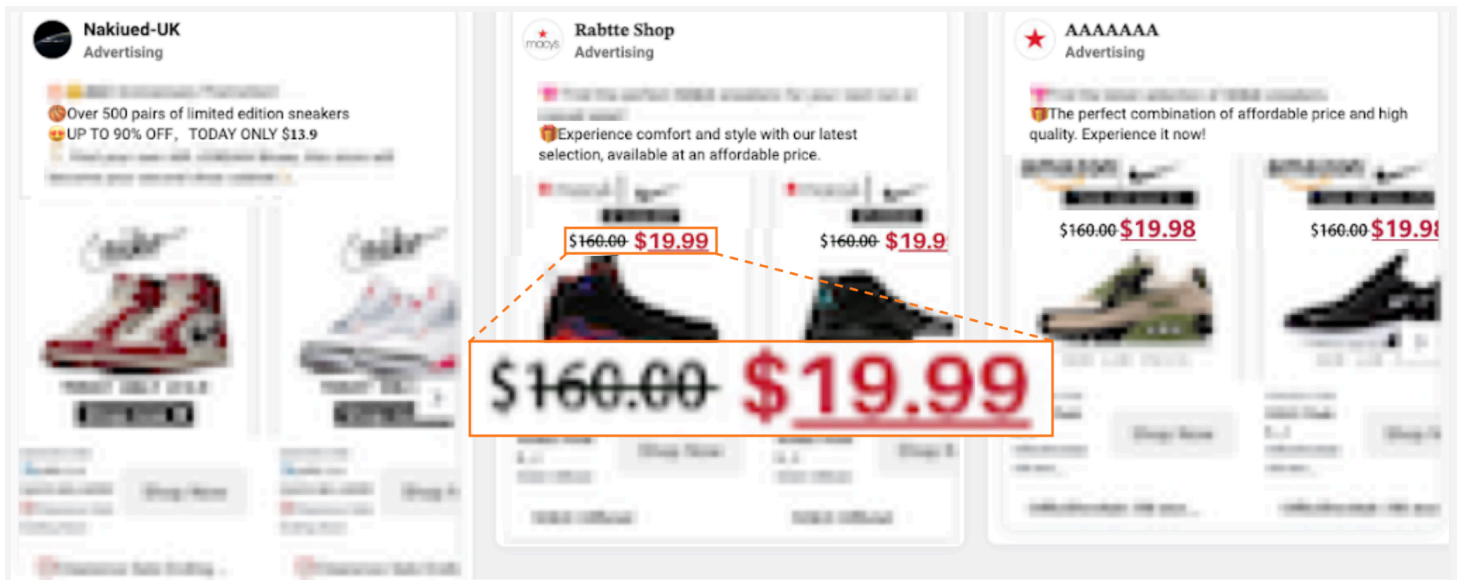
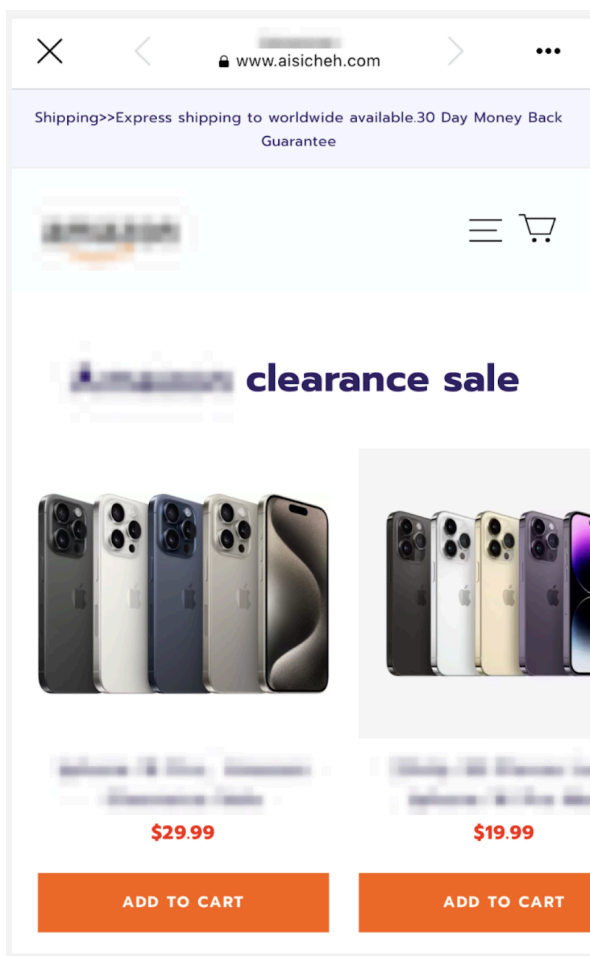


Figure 4: This scam ad campaign advertised limited-time offers for sneakers, likely to create a sense of urgency among victims (Source: facebook[.]com)

This scam e-commerce campaign’s operators likely used fictitious limited-time offers to generate a sense of urgency among potential victims. As with legitimate marketing efforts, this was likely intended to encourage impulsive purchases among victims and increase the likelihood of the scam’s success. One scam ad campaign we identified promoted sneakers that usually retail for \$160 for as little as \$20 (Figure 4).

Scam Campaign Targeted Mobile Browsers and Blocked Desktop Browsers, Likely to Avoid Detection

The scam campaign deliberately targeted users on mobile devices who arrived at the scam websites via the campaign's Facebook ads but blocked desktop users and users who directly navigated to the scam websites via URL input. The threat actors screened out visitors based on their referrer and user-agent headers. If a visitor's referrer value indicated Facebook and their user-agent value indicated a mobile device, then the visitor would be directed to a functioning scam website (**Figure 5**). If these criteria were not met, then the visitor would be served a 404 error page (**Figure 6**).

The threat actors operating the scam campaign likely screened their victims to reduce detection and increase the lifespan of the scam campaign. Generally, online ad services like Facebook Ads and third-party security tools use automated algorithms to scan ad content for malicious indicators. For this scam campaign, the threat actors likely intended to reduce detection rates for their malicious ads by adding two criteria to access the scam websites — a mobile device-based user agent and a referrer

header from Facebook — that real victims would possess but automated systems may fail to incorporate.

Ultimately, the degree to which these screening parameters reduced detection rates is unclear. The Facebook ad campaign for *aisicheh[.]com* ran for five days before being suspended, and its associated scam website domains were short-lived. Complaints from victims and third parties could have also triggered its suspension.

In **Table 1**, we summarize the outcomes of access attempts to the scam websites in this campaign based on the device and method used by the victim, as indicated by user agent and referrer header. Note that attempts to access the scam websites via a desktop browser were also successful, provided the user-agent value was configured to imitate a mobile device.

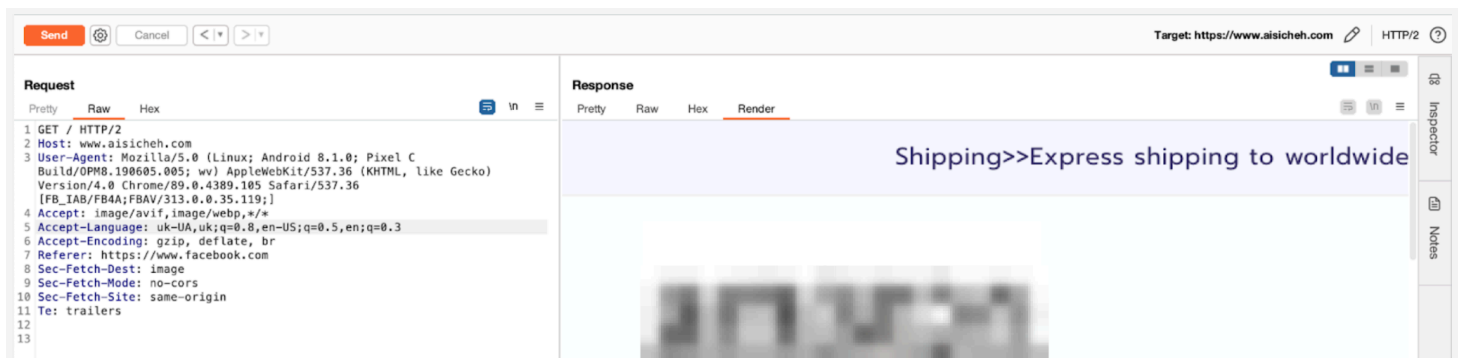


Figure 7: The scam websites still presented their fake e-commerce pages when accessed via desktop browser and Facebook ad lure — provided the browser's user agent (line 3, upper left) was configured to imitate a mobile device (Source: *aisicheh[.]com*)

Network and Domain Analysis Enabled Identification of Scam Websites

Our full analysis revealed 608 domains linked to the scam e-commerce website campaign and associated ad campaign; we list these domains in the [Appendix](#) of this report.

Our investigation identified four characteristics that served as indicators for this scam campaign. We used the presence of the first three of these indicators — listed below — to confirm our identification of each domain as a scam website.

Content Delivery Network

The use of the CDN known as *oss[.]eriakos[.]com* by a domain was an essential and distinctive indicator for scam websites in this campaign. We observed this CDN in use across all versions of the websites we analyzed, regardless of whether the Facebook Ads referrer header or mobile user-agent data was present. CDNs are geographically distributed groups of servers used to deliver web content quickly, reliably, and securely.

Note that the CDN *oss[.]eriakos[.]com* has previously been associated with fraud activity. However, as of this writing, it is unclear if the CDN is exclusively used to support fraud or other illegal activity.

Domain Registrar

Another indicator for scam websites in this campaign was the use of the domain registrar Alibaba Cloud Computing Ltd. d/b/a HiChina ([www\[.\]net\[.\]cn](#)) to register the domain. While the registration of a single domain name with a particular registrar is not suspicious, the registration of all domains linked to the identified scam ad campaigns indicated the operators of this campaign had made an effort to register the scam domains at scale. Domain registrars are companies responsible for leasing domain names to the public.

IP Address

The presence of one of two IP addresses — *47[.]251[.]129[.]84* and *47[.]251[.]50[.]19* — also served as an indicator that a domain was a scam website. Similar to the CDN *oss[.]eriakos[.]com*, these IP addresses have been associated with fraud activity. As of this writing, it is unclear if they are exclusively used to support fraud or other illegal activity.

Domain Misconfiguration

In addition to using the domain registrar Alibaba Cloud Computing Ltd. d/b/a HiChina ([www\[.\]net\[.\]cn](#)), we identified a specific domain misconfiguration as another key indicator for scam websites linked to this campaign. While the scam websites' main domains were registered under the above domain registrar, their *www* subdomains were registered under Cloudflare. Note that we did not manually verify whether domain misconfiguration was present for every identified scam website.

Merchant Accounts and Businesses Linked to the Scam Campaign

We obtained merchant account data and indirectly linked business information for a portion of confirmed scam websites in this campaign.

Linked Merchant Account Data for Scam Website Checkout Pages Used for Cash-Out and Data Theft

During our investigation, we collaborated with partner financial institutions to surface linked merchant account data for the identified scam websites (**Table 2**). The merchant account data we surfaced indicated the scam websites were using two Chinese payment service providers (PSPs) — AQAPAY and Hui — to process victim transactions. As described above, the scam websites did not allow victims to access the website's checkout page if a Facebook referrer header was not present. When accessing the scam websites with the Facebook referrer header and mobile user agent, the websites presented their checkout pages. These checkout pages functioned like legitimate e-commerce checkout pages and accepted payments from cards on major card networks.

Confirmed Scam Merchants Likely Offer Leads for Additional Scam Merchant Identification

Financial institutions and PSPs may be able to business information indirectly linked to the scam merchant accounts we identified in Table 2 to surface additional merchant accounts related to the ERIAKOS scam campaign.

We derived five domain names from the text of the merchant names listed in Table 2 (e.g., “AQAPAY***shpebe**” → **shpebe[.]com**). Each of the websites on these domains listed business information (**Table 3**) that was not present on any of the scam websites we identified. It is worth noting that these businesses are registered in Hong Kong, which aligns with the merchant account data we surfaced.

Merchant accounts are frequently named after the e-commerce domain or business they are associated with. Although the scam merchant accounts we identified clearly use a domain-based naming convention, our understanding of scam TTPs and merchant naming conventions suggests more merchant accounts linked to this scam campaign that use a business-based naming convention may exist.

If additional merchant accounts using a business-naming convention do exist, financial institutions and PSPs can likely surface these accounts, including by querying historical transactions.

Mitigations

- Identify merchant account information for the scam website domains listed in this report.
- Blocklist merchants affiliated with the scam domains in this report and block customer authorizations or transactions with these merchants.
- Check historical transaction activity for the merchants identified in the report to identify card accounts that may have been exposed to the risk of compromise.
- Solicit scam website leads from your customers to identify scam campaigns that pose a threat to your customer base. Engagement with customers is crucial to identify scam websites such as those identified in this report, which chiefly target users on social media and employ various methods to reduce the likelihood that victims will report them as scams.
- Provide scam website leads to Recorded Future Payment Fraud Intelligence to identify related scam websites that may pose a risk to your customers — and, by extension, your organization. Early information sharing is crucial to determine the scope and threat level posed by scams.
- Review fraud intelligence reporting to stay abreast of trending scam threats to your customers and your organization. Share common elements for identified scam website campaigns with your customers and encourage them to avoid interacting with these websites.
- Leverage [Recorded Future Payment Fraud intelligence](#) (PFI) to detect and mitigate possible scam websites using the PFI common-point-of-purchase (CPP) dataset.
- Leverage [Recorded Future Brand Intelligence](#) to detect and mitigate brand impersonation threats.

Scam websites pose a direct risk to financial institutions' customers. To reduce this risk, encourage your customers to apply the following mitigation strategies:

- Only provide personal and payment information on secure, trusted websites.
- Research companies before you make purchases from them. Review complaints on the Better Business Bureau's (BBB) [official website](#), ask trusted sources, or perform a web search to understand others' experiences with the company.
- For companies you trust, verify the legitimacy of e-commerce websites and their payment subdomains before making purchases. Check the website's URL, ensure that it uses HTTPS, and compare it to the official website's URL.
- Understand the terms and conditions for purchases you make, and be aware that honest businesses do not hide these terms from their customers. Do not continue with your purchase if the terms and conditions differ from your understanding of the offer. Be wary of pre-checked boxes that may give your consent to sign up for expensive monthly subscriptions.
- Be wary of unsolicited communications or advertisements. Scam operators frequently use social media advertisements or other online advertisements to disseminate their scam sites.
- Stay aware of common scams and phishing techniques and remain vigilant when interacting with online social media content.
- Report scams to your card issuer and the BBB and dispute losses to attempt to recover your funds through chargebacks.

Outlook

Brand impersonation is an enduring tactic for scams and phishing websites because it is effective. For this reason, the operators of this campaign will likely continue to model their scam websites after the brands they are currently imitating in order to attract potential victims as quickly as possible. They may also target additional brands for impersonation or expand their fraud-malvertising tactics through the abuse of additional online advertising services. As is typical for scam website campaigns, this campaign will likely continue to expand to additional domains. The scam operators may also be able to acquire additional merchant accounts to steal victim funds and data, although the barriers to acquiring merchant accounts are likely greater.

More broadly, the expanded use of the screening TTP we observed for this campaign among other scam campaigns would likely indicate a wider trend toward similar TTPs. By extension, the increased adoption of these screening TTPs would likely create detection gaps for current scanning technology designed to detect brand abuse, which could prolong the lifespan of scam websites, increase victim exposure to the websites, and delay takedown operations.
