Regulations under the Radiation Protection and Control Act. 1982

PURSUANT to the Radiation Protection and Control Act, 1982, and all other powers, I, the Governor, with the advice and consent of the Executive Council, make the following regulations.

Regulations under the Radiation Protection and Control Act, 1982

- 1. These regulations may be cited as the 'Ionizing Radiation (Amendment No. 1) Regulations'.
- 2. The Ionizing Radiation Regulations, 1985 (No. 47 of 1985) made on 4 April 1985 and published in the *Government Gazette* of the same day at page 993, are in these regulations referred to as the 'principal regulations'.
- 3. Regulation 15 (1) of the principal regulations is varied by deleting from paragraph (d) the passage 'the number 1.25;' and substituting the passage:

'the number 1.25, expressed in millisievert.'.

4. Regulation 101 of the principal regulations is varied by deleting from paragraph (b) of subregulation (3) the passage 'from 10 000 microgray per hour to and substituting the passage:

'from 10 microgray per hour to'.

- 5. Regulation 150 of the principal regulations is varied by deleting from subparagraph (i) of paragraph (a) of subregulation (1) the words 'air kerma' and substituting the words 'absorbed dose'.
 - 6. Regulation 171 of the principal regulations is varied:
 - (a) by inserting in subregulation (3) after the word 'gauge' the passage ', that is first installed after 1 April 1986,';
 - (b) by deleting from subregulation (5) the passages '4.3.6,' and '4.3.20, 4.3.23,'; and
 - (c) by inserting after subregulation (5) the following subregulation:
 - '(5a) The owner of a radiation gauge that is first installed after 1 April 1986 shall comply with the requirements of paragraph 4.3.6 of the Code.'.
 - 7. Subregulation (5) of regulation 172 of the principal regulations is revoked.
- 8. Regulation 193 of the principal regulations is varied by deleting from subregulation (2) all the words after the word 'Act' and substituting the following passage:

'premises:

(a) in which radioactive substances are stored in transit during the course of transport in accordance with the Radiation Safety (Transport of Radioactive Substances) Regulations, 1984; and (b) in respect of which an application has been made to the Commission for registration and in respect of which the Commission has not made a determination,

are premises of a prescribed class.'.

- 9. Regulation 199 of the principal regulations is varied by inserting after subregulation (5) the following subregulation:
 - '(6) Paragraph (a) of subregulation (2) of this regulation shall not apply to a fume cupboard that is a laminar flow cupboard.'.
- 10. Regulation 200 of the principal regulations is varied by inserting in paragraph (a) of subregulation (2) after the words 'glove box' the words 'or other total enclosure'.
- 11. Schedule 1 to the principal regulations is varied by deleting from Group 1 the symbol 'Cf-259' and substituting the symbol 'Cf-250'.
- 12. Schedule 7 to the principal regulations is varied by deleting Form 4 and Form 5 and substituting the following forms:
