































	<p><b>SOURCE OF DATA COLLECTION</b> Your personal data identified below (the "<b>Personal Data</b>" or "<b>Data</b>") may be collected directly when you visit one of our galleries located in Italy, France, the United Kingdom, Hong Kong, China, and the United States (the "<b>Galleries</b>"), during exhibitions, trade fairs, and/or our events, when you browse on our Website or purchase, for your own or on behalf of the company you represent, one of our works (the "<b>Works</b>") or catalogues of Works, either at our Galleries or through the Website.</p>

Purpose of processing			
 <p>1. Purchase of Works and Catalogues</p> <p>Allow the purchase, in person or remotely, also on behalf of a company, of Works or catalogues of Works at one of our Galleries, at trade fairs or at the Website and provision of after-sale services.</p>		<p><b>Type of Data</b> Personal and contact details, such as name, surname, tax identification code, email, telephone number, shipping address, ID information, and possibly role in the company you represent. Purchase data such as means of payment, type and price of Works or catalogues of Works purchased.</p>	
		<p><b>Legal Basis</b> The need to fulfil pre-contractual and contractual obligations to which you, or the company you represent, are a party.</p>	
		<p><b>Nature of Provision</b> Required. If you do not wish to provide your Data, the Data Controller will not be able to execute the corresponding purchase order or provide the services for the Works or catalogues of Works.</p>	
		<p><b>Data Retention Period</b> The Data Controller undertakes to delete Data provided for the execution of the sale and management of after-sale services from its systems 10 years after the date of the last purchase or the last interaction with the Data Controller.</p>

Therefore, shorter data analysis times would not allow the provision of customized services. In any event, the Data will be retained for 10 years for sales management and after-sale services.

			<p><b>Legal Basis</b></p> <p>The lawful interest of the Data Controller in optimizing the efficiency of its marketing activities, balanced against Customers' interest in receiving only communications of interest to them regarding the category to which they belong (private customer or art advisor, whether they have made online purchases or from one of our Galleries, if they are resident in a particular region).</p> <p>We will only send promotional communications according to your group or category if you have given your consent, which may be withdrawn at any time and without prejudice. **COOKIES**

The website uses information technology for the direct acquisition of personal user identification data consisting of "code strings": "cookies". For all information about cookies active on the Website and the related processing of personal data, please see the relevant policy statement in the "Cookie policy" section of our Website.

The information contained in this policy does not apply to third-party websites, apps or content of any kind, even if accessible from the Website by clicking on links contained therein. In such cases, the data protection provisions of such third parties may apply, which may differ from those presented herein and which the data subject is invited to consult prior to the communication of any Data.

**METHODS OF DATA PROCESSING**

The Data will be processed in compliance with the principles of fairness, lawfulness and transparency, through manual and automated methods and using paper and electronic means, in any case within the limits of the purposes of the data processing(s) established by this privacy policy information sheet and, in any case, always guaranteeing the security and confidentiality of the Data.

In addition, and without prejudice to the above, the Controller undertakes to base the processing of Personal Data on the principles of minimization, verifying on an annual basis the need for their storage for a period not exceeding that required by the purposes for which the data were collected and processed. The Controller may retain Personal Data in order to comply with the law or to exercise or defend any right or claim in judicial proceedings. Once the purposes for which the Personal Data have been collected and processed have been achieved, the Data Controller shall implement appropriate measures to make them anonymous, so that the data subject cannot be identified.

**POSSIBLE AUTOMATED DECISION-MAKING PROCESSES**

As indicated above, the Data Controller shall, on the basis of its lawful interest, categorize its customers in order to send commercial information on shows, exhibitions, trade fairs and events targeted at the needs of a certain category or group of customers to which you belong. This procedure is carried out by dividing the interested parties into non-invasive and non-discriminatory categories, such as country of residence (residents in Italy, for example, if it involves identifying a category of parties who may be interested in an event in Milan), type of customer (private customer or art advisor who operates individually or on behalf of a company) and purchase channels used for the Works or catalogues of Works (e.g. differentiating communications addressed to customers who mainly use the Website from those preferring purchases at the Galleries and trade fairs). Following this analysis, which may also be automated, the user can be classified into one or more groups with different characteristics and receive from the Data Controller, communications dedicated to the category that the Data Controller considers are in line with the customer's requirements. In relation to such processing, the Data Controller has successfully conducted a fair balance test in order to determine that the processing linked to the categorization in question is conducted on the legal basis of the lawful interest of the Data Controller in achieving maximum efficiency in its marketing activities.

The Controller may also, with your consent, analyse your purchasing habits over time, for a more in-depth assessment than one based on a simple categorization, of which Works or initiatives best meet your tastes and preferences (for example, if during a 2-year period you demonstrate an interest in a particular Work or artist, we will send you proposals dedicated to that type of Work or artist and not others that are not of interest to you or that are outside your sphere of tastes and preferences). In this way we can offer you a unique and customized shopping experience even if you visit one of our Galleries. In that case, our sales team will be able to recognize you and direct you more efficiently to the Work or to the artist that you prefer. Of course you can always ask our team to evaluate different proposals. It should be noted that the Data Controller has conducted a specific impact assessment of the processing of personal data necessary for profiling to ensure compliance with the principles of the GDPR, including non-discrimination, efficacy and the absence of harmful consequences for the Data Subject.



**DATA RECIPIENTS/CATEGORIES OF RECIPIENTS**

Data may be collected and processed by our staff expressly authorized to process the Data on the basis of instructions and subject to the adoption of appropriate measures to protect the Data in relation to all the purposes indicated above, and by the staff of our related and/or subsidiary companies listed below who manage the Galleries abroad (the "MDC Companies").
