This Guide for Authors is valid until the 2025 edition, Volume 21. SOLA will be published as a Springer/Nature journal starting from the 2026 edition. Manuscripts submitted after September 2025 and those accepted after January 2026 will be published as S/N Journal articles with a different APC from the current regulation and a different editing platform from the current system. It should be remarked that there is possibility that the manuscript submitted in 2025 and accepted much earlier than 1 January 2026 must wait for publication until the S/N publication platform opens. For manuscripts published as S/N Journal articles, please refer to the submission guidelines that will be independently provided soon later (as of 16 July 2024).

## AIMS AND SCOPE

*SOLA (Science Online Letters on the Atmosphere)* is a peer-reviewed, Open Access, online-only journal. It publishes scientific discoveries and advances in understanding in meteorology, climatology, the atmospheric sciences and related interdisciplinary areas. SOLA focuses on presenting new and scientifically rigorous observations, experiments, data analyses, numerical modeling, data assimilation, and technical developments as quickly as possible. It achieves this via rapid peer review and publication of research letters, published as Regular Articles.

Published and supported by the Meteorological Society of Japan, the journal follows strong research and publication ethics principles. Most manuscripts receive a first decision within one month and a decision upon resubmission within a further month. Accepted articles are then quickly published on the journal's website, where they are easily accessible to our broad audience.

## JOURNAL POLICIES

*SOLA* upholds the highest scientific and publication ethics standards and the journal's various policies are detailed below. *SOLA* follows the Committee on Publication Ethics (COPE) guidelines when dealing with any cases of misconduct or dispute.

### *Acceptance criteria*

*SOLA* is a rapid review, rapid publication journal that publishes articles meeting the basic criteria for scope, length, ethical standards, English standards and clarity of expression. In addition, articles must be scientifically rigorous and technically proficient, with methods and analyses that are appropriate to the study being reported.

Furthermore, all manuscripts reporting original research should:

- a) contain observations, experiments, data analyses, numerical models, or theory concerning the basis and application of meteorology, climatology, and atmospheric sciences
- b) contain new findings with scientific value or technical developments, obtained by the authors themselves
- c) have logically explained conclusions
- d) be written in clear and concise English.

### ***Authorship***

By submitting to *SOLA*, all authors undertake that they have agreed to the author list. Any amendments to the list (such as changing the order, or adding or removing authors) after submission must be approved by all authors and the Editor. In addition, all authors must have contributed substantially to the work; have agreed to be accountable for their contributions to the work; be able to identify the co-authors responsible for each part of the work; have confidence in the integrity of the work; and have reviewed and approved the final manuscript. Contributors who do not qualify for authorship should be included in the Acknowledgements section.

### ***Duplicate submission and unoriginal material***

Authors must not have submitted their manuscript to another journal before the Editorial Committee makes the final decision on its suitability for publication in *SOLA*. If there is an indication of duplicate submission, the Editorial Committee will investigate further and will reject immediately in cases where duplicate submission is confirmed.

The journal screens accepted articles for any unoriginal material before publication using the iThenticate service (ithenticate.com).

Authors may freely submit their manuscripts to another journal after withdrawal or rejection from *SOLA*.

### ***Author warranties***

When submitting a manuscript to *SOLA*, the author(s) warrant that:

- a) The article is original and is not under consideration for publication in any other journal.
- b) The author(s) are the sole author(s) and sole owners of the copyright in the manuscript, and the manuscript does not infringe on existing copyright or other third-party rights. If material from other sources is included in the manuscript, then appropriate permissions have been obtained.
- c) Due care has been taken with the preparation of the manuscript to ensure its integrity, that the facts presented are true and accurate, and that nothing in the manuscript is obscene, defamatory or libellous or violates any right of privacy.

### ***Image and data integrity***

Images, especially graphics files, which are included in a manuscript for review should not be processed except for necessary guides for readers (e.g., labels or arrows, etc.). If manipulation is necessary, it should be applied to the entire image and any changes should be noted in the manuscript.

Any data associated with images or other aspects of the manuscript must be retained by the

authors and provided upon request.

### ***Reproducing copyrighted material***

If a manuscript contains a figure or other material from another source, the authors must provide documentation of the permission to re-use from the copyright holder. *SOLA* is not responsible for obtaining these permissions and authors warrant that they have the rights, or have obtained them, for all material in their manuscripts.

### ***Availability of data and materials***

*SOLA* encourages authors to include the data underlying their work as Supplementary Material. These data, which must be under 50MB, may describe observations, experiments, modeling or analyses and may take the form of databases, simulations, movies, large figures or as otherwise appropriate.

### ***Conflicts of interest***

*SOLA* strives for transparency around any real or perceived conflict of interest regarding articles published in the journal. A conflict of interest exists when judgement about one interest might be influenced by a secondary interest. This can extend to any financial consideration, academic competition and rivalry, personal rivalry or intellectual incompatibility. Conflicts of interest extend to all participants in the peer-review process: authors, reviewers, Editors, and Editorial Committee members.

Any real or perceived conflicts of interest by any of the participants in the publication process must be considered while undertaking their respective tasks for *SOLA*. When relevant, they should be declared clearly to the relevant person.

Authors should declare in their cover letters whether they have any conflicts of interest (financial or otherwise). If so, the Editor will determine the most appropriate course of action. Reviewers are asked to declare any potential conflicts of interest and recuse themselves if the potential for bias exists.

The Editors and Editorial Committee undertake to declare their conflicts of interest when handling manuscripts for publication.

### ***Confidentiality***

*SOLA* maintains the confidentiality of all submitted and rejected manuscripts. By submitting to the journal, authors agree to keep all correspondence about their manuscript (from the Editorial Office, editors and any others) confidential.

*SOLA* uses single-blind peer review, so the identities of reviewers are not revealed. Journal staff will not disclose a reviewer's identity unless the reviewer requests it. As part of their responsibilities, reviewers undertake to maintain the confidentiality of manuscripts to which they have access.

### ***Editorial and peer review process***

Upon submission, the Editorial Office ensures that the manuscript complies with the basic length and figure/table number requirements (see other sections for further details). For compliant manuscripts, the Chief Editor assesses whether the manuscript should be sent for peer review (and may often ask an Editor for assistance where necessary). If the manuscript is deemed suitable for peer review, the Chief Editor assigns an Editor who is responsible for

handling the peer-review process.

The Editor selects and assigns reviewers who are asked to return their reports within 2 weeks. When reports are received, the Editor assesses the manuscript and the reviewers' comments, and advises the authors of their decision: revise or reject.

If invited to resubmit a revised version, authors must do so within two weeks of the decision notification date. If the Editor judges that the manuscript needs major revision and it would take more than two weeks to revise, the Editor will usually reject it. However, the Editor may also recommend that the authors resubmit the manuscript as a new manuscript after sufficient revision is completed. Authors should note this in the cover letter of any resubmission of a rejected manuscript.

Manuscripts rejected as being not suitable for the journal or judged to be unlikely to be able to be sufficiently revised will not be reconsidered and should not be resubmitted.

The review process for corrigenda is simpler. The Chief Editor or the previously assigned Editor are responsible for assessing the merits of each corrigendum. The Editor may consult the reviewers or the Editorial Committee members during the review process.

### ***Referee suggestions***

Authors are requested to provide the Editor in charge with suggestions of up to 5 potential reviewers, with their e-mail addresses, during the ScholarOne submission process. The Editor in charge reserves the right to determine the final selection of manuscript reviewers.

### ***Appeals***

Authors who believe that errors have been made during the editorial review process may contact the Chief Editor and lodge an appeal. Authors must provide specific evidence of a misunderstanding or mistake by a referee or editor. Appeals will be considered carefully by the Chief Editor, whose decision is final.

### ***Corrigenda and Retractions***

SOLA supports the correction of errors in the published literature. If published articles are found to contain significant errors, the Chief Editor and Editorial Committee will determine whether a Corrigendum or a Retraction is most appropriate.

Retractions are used for articles that have been found to have invalid or unsound results or conclusions, or for cases in which authors are believed to have breached research or publication ethics.

Corrigenda are used to correct mistakes in the article that were made by the authors or during the production process, respectively. When preparing Corrigenda, include the title, author names and their affiliations. The title should follow this convention: "Corrigendum: *Your original article title*". No Abstract is required.

The main text of Corrigenda does not need to be divided into sections. However, if you do require the use of separate sections, please follow the instructions for Regular Articles below. For other elements, please follow the relevant instructions for Regular Articles as described elsewhere within this document.

## HOW TO SUBMIT

Before submitting your manuscript, please read through the entire Guide to Authors and prepare your manuscripts according to the instructions. Manuscripts must then be submitted via the journal's ScholarOne system at <http://mc.manuscriptcentral.com/sola>. ## ARTICLE TYPES AND ARTICLE PREPARATION

*SOLA* publishes Regular Articles, which are generally shorter, letter-style articles within a maximum word count of 3100 at the time of submission (\*) and a maximum total of 7 figures and tables. Authors can determine the structure of the manuscript's main text (\*see below for more details).

Corrections (Corrigenda and Retractions) are published when justified. Authors who would like to submit a Corrigendum should contact the *SOLA* Chief Editor and see the 'Corrigenda and Retractions' section for more details.

A sample style file for each article type can be obtained from the *SOLA* ScholarOne webpage (<http://mc.manuscriptcentral.com/sola>).

### ***Cover letter***

The manuscripts must be submitted with a cover letter that contains the title, author name(s), affiliations, telephone and fax numbers, and e-mail address of the corresponding author (<http://mc.manuscriptcentral.com/societyimages/sola/Sample-Cover-Letter.doc>). A short paragraph on the manuscript's suitability for the journal is useful.

Authors may specify names of at least one appropriate Editor in charge of their manuscript and are required to specify names of 3–5 potential reviewers and their e-mail addresses when submitting the manuscripts through the ScholarOne submission system.

Requests for waivers of the Article Processing Charge (APC) should be made in the cover letter. See the Open Access section for more details on the journal's APC waiver policy.

If the manuscript is a resubmission of a previously rejected paper in *SOLA*, the cover letter should include the manuscript number of the previous submission. In this case, please include point-by-point responses to the reviewers' comments in the previous submission. The Chief Editor will evaluate the suitability of the resubmission and may assign the same Editor from the previous submission.

### ***English standard***

All manuscripts must be written in clear and concise English. Those not reaching the required standard may be returned to authors for further revision.

### ***Format***

Regular Articles should include the main text, figures, tables (if any), a cover letter, and the License to Publish form, signed by all authors. The License to Publish form can also be sent separately via e-mail to the address of the *SOLA* Editorial Office (sola\_edit@metsoc.or.jp).

The main text must be a double-spaced Microsoft Word (".docx" format is recommended) or PDF file with line numbers on the left side of the pages. The main text should include, in this order: the title, the author names and affiliation(s), Abstract, main text in appropriately divided sections, Acknowledgements, Supplementary Material (if required), and the References. We strongly recommend using the relevant template file, which can be found at the "Instruction & Forms" link at the *SOLA* ScholarOne webpage (<http://mc.manuscriptcentral.com/sola>).

### ***Word limit***

The main text must be less than 3100 words at the time of submission, including the abstract and the main body of the manuscript. Note that the title, author names and affiliations, Acknowledgements, description of the Supplementary Material, References, figure captions and words within Supplementary Materials are not included in the word limit. The total number of figures and tables must not exceed seven.

Manuscripts exceeding the word limit and/or the total number of figures and tables will be returned to authors without review by the *SOLA* Editorial Office.

At the time of acceptance (the final version of the manuscript), the maximum word count is permitted up to 3500 (which includes the abstract and the main body of the manuscript), in order to allow the authors to incorporate revisions during the review process. Note that the limitation of the total number of figures and tables combined applies to the final version of the manuscript.

### ***Title, author names and affiliations***

An informative title that is attractive to the journal's readers should be provided. The full names and affiliations of all authors, and the name, e-mail address, telephone and fax numbers of the corresponding author should be provided.

### ***Abstract***

A short abstract of 200 words or less is required with each manuscript.

### ***Text***

The text should be divided into sections, each with a separate heading and numbered consecutively. The section heading should be written on a separate line, e.g.,

1. Section
- 1.1 Subsection

- a. Item
- (1) ...
- (i) ... .

Mathematical formulas and equations should be written clearly in the text with ample space above and below.

### ***Running title***

The running title should encapsulate the article and not exceed 10 words.

### ***Acknowledgements***

The Acknowledgements section should include individuals who qualify as substantial contributors to the paper, but do not meet the criteria for authorship. The funding sources (including grant numbers) should also be included.

### ***Supplementary Material***

Up to 5 items of Supplementary Material, such as large figures and animations, can be included. Each item of material should be numbered sequentially and specified in the text for where appropriate. The maximum allowance is 50 MB for each item. The author(s) may link outside source data (figures, movies, and big data, etc.) from the Supplementary Material. The authors should briefly describe the contents of the items in this section.

### ***References***

References should be arranged alphabetically by authors' names, without numbering. For example, the citation of references should be as "according to Rossby (1940)" or "as shown by earlier studies (Rossby 1945; Charney 1947)." In the list of references, each reference must be complete in the following form:

For a journal article: author(s), year: title of article. title of journal (abbreviated), volume number, pages.

### ***Figures and tables***

The maximum total number of figures and tables is 7. You can use the Supplementary Material to display additional figures and tables, if you would like to show in excess of the total allowable number.

Upon submission, each figure and table can be prepared separately or can be included within a single file. Separate figure files will be required if the manuscript is accepted for publication. The resolution of figures and tables should be above 300 dpi. The following formats are acceptable for figure and/or table files: TIFF, GIF, JPEG, AI, EPS, and PSD. If your manuscript is accepted, the Editorial Office will request separate files for the production process.

If you prepare your figure/table files separately, you should upload them in numerical order to the *SOLA* ScholarOne system. In this case, the legends of the figures and tables must be provided in the text box on the figure upload page.

### ***Figure and table legends***

To help the Editor and the reviewers evaluate your manuscript, each figure or table must be provided with a cogent and succinct legend that allows it to stand alone.

Figures: Each figure should be mentioned specifically in the text. Lettering must be large enough to remain clearly legible when reduced to the journal's column width. Color figures are welcome.

Supplementary Materials: Authors are encouraged to effectively use this function of *SOLA* in order to enrich or supplement the contents of the main text. Examples are detailed descriptions of the methods used in the study, supplementary figures/tables/animations, and sample codes for numerical simulations, or data analyses.

## **OPEN ACCESS, COPYRIGHT AND LICENSING**

### ***Article Processing Charge (APC)***

Authors or their institutions who are members of the MSJ are charged an APC of 80,000 Japanese Yen; non-members are charged 100,000 Japanese Yen (plus consumption tax if applicable). There is no extra charge for supplementary file(s) and no submission fee.

Authors can order print-format reprints for their published article. Reprint costs are additional to the APC and authors are contacted during the production process about their requirements.



The journal will waive the APC on an accepted article if all authors lack a professional affiliation with a research organization or if all authors are based in a “Least Developed Country” or “Other Low Income Country” on the [OECD’s qualifying country](#) list. Other waivers will be considered on a case-by-case basis by the journal’s Editorial Office. Authors must apply for a waiver before or upon submission of their manuscript. Requests for waivers should be made in the cover letter and include evidence of financial hardship; requests will not be considered after the review process has started. The ability of an author to pay the APC does not influence editorial decisions. To avoid any possibility of undue influence, editors involved with the decision-making process for submitted manuscripts are not involved in any deliberations on waivers.

### ***Copyright, licenses and usage***

*SOLA* has been a fully Open Access journal from January 2018. Articles are published under the terms of the Creative Commons Attribution 4.0 International (CC BY 4.0) License (<https://creativecommons.org/licenses/by/4.0/>). This license permits users to adapt, distribute, and reproduce the articles of *SOLA* in any medium, even commercially, provided that the users give appropriate credit to the original author(s) and the original source, provide a link to the license, and indicate if changes were made, without obtaining permission from the Meteorological Society of Japan (MSJ). The copyright of articles is retained by the authors. Authors are required to sign a License to Publish form in order to give the MSJ permission to reproduce the article in *SOLA* under the Creative Commons Attribution 4.0 International (CC BY 4.0) license.

Note that the MSJ owns the copyright in *SOLA* articles published before 2018.

Sample codes and/or programs provided as Supplementary Materials can be used, copied, and modified freely without obtaining any permission from MSJ for any purposes, given no specific terms and conditions for use are provided in the main text. Authors are encouraged to specifically provide the terms and conditions for the usage of the sample codes. The MSJ shall not be responsible or liable for any loss, damages, or inconvenience caused by the use of the sample codes.

### ***License to Publish form***

The License to Publish (LTP) form signed by all authors should be uploaded to the file upload page on ScholarOne at the time of manuscript submission or should be sent separately via e-mail to the *SOLA* Editorial Office ([sola\\_edit@netsoc.or.jp](mailto:sola_edit@netsoc.or.jp)).

Authors subject to Crown copyright or similar government provisions can attend to these within the same LTP form ([http://mc.manuscriptcentral.com/societyimages/sola/LTP\\_SOLA.pdf](http://mc.manuscriptcentral.com/societyimages/sola/LTP_SOLA.pdf)).

## **POST-ACCEPTANCE PROCESS**

### ***Author proofs***

The author can view and edit the final form of the manuscript before the article is published on the journal’s website. No English proofreading or editing is carried out by the *SOLA* Editorial Committee or during the production process. Thus, the author is fully responsible for the quality of English of the manuscript and the journal strongly recommends authors have their manuscripts edited by appropriate individuals or companies as necessary.
