## **Walter Bebout Memorial Award for Leadership in Canine Legislation**

### **Nomination Form and Instructions**

The American Kennel Club supports and recognizes the outstanding efforts that individuals, AKC clubs, federations and dog breeder/owner groups have made in advocacy and participation in canine legislative issues in their states and communities. To honor and support these efforts, and in tribute to Walter Bebout, former director of AKC Government Relations, AKC has created the Walter Bebout Memorial Award for Leadership in Canine Legislation.

Recipients of the award will have demonstrated a significant contribution (leadership, financial, or time/effort) in advocating on behalf of responsible dog ownership and the rights of responsible dog owners and breeders in the public policy arena.

Nominees should meet the following criteria:

- Active citizen advocacy and involvement in canine legislation; OR
- Independently hired a lobbyist to advocate on crucial canine legislative issues;  
AND
- Active in community outreach on canine legislation/responsible ownership issues
- Financial need may also be considered.

Nominations, including self-nominations, may be submitted by clubs, federations or breeder/owner groups.

Honorees may be announced as often as quarterly (four per year). Honorees will receive a commemorative award and a contribution of \$1,000 to defray expenses or assist in ongoing legislative efforts. In cases where the recipient is an individual, the monetary contribution will be made to their club or federation. AKC will send press releases to the honoree's local media, and their achievements will be featured in AKC magazines/e-newsletters.
