The "Column select" and the free trail status dialogs do not have a dialog role or an accessible name.  The "Notifications" button in the header is reposted as a menu button, but is a plain button that launches a dialog.  The rows in the search grid are missing the required child nodes.  Elements with an option role are missing the required selected state for non-selected items in the "Filter input", "Cloud forms", "Network", "Advanced configurations", and "Subnets" components.  Toggle buttons in the "Open connections" chart change name when expanded, which is confusing with the expanded state.
