## SURVEY DEMONSTRATES EFFECTIVENESS OF BELIEVE IN SPORT CAMPAIGN

A survey conducted with a sample of more than 250 YOG athletes and coaches at the “Believe in Sport” booths during the Games shows that the large majority understood the sense of the campaign, learnt more about the topic of competition manipulation, rated the information provided as clear and enjoyed the educational activities. The campaign is available to all stakeholders, comes with a toolbox and will be also activated in the run-up to the Olympic Games Tokyo 2020.



### NEXT STOP: TOKYO 2020 BOXING QUALIFYING EVENTS

Following the successful activation at the Youth Olympic Games Lausanne 2020, the “Believe in Sport” campaign will now be deployed at the four continental boxing qualifying events for the Olympic Games Tokyo 2020, to take place between February and April.
