Preply does use cookies

Preply ("us", "we", or "our") uses cookies and other technologies on the http://www.preply.com Website and the Preply mobile application (the "Services"). By using the Services and clicking the respective buttons on our banners, you consent to the use of cookies for the purposes we describe in this policy.

Cookies are...

Those small files comprising bits of text that are sent to your browser by a website you visit. They enable our server to provide you with the information that is customized to your needs when you use the Services the next time. Functional
