

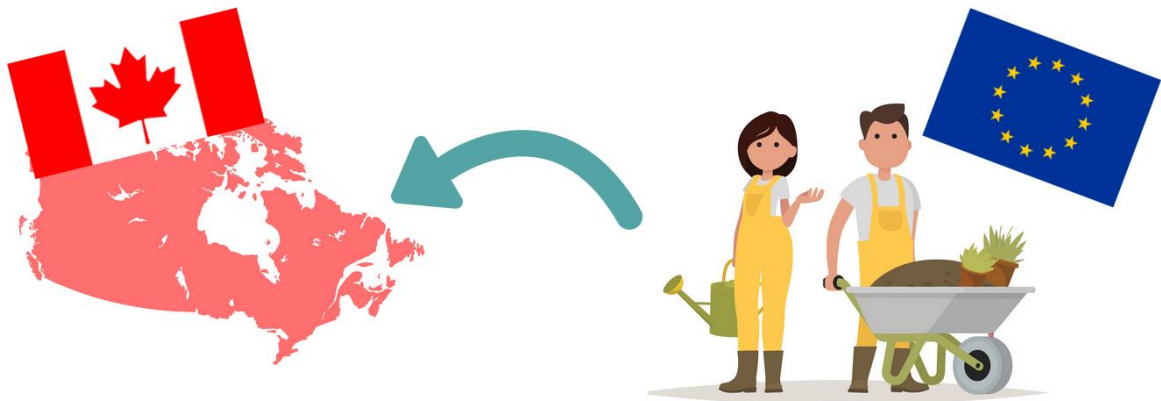

CETA removes Canadian customs duties and opens up the Canadian market to European food and drink products.

2. Protecting 143 Geographical Indications (GIs)



Promoting and protecting Europe's flagship food and drink products in countries outside the EU is a top priority for CETA, as for any EU trade deal.

CETA allows **143** European products with the status of Geographical Indications to be sold in Canada, giving them a similar level of protection from imitations as EU law does.
