

## Perceptions of Trump Guilty Verdict - HarrisX Overnight Poll - 31 May

This survey was conducted online within the United States from May 30 – May 31 among 1,006 registered voters by HarrisX. The sampling margin of error of this poll is plus or minus 3.1 percentage points. The results reflect a nationally representative sample of registered voters. Results were weighted for age, gender, region, race/ethnicity, income, political party, education, ideology and area type where necessary to align them with their actual proportions in the population.
