I've cc'd John McMahon on this. First, our collaboration and Voyager's support of LAPD all this time has truly been appreciated. We have been at times a difficult partner in exploring the values and application of this technology. I'm thankful that we were able to find a workgroup that dug in and identified the advantage of the application.

Unfortunately, given the severe cutbacks we are experiencing in our fiscal budget (\$150 million reduction - 500 fewer personnel and cutback in all accounts) and we have been asked to identify another \$51 million, I can not in all good conscious relay with any level of certainty that we will be able to fund this endeavor on an annual basis. The projected annualized costs exceeding \$300k far outpaces our funding sources. Likewise, our foundation commitments have been already been spoken for and can not be reprogrammed.

This know this is not welcomed news and a decision I have made every effort to avoid having to make. However, as bad as the last 6 months has been in fiscal cutbacks, it appears the next year will be even worse.
