You should already have received newsletters and since today you will get them every morning at 8PST. We managed to incorporate some of your comments:  
Re. 4: As agreed, you will get all 3 reports (English language tweets, LA specific tweets and tweets sent from LA area - all filtered by agreed subjects). The biggest report contains 10K tweets with higher reach per subject. Without this limit it gets so big that the emailing system can't handle it. I hope that's ok for you.  
Re. 5: We added Twitter accounts you listed and their tweets are listed in „Special Handles section”.  
Re. 7: We filtered out „[REDACTED]” account tweets from reports.

Early next week, we will come back with Searching Dashboards and some more improvements.

Received, thank you. Responses below in bold...

1) Please take a look at collected data - especially included tweets - and let us know if it works fine. Please be aware that we cannot filter out all irrelevant messages. We update queries daily to get a reasonable dataset, but there is still a significant amount of unrelated stuff. We may also miss some Tweets or articles - if you find subjects we are missing, please let us know, so we will be able to improve our queries.

2) What is the best time for you to get these newsletters? We recommend you every morning at 8AM your time.
