The purpose of this form is to authorize EQT Production Company and its affiliates to withhold the donation from your royalty payments, as indicated above, and provide it on your behalf, along with your name and address, to the GIVE Campaign fund(s).

I represent to EQT Production Company and its affiliates that I have the requisite power to make this authorization and directive. Donations will continue to be deducted on a monthly basis until canceled. Enrollment and cancelation may take up sixty (60) days depending on date of receipt of this form.
