Prior to the summer break, the Committee on Agriculture and Rural Development was immersed in the trilogue negotiations on the Common Agricultural Policy (CAP). The political agreement reached on 26 June has demonstrated that the new decision-making procedures introduced by the Lisbon Treaty can be made to work, even for the most contentious of dossiers. Our negotiating

success was testament to a huge collaborative effort within the Parliament, including a remarkable contribution from Policy Department Structural and Cohesion Policies, with its internal and external expertise underpinning every stage of the legislative process. European Council Conclusions on the Multiannual Financial Framework 2014-2020 and the CAP

This is the second working paper written by Policy Department B on the CAP inside the Multiannual Financial Framework for the 2014–2020 period. The purpose of this document, published in July 2013, was to provide a comparison between the European Council Conclusions of 7–8 February 2013 and the positions of the EP at the current stage of the financial and sector specific CAP negotiations. The aim was to provide gualitative and guantitative information to COMAGRI Members relating to the financial concerns of the CAP in order to support the ongoing trilogue negotiations.

Strasbourg-Lisbon-Chicago: NATO guo vadis?

The past three NATO summits have witnessed the rather turbulent development of the alliance's strategic environment. NATO has become much more focused on sustainable high-end operations abroad, but the likelihood of more action if this type is rather slim. With the financial crisis and the concentration of the US on Pacific security interests. European allies need to do more for European security. Today, NATO and the EU must develop a

profound and mutually beneficial cooperation. With the Lisbon treaty, which abolishes the pillar divides between the Union's security and defence policy and its other policies, the EU may now exercise a complete security role. A reflection on the question is today more important than ever before.

Occupational health concerns and the existence of stress-related and psychological problems associated with work

The study presents recent trends on stress at work as well as an overview of EU and national measures to tackle this problem, especially in the context of the economic and financial crisis. It also includes a number of case studies illustrating initiatives that proved successful in improving workers' mental well-being, in particular during

restructuring. Given the growing concerns on the impact of the economic and financial crisis on workers' mental health, one of the main recommendations put forward in the study is that the next Strategy, or any other relevant European framework, should include stress at work as a priority area.

Member States' Policies for Children with Disabilities (incl. 18 country reports)

This study presents the comparative analysis of case studies conducted in 18 Member States regarding their policy for children with disabilities. Member States' and the Union's legal frameworks were examined in relation to the obligations arising from the United Nations Conventions on the Rights of the Child and on the Rights of Persons with Disabilities.

The research identified a broad recognition of the rights of children with disabilities under national legal systems either through general or specific legislation. However, their practical implementation revealed to be problematic in most Member States resulting in obstacles faced by children with disabilities in their day to day life. This led to a set of recommendations for EU action to enhance the situation of children with disabilities. The 18 country reports are made available separately.

The study summarises the results of a peer review of the CIP and EIP evaluation reports. The peer review was conducted in two stages: first, the general CIP evaluation and, second, a detailed review of the EIP evaluation with regard to the specific needs of SMEs and how the EIP programme has targeted these needs. The peer review process was conducted with consideration of the heterogeneity and complexity of the nature of SMEs.
