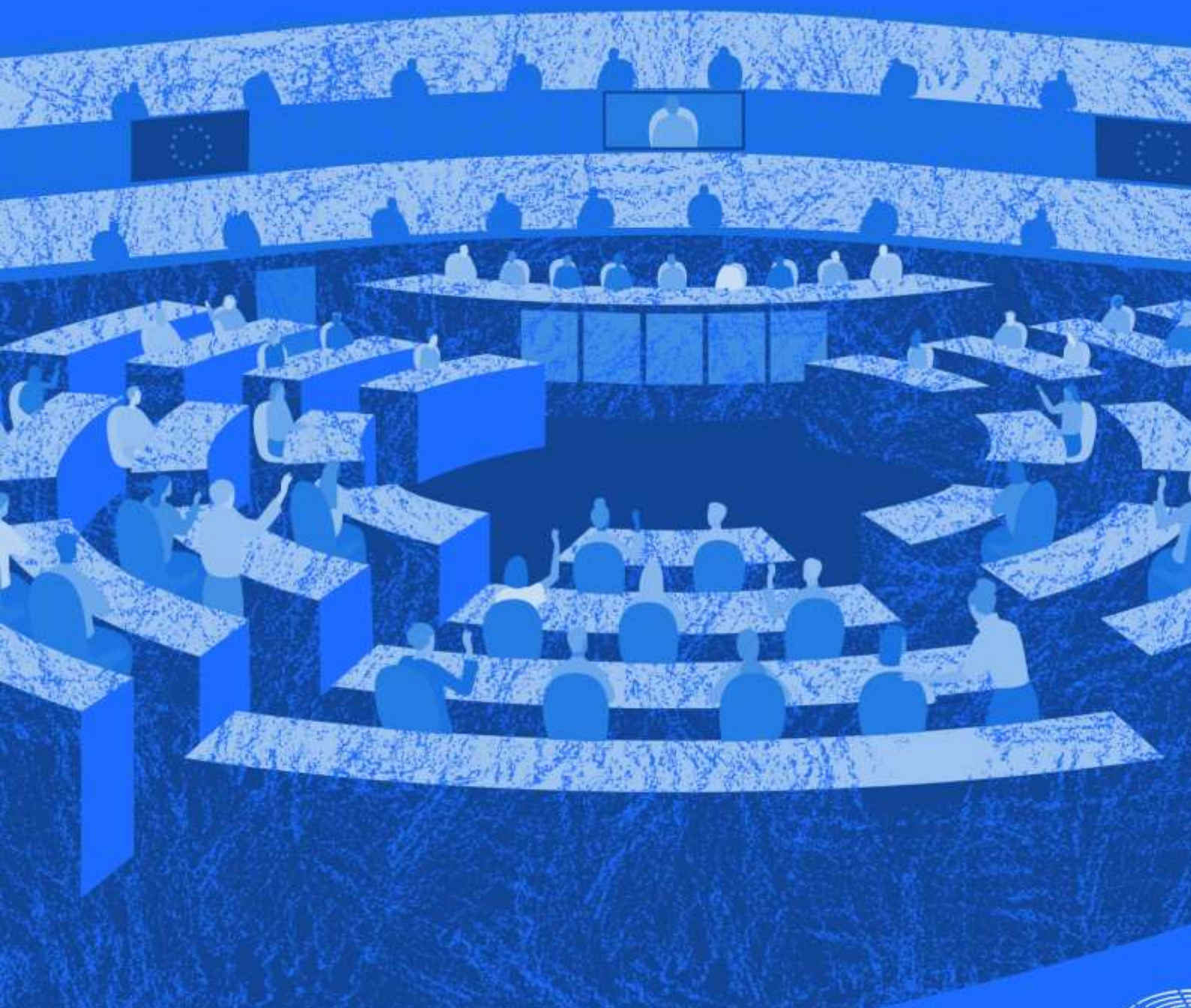

## Chairman's foreword

Dear Reader,

With the closure of the final plenary session of the Parliament's 9<sup>th</sup> parliamentary term, the time has come to reflect on the accomplishments of the Committee on the Environment, Public Health and Food Safety (ENVI) over the past five years.



During this period, we dealt with an unprecedented amount of legislative activities in all areas of ENVI committee competence. This significant volume of legislation has put the EU on consistent pathway towards climate neutrality and a nature-positive society. The change it has brought about is systemic and across all the sectors of the economy, which places the EU in a strong position to engage in the global endeavour to secure the localisation of green value chain. I am convinced that all the EU legislation we have passed in the past 5 years will make the EU stronger, more independent and more resilient.

It was a period marked by the COVID-19 pandemic crisis and Russia's war of aggression on Ukraine. The challenges we faced helped us build the European Health Union and did not weaken our support for the European Green Deal and its objectives. ENVI played a pivotal role in writing the carbon-neutrality goal into the European Climate Law and in passing all legislative proposals of the 'Fit for 55%' package that were required to ensure that all key sectors of the economy, including aviation and maritime transport, have emission reduction targets and contribute fairly to the green transition. Indeed, Parliament's negotiators were determined to achieve a high level of ambition, including a ban of the combustion engine for passenger cars by 2035, establishing more stringent emission standards for heavy-duty vehicles, and further expanding the Emission Trading System to the maritime sector. While asking our producers to do more to decarbonise, we also addressed the risk of carbon leakage through the Carbon Border Adjustment Mechanism, which will spur the creation of carbon pricing systems worldwide.

Enabling the EU economy to be more resource efficient, while stimulating green transition and enabling clean innovation, is another achievement of this parliamentary term. ENVI members worked to achieve the highest possible level of ambition for the batteries regulation. The law promotes the development of a competitive battery industry, an essential element for EU's clean energy and transport sectors, while ensuring that batteries are sustainable throughout their entire life cycle. ENVI also led Parliament's negotiations to a deal on another initiative that will play a pivotal role in driving green growth. The new Ecodesign regulation introduces circularity requirements of products to extend durability and reparability, enhance their energy and resource efficiency, and facilitate safe recycling. It also introduces a digital product passport that by providing reliable, comparable information about products' life cycle impacts on the environment, it will help establish a level playing field for circular materials, products and services. Finally, a political deal was reached on a law that will ensure that all packaging is more sustainable and recyclable, while also setting out targets for re-use of certain packaging. Parliament secured the introduction of a ban on the use of "PFAS" in food contact packaging.

ENVI also worked jointly with ECON to establish the sustainable finance framework, called the Taxonomy Regulation, which will help directing investments towards activities that

contribute to the EU's climate objective, reduce pollution or protect nature. ENVI also contributed to files from other committees, including to improve sustainability practices of business operators via reporting obligations and requirements to identify and mitigate environmental impacts within their value chain, including outside the EU. While in the middle of the energy crisis many called to put breaks on the green transition - ENVI defended the potential of the European Green Deal as the recovery and growth strategy, providing inputs to proposals promoting renewable energy, energy efficiency and energy performance of buildings.

In early 2020, the COVID pandemic outbreak put health at the top of the political agenda. Swift action was necessary to protect lives and strengthen overburdened healthcare systems. I am proud to say that ENVI Members played a central role in improving the EU response to the pandemic, including the development and procurement of safe, efficient vaccines. Through resolutions, debates, and hearings, including with CEOs of pharmaceutical companies, we kept the political pressure high while ensuring democratic control and transparency. The pandemic also created a window of opportunity for more ambitious EU legislation on health, under the European Health Union umbrella, to increase EU's preparedness and ability to respond in case of future public health crises

This included extending the mandates of the European Centre for Disease Prevention and Control (ECDC) and the European Medicines Agency (EMA), so that they are better equipped to protect EU citizens, including through epidemiological surveillance, capacity to mobilise and deploy an EU Health Task Force or by facilitating faster approval of medicines that could treat or prevent a disease causing a public health crisis. Finally, the regulation on serious cross-border threats to health paved the way for joint procurement of medicines and established an early warning system and a mechanism for recognition of emergencies at the Union level. Parliament welcomed the establishment of the Health Emergency Preparedness and Response Authority (HERA) while criticising the decision not to establish it as a fully-fledged independent agency, with a more ambitious mandate and subject to the same rigorous scrutiny as other EU agencies. A review of the structure and governance of HERA should take place by 2025, so the discussion will continue during the next parliamentary term.

Recently, together with the LIBE committee, ENVI closed the deal on the European Health Data Space that will make exchange and access to health data easier at EU level. The efforts to complete the building blocks of the European Health Union will continue in the new legislative term, as Parliament has established its position on the 'Pharma package' - a crucial set of proposals to ensure availability and affordability of supply of medicines in Europe and inter-institutional negotiations will begin as soon as Council is ready to negotiate.

ENVI has not forgotten that important part of its mission is to protect citizens' health and the environment against pollution. The Industrial Emission's Directive has been strengthened to reduce air, water and soil pollution from industrial and certain agricultural activities while incentivising operators to invest in clean, resource-efficient technologies. Also, the work to improve air quality, urban wastewater treatment and the quality of drinking water has been concluded, while the Parliament's position is established on the law to reduce pollution from microplastics.

Despite the crises, ENVI has also kept nature high on the political agenda. From a 2021 resolution responding to the Commission's EU Biodiversity Strategy for 2030 to the Nature Restoration Law setting out legally binding targets to restore at least 20% of the EU's land and sea areas by 2030 and all ecosystems in need of restoration by 2050, ENVI Members worked to ensure that nature protection is not limited to Natura 2000 areas and that all sectors that impact nature, such as agriculture, forestry or fisheries, contribute to protection

efforts. Following the political agreement in the inter-institutional negotiations, the European Parliament closed its first reading position. Now, all eyes are on the Council to keep their end of the deal and adopt this crucial law.

Since EU consumption impacts biodiversity also outside its borders, ENVI initiated new rules obliging companies to ensure that products sold in the EU have not led to deforestation and forest degradation in other parts of the world. This is an example where the added value of European Parliament's action is particularly visible – the Commission's proposal was put forward in response to ENVI's own-initiative legislative report that noted the limited effectiveness of voluntary schemes in addressing the issue and called on the Commission to come up with an EU legal framework instead.

Last but not least, ENVI also played an active role in policy making on the international stage. ENVI Members took part on in UNFCCC Climate COP meetings, in the Convention on Biological Diversity COP 15 in Montreal in December 2022, where the ground-breaking agreement to set binding goals to halt and reverse biodiversity loss was reached, and in meetings of the Marine Environment Protection Committee of the International Maritime Organisation. Those are just examples of events where the Parliament political message was passed through resolutions, while ENVI Members were present at the conferences, to also convey it on the ground and support the EU delegation. Furthermore, as part of its legislative powers under consent procedure, at its last meeting before elections, ENVI recommended that the EP approves the conclusion BBNJ Agreement, which, under UN's Convention on the Law of the Sea, will protect marine biodiversity in areas beyond national jurisdiction.

These are just a few examples of the work done by ENVI in the last five years. With 88 Members, a very high number of reports and opinions adopted related to the environment, climate, public health, and food safety, it was the largest and one of the busiest legislative committees in the Parliament during this parliamentary term. It is worth underlining that, besides dealing with legislative and non-legislative reports and opinions, ENVI Members closely watched how the Commission implements existing legislation, when exercising its power of scrutiny of delegated and implementing acts. Notably, they submitted more than a hundred objections to delegated and implementing acts, out of which, many were adopted in ENVI and passed on to the plenary.

I invite you to read this activity report to get more details about all that was accomplished, thanks to passion and dedication of ENVI Members. I use this opportunity to also thank all the staff, including the ENVI Secretariat, political group advisors and also accredited parliamentary assistants, we could not have succeeded without your hard work and support. It was an honour and privilege to chair the work of the ENVI committee during this time.

  - (b) air, soil and water pollution, waste management and recycling, dangerous substances and preparations, noise levels and the protection of biodiversity,
  - (c) sustainable development,
  - (d) international and regional measures and agreements aimed at protecting the environment,
  - (e) restoration of environmental damage,
  - (f) civil protection,
  - (g) the European Environment Agency,
  - (h) the European Chemicals Agency;
2. public health, in particular:
  - (a) programmes and specific actions in the field of public health, ANNEX VI - 162
  - (b) pharmaceutical and cosmetic products,
  - (c) health aspects of bioterrorism,
  - (d) the European Medicines Agency and the European Centre for Disease Prevention and Control;
3. food safety issues, including in particular:
  - (a) the labelling and safety of foodstuffs,
  - (b) veterinary legislation concerning protection against risks to human health; public health checks on foodstuffs and food production systems,
  - (c) the European Food Safety Authority and the European Food and Veterinary Office.

In the context of point 2, a subcommittee on public health (SANT) was set up by the European Parliament decision of 14 February 2023<sup>2</sup>, which provides also that the Committee on the Environment, Public Health and Food Safety “remains responsible for the examination of legislative proposals, and votes shall take place therein”.

## Files of the ENVI Committee

### Introduction



This activity report covers the period from the first plenary session 2 July 2019 till the completion of the last plenary session of 22-25 April 2024 (9<sup>th</sup> parliamentary term).

In this period, the ENVI Committee was the biggest parliamentary committee of the European Parliament. It began the legislative term with 76 full Members and rose to 81 following UK's withdrawal from the EU on 31 January 2020, while on 20 January 2022 it further increased to 88 Members. On 14 February 2023, the European Parliament approved the creation of a subcommittee on public health, consisting of 30 full Members and dealing with non-legislative matters.

The ENVI Committee was responsible for a large number of legislative and non-legislative files, including 82 files under ordinary legislative procedure and 25 files under a special procedure. Sixty-six of those files were successfully concluded (1<sup>st</sup> reading closed by the European Parliament and the Council), while on 10 files, a plenary first reading took place, in view of inter-institutional negotiations during the next parliamentary term. ENVI also contributed to reports of other committees, adopting 214 mostly legislative opinions on matters related to its competences, monitored the implementation of the Union's budget. ## Budget and Discharge

Each year, Parliament examines the execution of the budget and gives discharge to the Commission and to all the other institutions, bodies and agencies. The aim of this form of budgetary control is to ensure that the EU's budget operations are legal and regular, and that the budget is managed in a sound financial way according to the principles of economy, efficiency and effectiveness.

The discharge cycle starts with the European Court of Auditors' (ECA) annual report on the implementation of the budget for the previous year. The Committee on Budgetary Control, taking account of opinions from relevant Committees, adopts reports containing a political evaluation of the implementation and recommendations aimed at improving financial management by the institution or agency concerned. A majority vote in plenary is needed to grant discharge. Parliament may also choose to postpone discharge when it is dissatisfied with aspects of the budget's management or can even refuse to grant discharge. The Commission and the other institutions are required to act on the observations made by Parliament in its discharge resolutions. Parliament follows up on their responses.

ENVI provides annual opinions on the general budget and on the discharge relating to the implementation of the budget of the European Commission and the Agencies under ENVI's remit, i.e. the European Environment Agency, the European Medicines Agency, the European Food Safety Authority, the European Centre for Disease Prevention and Control and the European Chemicals Agency. The ENVI Chair serves as rapporteur for all opinions on budget and discharge.

### **Questions with resolutions to the EC and to the Council**

The Committee can put a question to the Council or to the Commission, accompanied with a request that they be placed on the agenda of Parliament. A debate on one or more oral questions is usually accompanied by a resolution. Such resolution and oral questions are prepared in order to set the Parliament's position ahead of an important international event, such as UN COP meeting, or as a reaction ahead or after the Commission presents a legislative proposal or a Communication.

The ENVI committee's usual practice is that after the coordinators approve a request coming from one or more the political groups, each political group appoints a co-sponsor. The ENVI secretariat then prepares a draft resolution and oral questions and leads the negotiations with political groups in preparations for the final resolution.

## Proposals treated as urgent according to Rule 163 of the Rules of Procedure

In line with Rule 163, a request that a debate on a proposal submitted to Parliament be treated as urgent may be made to Parliament by the President, a committee, a political group, Members reaching at least the low threshold, the Commission or the Council. In spite of the fact that there is no committee report under the urgency procedure, technical briefings and political discussions often take place at committee or coordinators level.

During the 9<sup>th</sup> parliamentary term, the COVID-19 outbreak as well as the withdrawal of the United Kingdom (from the European Union (Brexit) created a number of situations, where the entry into force of certain Regulations falling under the remit of the ENVI committee became especially urgent. Other requests for urgencies were linked to deadlines laid down in EU legislation on certain medical devices, including in vitro medical devices.

## RPS Measures, delegated and implementing acts

The ENVI Committee scrutinises a high number of delegated acts, measures under the regulatory procedure with scrutiny (RPS measures) and implementing acts, adopted on the basis of legal acts under ENVI remit

All delegated acts, RPS measures and implementing acts within the areas of ENVI responsibility are circulated to Committee Members for their review by way of regular newsletters prepared by the ENVI Secretariat. The Secretariat sends four newsletters per week to all Committee Members, two containing information on delegated acts and draft RPS measures and two containing information on implementing acts. In the 9<sup>th</sup> legislative term, almost 800 ENVI newsletters were sent out, containing around 8 000 documents. In addition to these newsletters, the secretariat also circulated more than 400 "Right of Information Newsletters", with related documents, such as minutes from expert/comitology meetings, summary reports, agendas, etc.

In accordance with the Rules of Procedure, Members can decide whether to object to the circulated delegated acts, draft RPS measures and implementing acts. The objections are presented in the form of a draft Motion for a Resolution, which is then put to vote in ENVI committee. Before voting on an objection, the ENVI Committee normally holds an exchange of views with the Commission to foster a comprehensive discussion and understanding of the issues at stake. The secretariat sometimes also organises technical briefings for interested staff, especially with regard to draft RPS measures and delegated acts at a preparatory phase.

During the 9<sup>th</sup> parliamentary term, the ENVI Committee has been the responsible Committee for scrutinising:

- 317 draft RPS measures (around 90% of all RPS measures received in the Parliament)
- 261 delegated acts (around 25% of all delegated acts received in the Parliament)
- approximately 4100 implementing acts (around 50% of all implementing acts received in the Parliament).

The Parliament has a formal right to object to both delegated acts and draft RPS measures (by absolute majority in plenary). Out of the 578 procedures above, ENVI received 39 objections during the 9<sup>th</sup> parliamentary term. Out of these 39 objections, 20 were adopted in committee and submitted to the plenary for a final decision<sup>5</sup>. Several of these objections – 11 on draft RPS measures and 4 on delegated acts – obtained a majority in the plenary and the proposed acts were thus formally rejected by Parliament.

During the 9<sup>th</sup> parliamentary term, the ENVI committee also dealt with 75 objections to implementing acts. Out of these 75 objections, 55 were adopted in committee and submitted to plenary, where 53 were eventually adopted. Following an objection to an implementing act by Parliament, the Commission has the obligation to review the

act, taking account of the positions expressed, and to inform the Parliament whether it intends to maintain, amend or withdraw the draft implementing act.

After Regulation (EU) 2020/852 (the “Taxonomy Regulation”) entered into force on 12 July 2020, the joint ECON-ENVI committee dealt with 5 objections to delegated acts under that regulation, of which two were adopted in joint committee. None of these objections were however adopted in plenary.

## Petitions

Any citizen of the European Union, or resident in a Member State, may, individually or in association with others, submit a petition to the European Parliament on a subject which comes within the European Union’s fields of activity and which affects them directly. When a petition falls into the remit of ENVI competencies, the Petitions Committee (PETI) transfers it to ENVI for information or for opinion. During this parliamentary term, ENVI received 495 petitions for information and 67 petitions for opinion. In the latter case, the ENVI coordinators examine the petition and reply to PETI on any follow-up they deem appropriate.

## Agencies

The ENVI Committee is in charge of relations with five EU agencies, which were set up by legislative acts falling under the legislative competences of the ENVI Committee. These are the European Chemicals Agency (ECHA), the European Food Safety Authority (EFSA), the European Medicines Agency (EMA), the European Environment Agency (EEA) and the European Centre for Disease Prevention and Control (ECDC).

At the start of the parliamentary term, the Coordinators appoint an MEP as a contact person for each agency, who – together with the Chair and Coordinators – is responsible for the Committee's interaction with that agency. The Coordinators and contact persons are also involved in the appointment of Directors and Executive Directors to the agencies and in the nomination of EP representatives for the management boards, and certain other bodies<sup>6</sup>, of those agencies.

There are regular exchanges between the Committee and the agencies including an annual presentation in the Committee by the (Executive) Directors on the agencies' work programmes and priorities and exchanges of views with agency representatives on specific topics.

The contact person and other committee members pay visits to each agency normally every 2.5 years (due to the Covid-19 pandemic, less visits took place during the 9<sup>th</sup> parliamentary term). The agency may also have contacts with individual rapporteurs on legislation within their areas of responsibility.

### The European Environment Agency (EEA)<sup>7</sup>

EEA, located in Copenhagen, supports sustainable development and helps to achieve the aims of environmental protection and improvement laid down by the Treaty and by successive Community action programmes on the environment. To this end, it provides the Union and Member States with technical and scientific support and with objective, reliable and comparable information enabling them to take the requisite measures to protect the environment, to assess the results of such measures and to ensure that the public is properly informed about the state of the environment.

### The European Chemicals Agency (ECHA)<sup>8</sup>

ECHA, located in Helsinki, aims to protect health and the environment by ensuring chemical safety through science, collaboration and knowledge. It contributes to the implementation of the common chemicals policy by providing opinions to the European Commission on the scientific and technical aspects of hazard assessment, risk assessment, risk management and the societal and economic consequences of risk management decisions. In order to ensure

consistency at EU level, ECHA manages and in some cases carries out the technical, scientific and administrative aspects of chemical legislation, i.e. Regulations on the registration, evaluation, authorisation and restriction of chemicals (REACH), on classification, labelling and packaging (CLP), on biocidal products (BPR), on prior informed consent for the export and import of hazardous chemicals (PIC), on persistent organic pollutants (POPs), performs specific tasks under the Waste

Framework and Drinking Water Directives, and provides scientific opinions on Occupational Exposure Limits.

## The European Medicines Agency (EMA)<sup>9</sup>

EMA, located in Amsterdam, is responsible for the scientific evaluation and supervision of new medicines for human and veterinary use. It does this by bringing together expertise from national medicines agencies, hospitals and academia and involves patients and healthcare professionals in its work. EMA's scientific committees provide independent scientific evaluation of applications for European marketing authorisations for both human and veterinary medicines, which form the basis for the approval or rejection of the application by the Commission. Moreover, EMA monitors the safety of medicines across their lifecycle and facilitates development and access to medicines through various activities.

### **Health and Food Audits and Analysis Directorate**

The Health and Food Audits and Analysis Directorate of DG SANTE (which was formerly the Food and Veterinary Office, FVO) is located in Grance and carries out audits to ensure that the national authorities in EU countries and non-EU countries exporting to the EU are fulfilling their legal obligations, i.e. that they properly implement and enforce EU legislation on food safety, animal health, animal welfare, plant health and some areas of human health. In general, these audits focus on control systems rather than individual premises, but other controls such as fact-finding studies are also carried out.

Despite a fact that it is not an agency, ENVI appoints an MEP as a contact person and may hold exchanges of views on relevant issues with representatives of the Directorate.

## European Court of Auditors

The European Court of Auditors (ECA) is an independent institution that audits the accounts of the EU's income and expenditure. It examines revenue and spending in every area of the EU's work and issues annual reports of financial audit on the EU budget and EU agencies, as well as special reports on performance and compliance audits of various specific policy areas. Its work is particularly important to the European Parliament, especially the CONT committee who is in charge of the discharge procedure, when deciding whether the EU's accounts for the previous year are accurate and the funds are properly spent.

The ENVI Committee, in close cooperation with the CONT committee, regularly invites Members of the European Court of Auditors (ECA) for an exchange of views, following the publication of ECA reports on relevant topics. The ENVI Committee also provides suggestions for audits in its areas of responsibility for the annual work programme of ECA.

## Other EU bodies

The Commission's Health Emergency Preparedness and Response (HERA) authority was set up in September 2021, in the aftermath of the COVID-19 pandemic to strengthen the EU's health emergency preparedness and response to cross-border health emergencies. HERA builds the necessary capacities to respond to health crises by addressing gaps in the EU's preparedness and, in case of a health crisis, coordinates the development, manufacturing, and procurement and distribution of critical medicines, vaccines, and other medical countermeasures such as gloves and masks. During an emergency phase, the Health Crisis Board chaired by the President of the European Commission will coordinate action by the Commission, the relevant Union agencies and bodies, and Member States to ensure the supply of and access to medical countermeasures.

Despite repeated EP calls for a stand-alone agency to perform such important tasks, HERA was established as a Commission service. The Parliament strived to guarantee the necessary coherence between HERA and the purposes to which it was created by ensuring that Regulation (EU) 2022/2371 on Serious Cross-Border Threats to Health included a review clause on the work of HERA and an assessment of the need to establish HERA as a distinct entity by 2024 at the latest. A Communication from the Commission to the European Parliament and the Council on the review of HERA is expected by the second quarter of 2024.

### **European Scientific Advisory Board on Climate Change (ESABCC)**

The European Scientific Advisory Board on Climate Change (ESABCC) is an independent body, providing the European Union (EU) with scientific knowledge, expertise and advice relating to climate change. The Advisory Board evaluates policies and identifies actions and opportunities to successfully achieve the EU's climate targets. It was established, at the initiative of the European Parliament, in 2021 by the European Climate Law and consists of 15 independent senior scientific experts.

## Working groups – Health Working Group

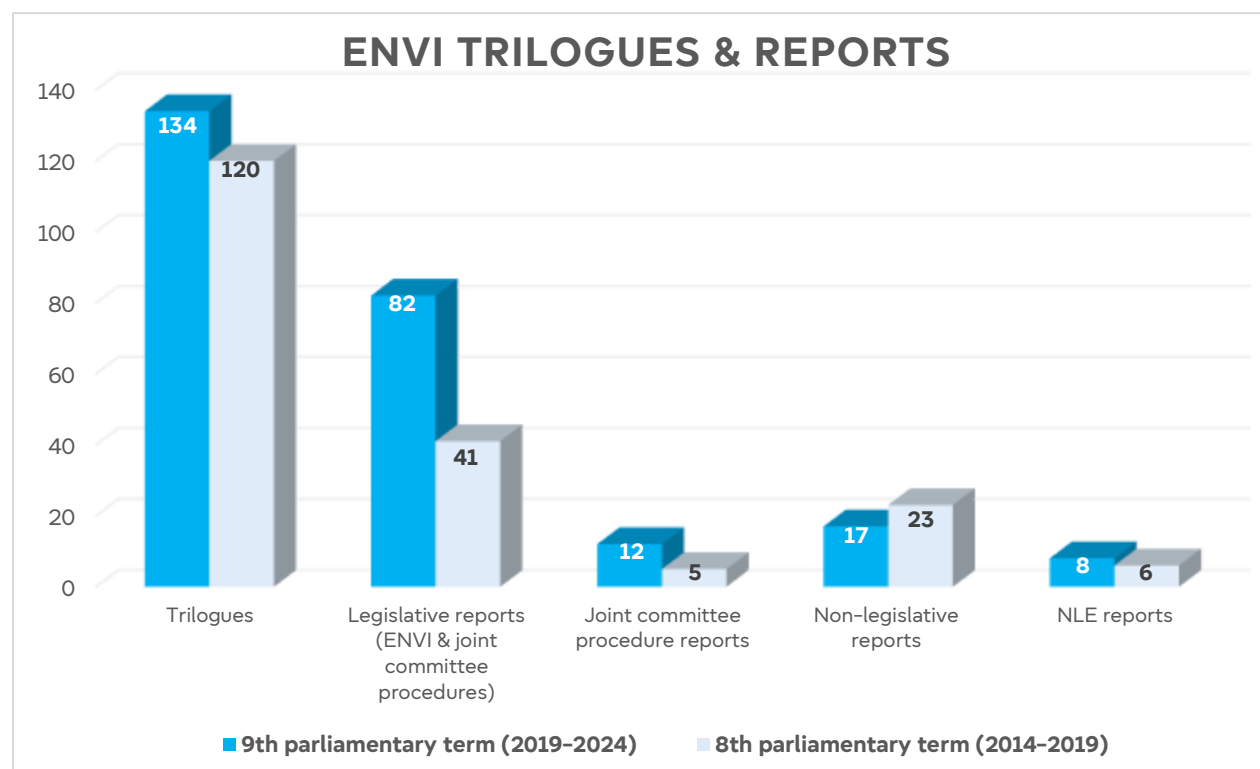
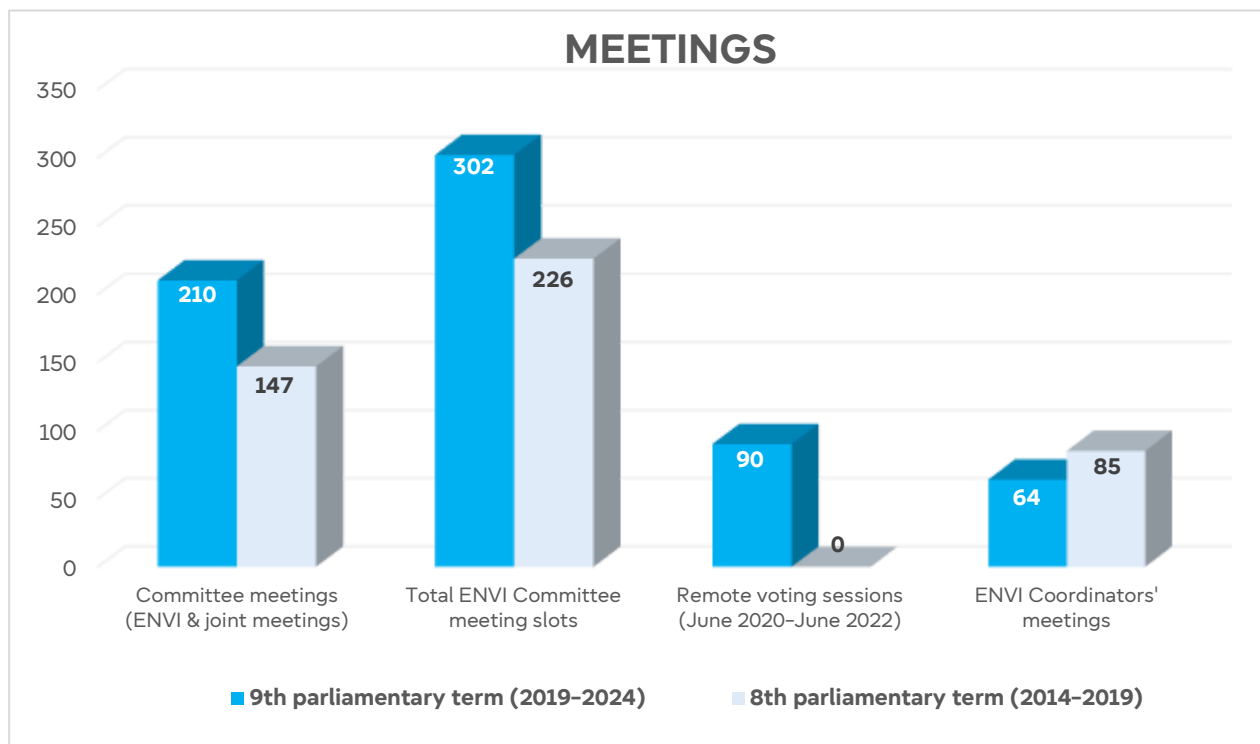

#### Comparison of the 9<sup>th</sup> and the 8<sup>th</sup> parliamentary terms

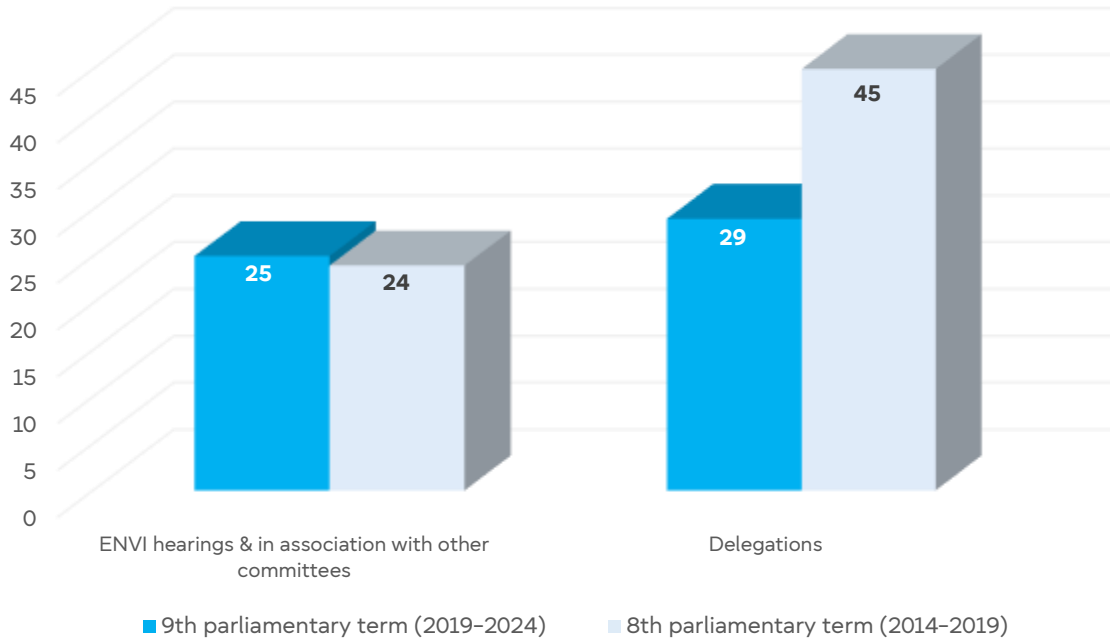
