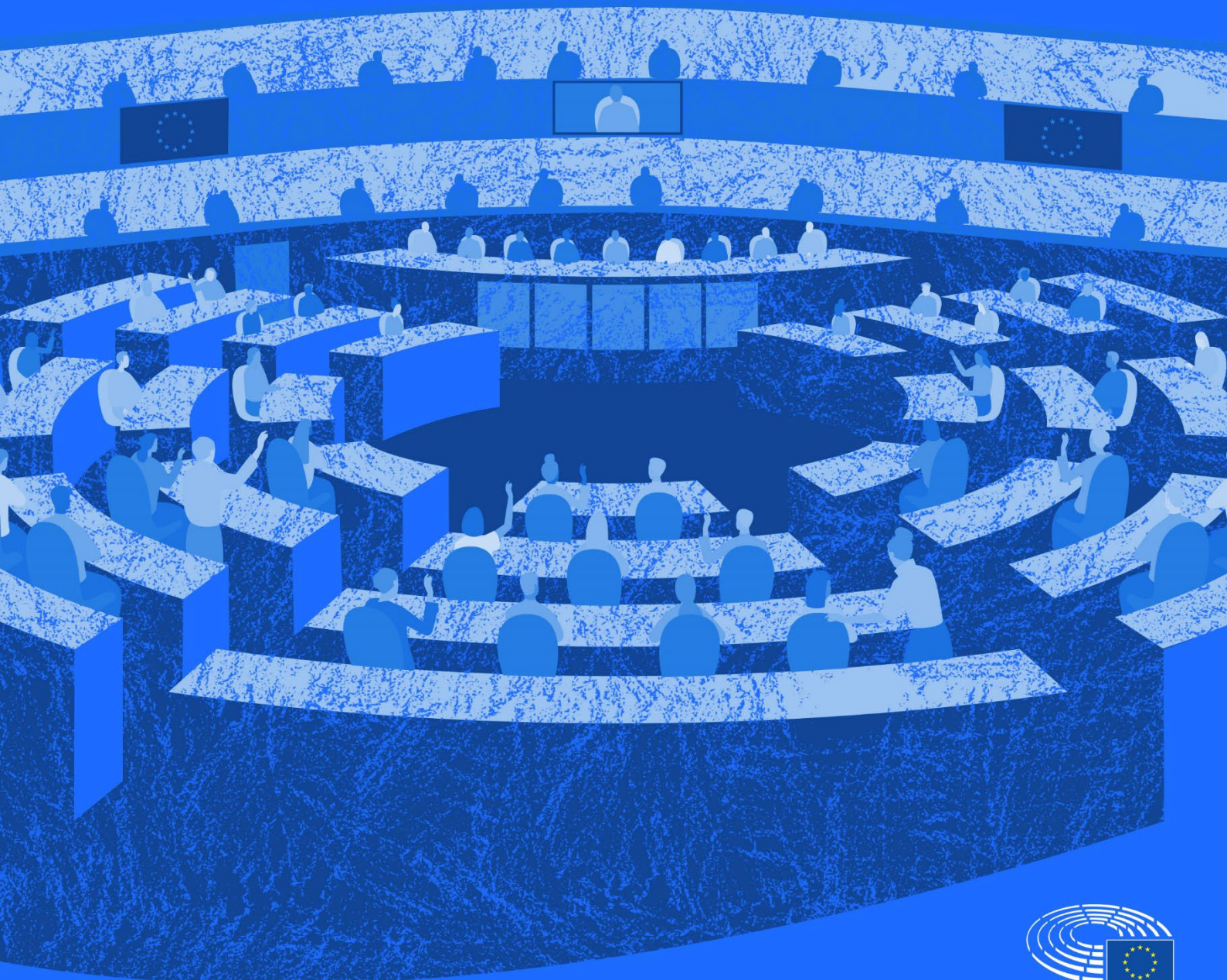

The work of the Subcommittee on Human Rights (DROI) during the 9th parliamentary term: summary of activities

The Subcommittee's role and means of action

Throughout the 2019–2024 legislative term, the Subcommittee on Human Rights (DROI), in line with its mandate as set out under Parliament's Rules of Procedure, acted to ensure alignment between the EU's external policies and its human rights policy. Tasks carried out by DROI include:

- Monitoring respect for human rights in EU external policies;
- Scrutinising the implementation of EU human rights policy, its impact and its contribution to promoting respect for human rights, the rule of law and democracy in partner countries;
- Fostering parliamentary diplomacy with a broad range of interlocutors, such as UN counterparts, representatives of regional human rights organisations, national human rights institutions, and international, regional and local civil society organisations;
- Mainstreaming a more consistent human rights agenda, e.g. across parliamentary committees and delegations.

1 - Monitoring respect for human rights in EU external policies

DROI has taken a number of initiatives, including through exchanges of views, public hearings, studies, reports and specific events, to assess, strengthen and ultimately expand the EU's human rights toolbox for the promotion and protection of human rights and democracy around the world. DROI places special emphasis on building connections between EU institutions and international and regional human rights stakeholders to discuss and introduce new frameworks or ad hoc mechanisms for places where legal gaps remain in order to tackle war crimes, transitional justice and accountability. It has shed light on the critical consequences that global crises (the pandemic, wars, etc.) have had on human rights and has recommended related priority actions to be taken as part of the EU's foreign policy.

- After advocating and making proposals to strengthen EU instruments aimed at sanctioning individuals and entities responsible for human rights abuses, DROI strongly supported the establishment of the [EU Global Human Rights Sanctions](#)

[Regime](#) (EU Magnitsky Act) in December 2020. In a [recommendation](#) to the Council and the Vice-President of the Commission / High Representative of the Union for Foreign Affairs and Security Policy (VP/HR), DROI further requested that the scope of the current EU Global Human Rights Sanctions Regime be expanded to include acts of corruption or that, alternatively, the Council and the VP/HR come forward with a legislative proposal to adopt a new thematic sanctions regime for serious acts of corruption. The recommendation underlined the need to further integrate a human rights-based anti-corruption approach into EU external action instruments, including the Neighbourhood, Development and International Cooperation Instrument – Global Europe (NDICI), the Instrument for Pre-Accession Assistance and EU trust funds. Members proposed that the European Parliament should be able to address cases of serious human rights violations, and recommended the introduction of qualified majority voting for the adoption of sanctions, while insisting on a swift and coordinated EU response to retaliatory sanctions by non-EU countries.

- In the aftermath of the presidential elections in Belarus and the crackdown on members of civil society and protesters, DROI was active in launching the **European Parliament Platform for the fight against impunity in Belarus** (26 March 2021), in collaboration with international and regional experts from the Organization for Security and Co-operation in Europe (OSCE), the Council of Europe and the Office of the UN High Commissioner for Human Rights (OHCHR), as well as UN special rapporteurs and key figures from the Commission and the European External Action Service (EEAS) working on documenting human rights violations. Several meetings of the Platform took place with a focus on the situation of the media and journalists (12 July 2021) and on justice and accountability (30 November 2021).
- A few weeks after the start of Russia's aggression against Ukraine in February 2022, DROI took action aimed at ensuring full accountability for international crimes committed in Ukraine, including child and civilian abductions and other war crimes and crimes against humanity. In the absence of International Criminal Court (ICC) jurisdiction over the crime of aggression perpetrated on the territory of Ukraine, DROI explored different avenues to ensure **accountability for the crime of aggression** against Ukraine. Members discussed the jurisdiction of the crime of aggression with international lawyers, experts, academics and UN diplomats. They assessed the existing international mechanisms for prosecuting the crime of aggression (12 July 2022) and the feasibility of establishing a dedicated international criminal tribunal to ensure that senior Russian officials, including at the highest level, would be brought to justice and held accountable (28 March 2022). These initial discussions were further developed with the presentation of the in-depth analysis entitled 'International Tribunal for Russia's Crime of Aggression against Ukraine - a Legal Assessment' (28 November 2022). The outcome of DROI's work was then reflected in the

[European Parliament resolution](#) calling for the establishment of a tribunal on the crime of aggression against Ukraine (19 January 2023). DROI members followed up on the establishment of such jurisdiction during their visit to Ukraine on 22–23 October 2023 and they continued discussions with international lawyers and experts that touched on lifting immunity for high-level officials and the possibility of proceeding *in absentia* (14 February 2024).

- DROI closely followed the situation of Russian citizens who refused to fight or get involved in Russia’s war of aggression against Ukraine, paving the way for a [resolution](#), adopted on 16 February 2023, in which Parliament demanded that the EU Member States protect and grant **asylum** to Russians and Belarusians being persecuted for speaking out or protesting against the war, as well as to Russian and Belarusian conscientious objectors and deserters.
- In the same vein, DROI placed special attention on how to safeguard those protecting fundamental freedoms in their countries, such as human rights defenders (HRDs). Parliament’s [resolution](#) on the EU Guidelines on HRDs specifically emphasised that visas and shelter were key protection tools. DROI followed-up on the resolution by commissioning a [study](#) that was published in January 2024 entitled ‘Enhancing the protection of human rights defenders (HRDs): Facilitating access to the EU and supporting HRDs from third countries’. DROI hosted discussion on this study during a committee meeting in which the Commission and the EEAS had the opportunity to inform Members about the ongoing preparation for the revision of the **Visa Code Handbook**.
- The outbreak of the COVID-19 pandemic disproportionately affected certain communities and vulnerable groups, including migrants, children and minorities. An increase in hate speech, racism and ethno-nationalism was observed and the crisis provided a pretext for authoritarian regimes to adopt repressive measures for purposes unrelated to the pandemic. In their attempts to contain the COVID-19 pandemic, many governments around the world imposed limitations on freedom of movement and other related freedoms within their territories, thereby severely curtailing certain fundamental rights. Some regimes abused the situation in order to consolidate authoritarian rule or disproportionately restrict the regular functioning of the rule of law and institutions. DROI addressed the impacts that management of the pandemic had on human rights. On several occasions, Members were briefed by experts from UN agencies (e.g. UNICEF, the Human Rights Council, OHCHR and the World Health Organization), representatives of the European Court of Human Rights and non-governmental organisations (NGOs) on the risk that large-scale temporary coercion measures valid for the duration of the lockdowns could be made permanent in some democracies. DROI members discussed the sanitary conditions in prisons and detention centres (11 May 2020) and [supported](#) the recommendations issued by the UN High Commissioner on Human Rights. Members also debated censorship

related to combating fake news and the use of digital surveillance tools meant not only to monitor infection risks, but also to watch citizens' political behaviour (7 July 2020). In addition, school closures severely affected children's rights to education, good nutrition (daily meals), healthcare (primary vaccinations) and mental health and well-being. Dropping out of school exposed children to violence, criminal networks, exploitation and forced labour. As part of its political priorities for the ninth legislative term, DROI prepared an own-initiative report to address the pandemic's multiple impacts on [children's education](#) as a foreign policy issue. Members requested that the Commission, the Council and the EEAS establish an EU strategy to mitigate the adverse effects of the pandemic on the rights of the child. This request was also a follow-up to the [High-Level Conference](#) organised at the initiative of DROI, jointly with the Committee on Civil Liberties, Justice and Home Affairs, in November 2019 to celebrate the 30th Anniversary of the Convention on the Rights of the Child.

- **Persecution and discrimination against minorities** on the grounds of belief or religion have been on the rise for the past decade. DROI members expressed concerns about the high levels of coercion, discrimination, harassment, violence and repression suffered by people belonging to religious or belief minorities. This global phenomenon affects many religious communities, including Buddhists, Christians, Hindus, Muslims and Jews, as well as groups of people who are atheists, humanists, agnostics or who do not identify with any belief or religion. The COVID-19 pandemic further exacerbated this trend (through smear campaigns, online hate speech, limited access to food and medical aid, digital tools for mass surveillance, etc.). DROI addressed the situation and prepared an [own-initiative report](#) that put forward a number of recommendations on mobilising EU foreign policy tools, including applying sanctions against persons and entities, making full use of human rights dialogues with partner countries, ensuring adequate funding for issues related to the protection of persons belonging to religious minorities or beliefs under the NDICI's thematic programme on human rights, and strengthening the EU's multilateral commitment on promoting respect for religious and belief minorities.
- In 2020, DROI started organising official side events to the annual **Brussels conference on supporting the future of Syria and the region**. The conference constitutes the main global gathering and fundraising event related to the conflict in Syria and its humanitarian and political impacts. The main purpose of DROI's side events to the conference was to address the human rights situation in Syria, with a view to setting out a road map for accountability, justice and long-term solutions. While acknowledging the complexity of the matter, the various discussions held aimed to come up with recommendations for way to uphold the EU's commitment to consistently include human rights protection in its external actions. Specifically, DROI focused its work on the children in the Al Howl camp (26 June 2020), on fighting impunity to protect victims whose human

rights were violated (23 March 2021) and on missing persons (23 May 2023). DROI's work on Syria also touched on culture and the arts. On 16 March 2022, an exchange of view was organised on the fight against impunity in Syria, 11 years after the uprising. The event included a screening of an extract of the film *Little Palestine*, in the presence of the director Abdallah Al Khatib and producer Mohammad Ali Atassi.

- In February 2022, a series of events was organised for **Afghan Women Days** to pay tribute to the group of prominent Afghan women nominated as Sakharov Prize finalists in 2021. In an effort to keep Afghan women's situation as a high priority on the EU and international agendas, the events (conference, media talks, youth seminars, artistic performances and exhibitions) focused on the dire situation of women and girls in Afghanistan after the Taliban takeover in September 2021 and their loss of rights and status within Afghan society. The Afghan Women Days tackled different aspects, including the ongoing humanitarian crisis, the Taliban's repressive rule against women and girls and the severe violations of their fundamental rights. Discussions also covered the challenges of rebuilding a new life in exile for those who managed to leave Afghanistan. Presentations from the Afghan University in Exile and representatives from the project for Afghan students run by the Global Campus of Human Rights displayed innovative opportunities for Afghan women to maintain hope and pursue their educations.
- In April 2023, against the backdrop of ongoing oppression in Tehran, the Democracy Support and Election Coordination Group (DEG) and DROI organised **European Parliament Solidarity Days for the people of Iran**, which allowed a broad spectrum of Iranian civil society representatives to make their voices heard and to reflect jointly on the future of their country. The meeting was organised in camera to allow for an open exchange and focused on challenges and prospects for Iran's democratic movement. One of the main ideas put forward was for the EU to massively support access to the internet in Iran, including through new virtual private network (VPN) technology that Iranian civil society could use.
- In March 2023, DROI and DEG organised an artistic performance and fashion show, marking the start of Parliament's work on banning products made by forced labour. The show led the audience on an imaginary journey starting with forced labour workers' traumatic experiences and ending with the glittering world of fashion, which stands on a foundation built with forced labour products. Imagination turned into reality with the presence of a forced labour survivor from Nepal and a Uyghur survivor of a concentration camp in China, who shared their testimonies with the public. In the presence of members from various committees (Committees on Internal Market and Consumer Protection, on Trade, on Transportation and on Development, as well as DROI), they also made

progress on preparing the new legislative ban on forced labour that was then agreed on in April 2024.

- DROI and the Global Campus of Human Rights decided to join efforts to address human rights challenges and shape future approaches that could enable the EU to strengthen its human rights-related external action, in close cooperation with international human rights organisations and like-minded partners. Against this background, the [Annual Venice Conference on the Global State of Human Rights](#) was launched in July 2021 and a second edition was organised the following year. These events gathered representatives from international organisations, national human rights bodies and civil society organisations, as well as HRDs, young people, academics from the Global Campus network and high-level officials from the EU institutions. The conferences offered an opportunity to highlight human rights priorities, such as due diligence, global accountability and children's rights, as well as the opportunity to assess the EU's response, through its external and internal policies, to human rights violations during the pandemic. It also helped to further raise the profile of the European Parliament and the EU more broadly in terms of their human rights engagement on the international and regional stage.

2 – Scrutinising the implementation of the EU's human rights policy, its impact and its contribution to promoting respect for human rights, the rule of law and democracy in partner countries; the EU's financial instruments and urgency resolutions

The EU's commitment to advancing human rights and democracy and the need for strong, consistent, effective and collective action in this field lie at the core of DROI's activities. To advance these goals, DROI pursues its scrutiny activities using a wide range of **means**.

An important scrutiny tool is DROI's strategic annual report on human rights and democracy in the world and the EU's policy on the matter, including the implementation of the EU action plan on human rights and democracy. This report allows DROI members to examine and analyse the EU's performance in the field of human rights and to put forward a number of concerns and recommendations. Ahead of the plenary vote, the draft resolution is debated with the VP/HR. The five annual reports adopted in the ninth legislative term tracked a number of alarming global trends, many of which were further exacerbated by the COVID-19 pandemic and the outbreak of war in the EU's immediate neighbourhood.

- In [2020](#), Members denounced the continuing pushback against multilateralism and the rule-based international order, which continued to pose a serious challenge to human rights around the globe. They condemned the misuse of legitimate purposes, such as counter-terrorism, state security and law enforcement, to limit freedom of expression both online and offline.

Furthermore, in this first annual report of the term, Members prepared the ground for a comprehensive Parliament position on business and human rights. They reaffirmed that the activities of all companies, whether operating domestically or across borders, must be fully compliant with international human rights standards. They also called for the EU to adopt a strategy on new technologies, such as artificial intelligence, and to respond to the threats these technologies could pose to human rights, including through the spread of fake news and hate speech, as well as an increased use of mass surveillance.

- In [2021](#), Members highlighted the negative impact of the coronavirus pandemic on democracy, the rule of law and space for civil society organisations and HRDs. They asked the EU to develop a comprehensive strategy at multilateral level to counter the increasing withdrawal of states from international human rights frameworks. DROI members also elaborated on how to strengthen the EU's foreign policy toolbox. They called for human rights clauses to be systematically included in all international agreements, in particular trade and association agreements between the EU and non-EU countries. They stressed the importance of providing adequate budgetary and other support for activities and the promotion and protection of democracy and human rights under the NDICI. They requested the introduction of qualified majority voting in the Council, notably when it comes to human rights-related matters. They pushed for the urgent adoption and implementation of an autonomous, flexible and reactive global EU human rights sanctions mechanism, as an essential part of the EU'S existing human rights and foreign policy toolbox.
- In [2022](#), Members underlined the increasing number of illiberal democracies and autocratic regimes, which made up a majority of governments in the world for the first time in 20 years. Members called for the EU and the Member States to use the tools at their disposal, including their economic leverage in bilateral trade relations, to provide more ambitious support for freedom, good governance, the rule of law and democratic institutions. Members stressed that climate change was one of the greatest threats to the human rights of our generation and future generations. They encouraged the EU and the Member States to promote the recognition of ecocide as an international crime and asked the Commission to study the relevance of ecocide to EU law and diplomacy. Expressing serious concern about the precarious situation of HRDs, Members asked for the EU to start developing a strategy for ambitious EU action to address the rising number of attacks against HRDs. Such a strategy should include the establishment of an EU-wide scheme for the issuing of short-term visas for the temporary relocation of HRDs.
- In [2023](#), Members highlighted an alarming rise in the number of serious violations of international humanitarian law around the world and requested strong international and multilateral cooperation to fight the trend. They called for the EU to continue supporting the UN, both politically and financially, including all UN human rights bodies. They also called for the EU to assist the Prosecutor of the ICC in investigating and prosecuting alleged perpetrators of

international crimes under its jurisdiction. They underlined that the EU's action on the international scene must be guided by the support for democracy, human rights and the rule of law that inspired its own creation. To that end, Members urged the EU to make consistent use of clauses in trade agreements that protect human rights, including those related to closer monitoring and enforcement of human rights commitments. They also called for the link between the granting of preferential trade treatment and progress on human rights to be strengthened in the updated Regulation on the Generalised Scheme of Preferences (GSP+).

- In [2024](#), Members strongly condemned an increasing disregard for international human rights law and international humanitarian law, in particular in armed conflict zones. They denounced attacks on the universality of human rights and all attempts to neutralise human rights mechanisms and the ability to hold states accountable for human rights violations, atrocities and international crimes. They called for the EU to further develop its toolbox and act in unity when opposing the global democratic decline and regression in human rights around the world. They asked the EU and its Member States to continue working to strengthen democratic institutions and transparent and credible electoral processes worldwide, to fight against impunity, and to ensure an enabling environment for the work of civil society. Members also urged the EU and the Member States to develop a comprehensive strategy to counter increasing state withdrawal and pushback against the international human rights frameworks.
- Additionally, all the annual reports surveyed a broad range of issues, including the global rights situation of minorities, women (including sexual and reproductive health rights), indigenous persons, children, migrants and refugees, persons with disabilities and LGBTIQ+ people, as well as freedom of expression and the use of the death penalty worldwide. Furthermore, Members consistently condemned attacks on and harassment of HRDs, including journalists, and highlighted the need for a proactive, holistic and long-term approach towards their protection. Members recalled that respect for human rights, democracy and the rule of law was a cross-cutting objective under the NDICI, and highlighted the importance of improving ways to fund civil society actors. Moreover, they called on the Commission to strictly refrain from providing budget support to non-EU governments in countries with widespread human rights violations and repression of HRDs. They reiterated their call for greater transparency regarding human rights-related provisions in financing agreements with non-EU countries under the NDICI and for a clarification on the mechanisms and criteria for the suspension of such agreements. Members underlined Parliament's role in the NDICI's programming process in this regard.
- During this term, the EU Special Representative on Human Rights **Eamon Gilmore** regularly participated in DROI's exchanges of views and other events, by presenting his annual work-programme and priorities and reporting on country visits. He also debriefed the Members on a number of **human rights**

dialogues with partner countries (Saudi Arabia, the Philippines, etc.). The meetings were an opportunity to show DROI's support and give more visibility to the work of the EU Special Representative. Furthermore, several European Commissioners participated in DROI's activities. Commissioner **Helena Dalli** addressed the EU's effort to fight systemic discrimination and enhance social cohesion (22 September 2020). Commissioner **Didier Reynders** gave details on how a new piece of EU legislation on due diligence could make corporations and businesses more responsive to human rights violations (16 July 2021). Commissioner **Janez Lenarčič** briefed the Members on EU humanitarian aid to the Afghan people and assistance to neighbouring countries hosting refugees (24 March 2022). Commissioner **Dubravka Šuica** reiterated the Commission's commitment to support the collection of evidence on the forced deportation of Ukrainian children to Russia, with a view to holding all perpetrators accountable before a court of law (01 March 2023). Commissioner **Jutta Urpilainen** participated in the high-level conference on the 75th anniversary of the Universal Declaration of Human Rights. She underlined the EU's commitment to use the Global Gateway to build mutually beneficial partnerships through a values-based approach that leaves no one behind (29 November 2023).

- DROI was tasked with overseeing negotiations of the EU's international agreements with partner countries, which included **human rights-related clauses** and mechanisms. Moreover, DROI was committed to monitoring the enforcement of such clauses in existing agreements through interactive dialogues with the EU institutions, the European Ombudsman and civil society representatives (05 September 2022). The need to link the ratification and implementation of the EU's trade agreements to the human rights situation in partner countries was addressed on a regular basis in DROI meetings and missions. In particular, Members supported the inclusion of strong and binding human rights clauses in all the EU's agreements. These clauses should then be triggered in the event of any deterioration in the human rights situation in the partner country and could, in extreme cases, lead to the suspension of the trade agreement. DROI members prepared an [accompanying resolution](#) in the context of the consent procedure on the EU-Viet Nam Free Trade Agreement (2019). In addition, DROI commissioned a [study](#) on this issue (with case studies on Tunisia, Viet Nam and Ethiopia), which was presented during a workshop entitled 'Implementation mechanisms of the Human Rights Clause' (14 February 2024).
- DROI also established a **Working Group on the NDICI, with the purpose of** assessing the EEAS's and the Commission's implementation of the thematic programme related to human rights and democracy. The working group established a number of DROI priorities, in line with the recommendations made in DROI reports, relevant Parliament resolutions and the priorities laid out by the DROI coordinators. DROI was then able to outline its final priorities ahead of the completion by the EEAS and the Commission of the mid- and long-term

planning documents that translated priorities into concrete actions and activities to be financed. These priorities were also addressed during the high-level political dialogues on the NDICI in the presence of EU Commissioners.

- Under Rule 144, the European Parliament adopts up to three resolutions on breaches of human rights, democracy and the rule of law at each of its plenary sessions. These 'urgency resolutions' provide Parliament with an effective tool to react to international events and crises and to keep political attention focused on human rights concerns and/or specific HRDs' situations. Although they are prepared by the political groups, DROI organises a **dedicated question time** to ensure regular follow-up them, thus providing opportunities to enhance DROI's dialogue and engagement with the EEAS and the Commission. During the last term, DROI held at least 20 such question-time sessions to allow for follow-up on the implementation of urgency resolutions.

3 - Fostering parliamentary diplomacy with a broad range of interlocutors, such as UN counterparts, representatives of regional human rights organisations, international justice institutions, officials in partner countries, national human rights institutions, and international, regional and local civil society organisations, including academic communities

DROI's delegations to international institutions reflected central human rights concerns and strong support for multilateralism and a rule-based international order.

- The regular DROI delegations to the spring session of the UN Human Rights Council ([Geneva 2022](#) and [2023](#)), to the UN General Assembly ([New York 2019](#)) and to the UN Global Forum on refugees (Geneva 2019 and 2023) allowed Members to gain regular insight into EU priorities and action at multilateral level. DROI helped set an international agenda, by closely interacting with stakeholders within the UN Human Rights Council and by strengthening its dialogue with the [UN High Commissioner for Human Rights](#), currently Volker Türk, and the regional offices, including during DROI's official visits to non-EU countries. For instance, DROI coordinated activities related to a number of country situations. During DROI meetings or prior to its official visits, UN mandate-holders regularly presented the main findings of their investigations on a number of regional situations (Afghanistan, Belarus, China, Ethiopia, Iran, Nicaragua, Russia, Yemen, etc.) and the state of play on related human rights conditions (including for migrants and refugees, children and indigenous communities), providing valuable inputs for Parliament's lawmaking process. DROI promoted the legally binding international treaty on business and human rights, in particular on access to remedy and the protection of victims, with the adoption of a [resolution](#) in 2024. It prepared Parliament's positions on adopting

legislation integrating a comprehensive human rights-based approach to mitigate the adverse effects of climate change, on promoting responsible business conduct and on ensuring respect for groups at the highest risk of having their human rights violated. In March 2024, DROI launched the preparation for Parliament's ad hoc delegation to the UN Summit of the Future. It organised an exchange of views (19 March 2024) with the UN Assistant Secretary-General for Human Rights and with the Co-Chair of the Intergovernmental Negotiations on the reform of the Security Council on the Zero Draft of the Pact for the Future, which was submitted in January 2024 and which guided the negotiations leading up to the summit.

- Parliament has been a strong supporter of the ICC as a central linchpin of the global accountability system. In its [2022 resolution](#) on its annual report on human rights and democracy in the world, Parliament called for the EU and the Member States to provide adequate financial support to the ICC and called for the EU to include a specific ICC clause in trade agreements to be concluded with non-EU countries. DROI regularly addressed the necessity of accountability and universal jurisdiction. DROI organised numerous activities, such as exchanges of views, workshops and hearings on international criminal justice to demonstrate support for the ICC's role and its Prosecutor – Fatou Bensouda, during her tenure from 2012 to 2021, and Karim Khan, since his appointment in 2021. In this context, DROI had a very fruitful visit to the ICC in June 2022 with a delegation made up of DROI members and both Chairs of the Committees on Legal Affairs and on Civil Liberties, Justice and Home Affairs. [The visit to The Hague](#) came at a crucial moment. It followed the start of the term of the new Prosecutor, Karim Khan, the significant attention paid to the ICC's role in the investigation of international crimes committed in Ukraine, and shortly before the 20th anniversary of the adoption of the Rome Statute on 1 July 2002. The delegation addressed the challenges arising from the Ukraine investigation and the jurisdictional limitations relating to the crime of aggression. It focused on the EU's role in responding to political attacks against the ICC and a lack of cooperation with the ICC, as well as on the ICC's cooperation with other accountability mechanisms.

A number of country visits show DROI's firm commitment to addressing the situation of human rights, transitional justice, the rule of law and democracy with interlocutors from non-EU countries. These visits included political dialogues with a country's authorities, meetings with local civil society representatives and briefings with a range of international staff. Members visited EU-funded projects to assess the impact of EU programmes and instruments in advancing human rights priorities.

- Focus was put on the situation of people on the move, such as the precarious conditions for migrants at the [US-Mexico Border](#) (2020), the protection of Syrian refugees in [Türkiye](#) (2022) and the integration of Venezuelan migrants in Colombia (2022). Members conducted several fact-finding visits to countries

affected by political crises that had resulted in either serious democratic setbacks, such as in [Tunisia](#) (2022), or constitutional reform process, like in [Kazakhstan](#) (2022). Members also comprehensively assessed the consequences of armed conflicts for the human rights situation in several countries, including by travelling to war zones and outside capitals. They were thus able to collect first-hand information from victims of atrocities and war crimes. In [Ukraine](#) (2023), DROI members stressed Parliament's firm support for Ukraine's quest for justice and underlined their commitment to work towards effective mechanisms to bridge the existing accountability gaps, including for Russia's crime of aggression, as well as the necessity of urgently addressing the situation of civilian detainees, missing persons and abducted children. In [Ethiopia](#) (2023), DROI members condemned, in the most absolute terms, the use of rape as a weapon of war. They observed the setting up of a broad inclusive national dialogue process to which the EU continues to provide financial and political support. They expressed Parliament's support for the establishment of a victim-centred, impartial and independent transitional justice policy. Finally, Members had already shed light on the critical human rights situation in [Israel and Palestine](#) in May 2023 and the major consequences of the ongoing political deadlock for the peace process. Members stressed the necessity of urgently halting the cycle of violence and insisted on substantially increasing EU political and financial support to all those in Israel and Palestine who promote accountability, peace and equality, including human rights NGOs and stakeholders promoting peaceful and educational projects as a way of building the necessary trust to re-open political discussions. After Hamas's terrorist attack against Israel on 7 October 2023 and the Israeli military's response in the Gaza Strip, the Chair of DROI visited the [Egyptian border with the Gaza Strip](#) (2024) to get an overview of the challenges that the conflict poses from a humanitarian and human point of view and also held discussions with Israeli and Palestinian interlocutors.

- Over the past decade, Parliament has welcomed the use of trade agreements and trade preference programmes as levers to promote human rights. In the context of the new Generalised Scheme of Preferences Plus (GSP+) (as of 2024), DROI members visited [the Philippines](#) (2022) to assess the state of its compliance with human rights obligations. Members took stock of the dialogue between the Philippines and the EU on the core human rights dimension of the country's reapplication to the GSP+ preferential trade scheme. They recalled the importance of firm and actionable steps in relation to the implementation of the Philippines' obligations under the relevant international human rights conventions. In [Pakistan](#) (2022), the DROI visit allowed members to get an overall picture of the human rights challenges faced by the country. Members underlined that significant progress and renewed commitment to genuinely changing the situation on the ground were essential for Pakistan to succeed in its application process for the post-2023 GSP+. Following the ratification of the

EU-Viet Nam Free Trade Agreement, DROI members assessed human rights developments in [Viet Nam](#) (2023). They stressed the positive role played by this Free Trade Agreement in facilitating Viet Nam's economic development, while underlining their disappointment that progress had not yet materialised in the field of human rights.

- At a time when the **universality of human rights** was being challenged, DROI remained strongly committed to supporting the OHCHR's global leadership in protecting and promoting human rights worldwide. At the initiative of DROI, the European Parliament organised a [high-level conference on the 75th anniversary of the Universal Declaration of Human Rights](#). The public event was opened by Parliament President [Roberta Metsola](#) and followed by a keynote speech from [Volker Türk](#), UN High Commissioner for Human Rights. The event was a great success with a broad variety of speakers, including from the Inter-American Commission on Human Rights, the African Commission on Human and Peoples' Rights, the OSCE Office for Democratic Institutions and Human Rights, the European Court of Human Rights and the EU, with the objective of engaging with regional organisations worldwide. Other speakers included the 2021 and 2022 Nobel Peace Prize laureates, representatives from prominent human rights organisations and youth representatives. It was the combination of both institutional and local stakeholders that gave the event its added value. There was a shared understanding of the fact that Europe should remain the continent of hope in terms of protecting and promoting human rights standards, while underlining the fact that prioritising new geopolitical considerations must never come at the expense of values and principles. Guests strongly called on the EU and Parliament to uphold the EU's founding values (Article 21 of the Treaty on European Union) by not adopting short-sighted partnerships with authoritarian regimes that undermine the people and organisations working for real change in society. Emphasis was put on the EU's credibility and on the EU's actions, which must be reliable and without prejudice, so as to preserve the consistency and integrity of the international system as a whole. Any ambiguity, silence or lack of coherency can only strengthen the narrative of those who seek to tear down the international human rights system, including in Europe. Last but not least, participants expressed their strong support for EU legislation, as it sets high standards on human rights worldwide (e.g. the Directive on corporate sustainability due diligence and the Digital Services Act). Pressing challenges were also thoroughly discussed, including climate justice, digital rights, the rights of children in conflict zones and migrants' rights.

4 – Mainstreaming a more consistent human rights agenda, including in legislation and across parliamentary committees and delegations.

DROI actively contributed, in cooperation with relevant parliamentary committees, to the preparation and adoption of legislation in various EU policy areas, with the aim of

enhancing the consistency of the EU's external policies and promoting democracy, respect for human rights and the rule of law in the world. Strong focus was put on climate, trade and migration. For instance, in the field of trade and business, it focused on various pieces of legislation.

- The European Parliament consistently called on the Commission to launch a binding piece of legislation on corporate due diligence and corporate responsibility. It considered that voluntary due diligence standards had not achieved significant progress in protecting human rights, preventing environmental harm or enabling access to justice. As associated committees, the Committee on International Trade and DROI worked closely with the Committee on Legal Affairs, the lead committee on the relevant legislative own-initiative report. Parliament and the Council agreed on [new binding rules that oblige EU and non-EU companies to integrate human rights and environmental impact into their management systems](#). These rules will benefit millions of people, including children, subject to modern slavery and labour exploitation, as well as other victims of corporate negligence. These rules will also help mitigate negative impacts on the environment and biodiversity. They complement other legislative acts, such as the [Deforestation Regulation](#), the [Conflict Minerals Regulation](#) and the agreed on draft regulation prohibiting products made with [forced labour](#). For the very first time, the UN Guiding Principles on Business and Human Rights will be codified in EU law. Parliament is a strong supporter of the UN discussions on an international legally binding instrument 'to regulate, in international human rights law, the activities of transnational corporations and other business enterprises'. DROI contributed to strengthening this position through a number of opinions, [studies](#) and a meeting with the Chair-Rapporteur of the UN open-ended intergovernmental working group on transnational corporations and other business enterprises with respect to human rights (19 September 2023). This work was then reflected in the [European Parliament resolution](#) adopted on 18 January 2024, as it was deemed important to highlight Parliament's position, in view of the latest developments, both at the EU and UN levels, and it reiterated the need for the EU to adopt an ambitious mandate for negotiations in order to participate decisively in the discussions.
- The EU has a strong commitment to eliminating forced labour. In 2022, the Commission proposed a new regulation to ban all products made using forced labour from the EU market. However, this proposal was criticised, as it failed to facilitate remedies for forced labour victims, in line with EU and global standards, such as the UN Guiding Principles on Business and Human Rights. In this context, DROI addressed several aspects (e.g. access to effective remediation and changes to be introduced in the Commission's proposed regulation) by commissioning a [study](#), which enabled preparations for an [opinion](#) for the lead committees dealing with the Commission proposal

(the Committees on International Trade and on Internal Market and Consumer Protection). On March 2024, Parliament and the Council reached a [provisional agreement](#) on new rules that ban products made with forced labour from the EU market. This regulation will create a framework for enforcing this ban, including through investigations, new IT solutions and cooperation with other authorities and countries. It has several references to remediation and is a step forward in achieving fair trade and cleaning up supply chains, while prioritising human rights. The next step will be to tackle forced and state-imposed labour, while working with like-minded partners at global level.

- Since the 1970s, one of the EU's main tools to promote human rights in non-EU countries is the **Generalised System of Preferences (GSP)**, which grants certain developing countries preferential trade access to the EU market. DROI was the associated committee on the [revision of the GSP Regulation](#). DROI underlined that, although the GSP had had a positive economic impact on beneficiary countries, it had not achieved its full potential with regard to improving living standards, environmental standards or respect for human rights. DROI requested the inclusion of, among other things, an *ex ante* human rights impact assessment before the granting of standard GSP or GSP+ in order to identify any risk of human rights violations or abuses by sector in the country; increase the transparency and effectiveness of the monitoring process, strengthen the involvement of both international and domestic civil society, strengthen complaints mechanisms and make them available to HRDs and civil society organisations. DROI requested clarification on the possibility of withdrawing the preferences in the event of serious and systematic human rights violations in a particular sector. Parliament and the Council failed to reach an agreement on this during the most recent term.

Migration is a global phenomenon amplified by globalisation, rising conflicts, inequalities, climate change and environmental degradation. Migrants and refugees continue to face violations of their rights. DROI has consistently and comprehensively addressed the external dimension of the EU's migration and asylum policy.

- In the European Parliament [resolution](#) on human rights protection and the EU's external migration policy (adopted on 19 May 2021), Members stressed that, alongside the Treaty obligation to uphold the values of respect for human dignity, the EU and its Member States must also uphold human rights in their external and extraterritorial actions, agreements and cooperation in the fields of migration, borders and asylum. They recalled that the EU and its Member States have human rights obligations towards non-EU nationals when cooperating on migration with non-EU countries or other actors. Alarmed by the increasing number of informal arrangements on migration-related cooperation concluded by the Commission with non-EU countries in

[North Africa](#) without due parliamentary oversight or judicial scrutiny, on 24 January 2024, in [a joint meeting](#) with the EU Ombudsman and experts, members of DROI and the Committee on Civil Liberties, Justice and Home Affairs addressed the practical human rights implications of such deals. Focusing in particular on the then recently announced Memorandum of Understanding with Tunisia, Members questioned the concept of a 'safe third country' and stressed that the EU should not turn a blind eye to arbitrary detention and pushbacks of people on the move, but should rather protect asylum seekers from violence and open legal pathways for immigration to the EU. Members recalled that the EU and its Member States should show leadership in approaching global displacement challenges and that they have committed themselves, in the context of the Global Compact on Refugees, to sharing responsibility for the effective and comprehensive protection of refugees and to alleviating the pressure on host countries. In addition, DROI prepared Parliament's recommendation on the negotiation of status agreements between the EU and non-EU countries ([Mauritania](#) and [Senegal](#)) on operational activities carried out by the European Border and Coast Guard Agency (Frontex).

Mainstreaming climate change and human rights into all relevant EU policies remained a priority for the European Parliament. DROI members ensured that this priority guided EU external action and called on the Commission and the EEAS to act as credible and reliable partners on the world stage.

- DROI addressed the effects of climate change on human rights and the related role of environmental defenders. The [resolution](#) adopted in May 2021 prepared the ground for other related dimensions addressed by other committees (Committees on the Environment, Public Health and Food Safety and on Development), such as [biodiversity](#) loss and degradation and [access to water as a human right](#). Members highlighted the risks of human rights abuses in international commodity supply chains for both traditional and green/renewable energy, including child labour in cobalt mines, which supply the global lithium-ion battery chain. It also called on the Commission to urgently present a proposal for an EU legal framework based on mandatory due diligence to ensure that value chains are sustainable and that products or commodities placed on the EU market do not result in or derive from deforestation, forest degradation, ecosystem conversion or degradation, or human rights violations. They underlined that sustainable and accountable corporate governance was an important element of the European Green Deal. Furthermore, DROI members have condemned all forms of violence that environmental HRDs face and called for their effective protection to be guaranteed.

The Sakharov Prize for Freedom of Thought

The European Parliament's annual Sakharov Prize for Freedom of Thought was established in 1988. It is awarded to individuals who have made an exceptional contribution to the fight for human rights across the globe. The Sakharov Prize is a way for the European Parliament to draw attention to human rights violations and to support the laureates and their cause.

In the 35 years of the existence of the Sakharov Prize, eight laureates were later awarded with the Nobel Peace Prize, including recently Memorial from Russia, Ales Bialiatski from Belarus and Olexandra Matviichuk from Ukraine.

Uyghur scholar **Ilham Tohti** was awarded in 2019 for his peaceful advocacy for the rights of China's Uyghur minority. His daughter received the prize on his behalf, as he is sentenced to life in prison, despite his calls for reconciliation.

The **Democratic Opposition in Belarus**, represented by Ms Sviatlana Tsiganouskaya and nine other persons, received the Prize in 2020 for their courageous fight for human rights and democracy in Belarus.

2021 laureate of European Parliament's Sakharov Prize for Freedom of Thought

Opposition political activist and anti-corruption campaigner **Alexey Navalny** was awarded in 2021 in recognition of his courageous fight against corruption, for human rights and democracy in Russia. His daughter Yulia Navalnaya and his Chief of Staff Leonid Volkov came to Parliament on his behalf. Navalny died in prison the following year, paying the ultimate price for his fight.

In 2022, the prize went to the **Brave People of Ukraine** represented by their President, elected leaders and civil society, for their heroic resistance to the aggression against their country and their defence of freedom, democracy and European values.



Jina Mahsa Amini and the **Woman, Life, Freedom Movement** in Iran received the Prize in 2023 in acknowledgment of their struggle for freedom and equality for all women in Iran.

The Sakharov Prize Community

In 2008, when the Sakharov Prize for Freedom of Thought celebrated its 20th anniversary, the Sakharov Prize Community was launched as a platform for the human rights activities of the Sakharov Prize laureates and the Members of the European Parliament. It aims at building a culture of human rights, raising awareness on human rights issues in and outside the EU, and supporting human rights defenders around the world through common action. The Sakharov Community grows with every new laureate, but also through a dedicated instrument, which Parliament has put in place to empower human rights defenders. Since 2015, the Sakharov Fellowship Programme has been offering once a year a two-week training for 14 defenders from all over the world to strengthen them in their advocacy. Parliament keeps engaging these defenders as part of the Sakharov Community and involves them in its human rights work.
