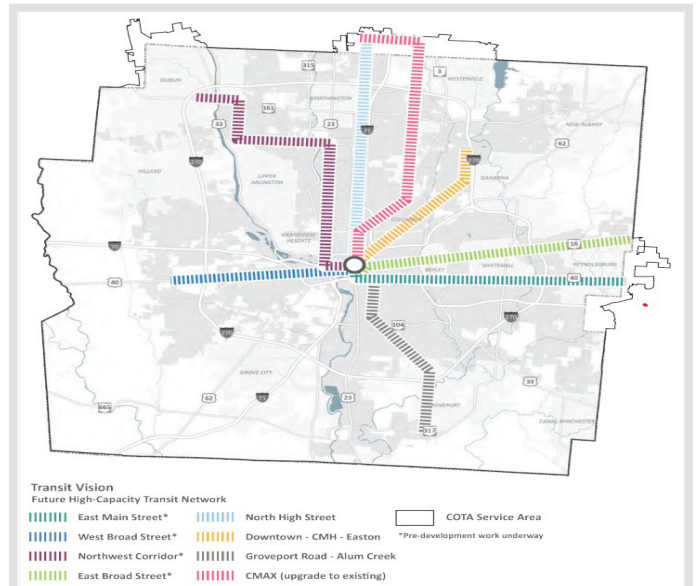

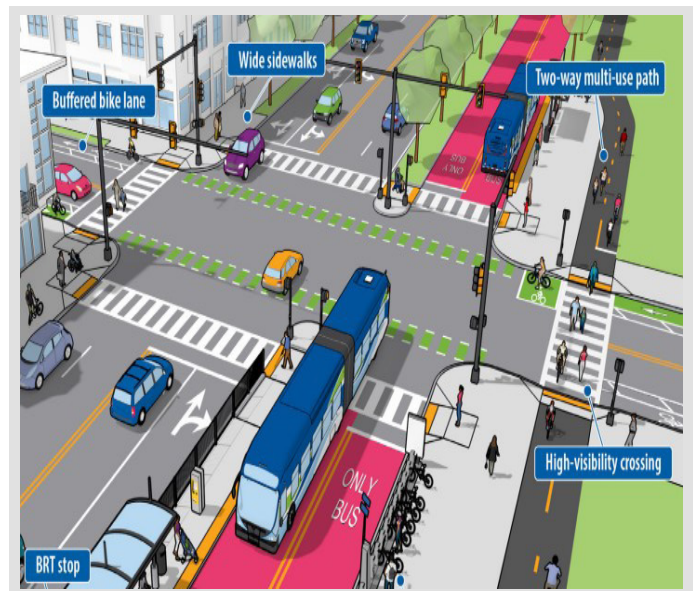

Equitable Transit-Oriented Development

Equitable Transit-oriented Development (E-TOD) creates dense, walkable, and mixed-use spaces near transit that support vibrant, sustainable, and equitable communities. E-TOD includes a mix of commercial, residential, office, and entertainment land uses. This strategic planning must be implemented to ensure developments are equitable, accessible, and sustainable. Below is an example of this approach in Central Ohio, located along the East-West LinkUS Corridor.
