

How to Avoid the Worst Sector ETFs

Question: Why are there so many sector ETFs?

Answer: ETF issuance is profitable, so Wall Street keeps cranking out more products to sell.

The large number of sector ETFs has little to do with serving your best interests as an investor. More <u>reliable</u> & <u>proprietary</u> fundamental data, proven in <u>The Journal of Financial Economics</u>, drives our research and analysis of ETF holdings and provides investors with a <u>new source of alpha</u>. We leverage this data to identify three red flags you can use to avoid the worst ETFs:

1. Inadequate Liquidity

This issue is the easiest to avoid, and our advice is simple. Avoid all ETFs with less than \$100 million in assets. Low levels of liquidity can lead to a discrepancy between the price of the ETF and the underlying value of the securities it holds. Small ETFs also generally have lower trading volume, which translates to higher trading costs via larger bid-ask spreads.

2. High Fees

ETFs should be cheap, but not all of them are. The first step here is to benchmark what cheap means.

To ensure you are paying average or below average fees, invest only in ETFs with <u>total annual costs</u> below 0.52% – the average total annual costs of the 327 U.S. equity Sector ETFs we cover. The weighted average is lower at 0.24%, which highlights how investors tend to put their <u>money in ETFs with low fees</u>.

Figure 1 shows InfraCap MLP ETF (AMZA) is the most expensive sector ETF and Schwab U.S. REIT ETF (SCHH) is the least expensive. AdvisorShares provides two of the most expensive ETFs while Fidelity ETFs are among the cheapest.

Investors need not pay high fees for quality holdings.¹ Fidelity MSCI Financials Index ETF (FNCL) is the best ranked sector ETF in Figure 1. FNCL's Neutral <u>Portfolio Management rating</u> and 0.09% total annual cost earns it a Very Attractive rating.² iShares U.S. Oil & Gas Exploration & Production ETF (IEO) is the best ranked sector ETF overall. IEO's Attractive Portfolio Management rating and 0.44% total annual cost also earns it a Very Attractive rating.

On the other hand, Schwab U.S. REIT ETF (SCHH) holds poor stocks and earns our Very Unattractive rating, despite having low total annual costs of 0.08%. No matter how cheap an ETF looks, if it holds bad stocks, its performance will be bad. The quality of an ETF's holdings matters more than its management fee.

3. Poor Holdings

Avoiding poor holdings is by far the hardest part of avoiding bad ETFs, but it is also the most important because an ETF's performance is determined more by its holdings than its costs. Figure 2 shows the ETFs within each sector with the worst holdings or <u>portfolio management ratings</u>.

Invesco appears more often than any other providers in Figure 2, which means that they offer the most ETFs with the worst holdings.

Global X Genomics & Biotechnology ETF (GNOM) is the worst rated ETF in Figure 2 based on our <u>predictive</u> <u>overall rating</u>. iShares Core U.S. REIT ETF (USRT), Fidelity MSCI Utilities Index ETF (FUTY), ProShares Kensho Smart Factories ETF (MAKX), and VanEck Green Infrastructure ETF (RNEW) also earn a Very Unattractive predictive overall rating, which means not only do they hold poor stocks, they charge high total annual costs.

Our <u>overall ratings on ETFs</u> are on our <u>stock ratings</u> of their holdings and the total annual costs of investing in the ETF.

The Danger Within

Buying an ETF without analyzing its holdings is like buying a stock without analyzing its business and finances. Put another way, research on ETF holdings is necessary due diligence because an ETF's performance is only as good as its holdings. Don't just take our word for it, <u>see what Barron's says</u> on this matter.
