- 1. **Stipend**: The stipend will be paid as per Apprenticeship Act, 1961.
- 2. **Age:** The age of the candidate should be between 18 to 25 years as on the day of application i.e. on 10.05.2024. Relaxation in upper age is admissible as per the Govt. of India guidelines for SC/ST/OBC/PH.

#### 3. Reservation:

Guidelines under Apprenticeship Act on Reservation for SC/ ST/OBC/EWS/PwBD will be followed. Applicants who are claiming reservation under above categories shall provide certificate as per Government standard format issued by the Competent Authority, failing which their claim for reservation will be considered as 'General' category only.

- Minimum Physical Standards: As prescribed in clause 4 of the Apprenticeship Rules 1992 and 4. amendments thereof if any.
- 5. Duration of Training: The duration of the training will be one year and contract would be terminated automatically after completion of the apprenticeship training period. Shortlisted candidates have to furnish undertaking that after completion of training they will not demand employment.
- 6. **Preference:** Preference for selection of Apprentice Trainees will be given as under:
  - (i) First preference will be given to candidates belonging to Champawat District.
  - (ii) Second preferences will be given to candidates belonging to Uttarakhand State.
- 7. The above mentioned vacancies may increase or decrease as per the requirement.
- 8. How to apply:
  - The candidate must go through the Terms & conditions as mentioned in this Notification. i.

If two or more candidates secure equal marks while preparing merit list, then the candidate of higher age will be considered. List of selected apprentice trainees shall be published in career section of www.nhpcindia.com website. Contract will; however, be generated in respect of the selected candidates on the website www.apprenticeshipindia.org against the applications of the candidates. The information about issue of contract shall automatically be sent to their registered Email-ID. Candidates will be required to ACCEPT as SIGN the offer in their e-mail as well the contract on the website www.apprenticeshipindia.org.
- 10. Candidates, who have already undergone Apprenticeship Training, should not apply.
- Employment in NHPC: The Apprenticeship training duration shall be of one year. The 11. Apprentice Trainees shall have no claim, whatsoever, as to any extension of training and / or employment in NHPC.
