TERMS & CONDITIONS

CONSENT TO USE NAME, IMAGE, VOICE, AND LIKENESS

REGISTRATION POLICY

All individuals attending the Academy Master Class must fill out a registration form and adhere to the following guidelines:

- The registration fee for PTC Members is USD 695 and non-members is USD 995. Registration fees must be paid in USD. All credit card transactions are processed in USD and subject to the current exchange rates; foreign transaction fees may be charged by your credit card company.
- Students who complete the Academy Master Class will receive a complimentary registration to PTC'24, which may be transferable to another individual within the same company.
- Students who complete the Academy Master Class will receive 14 Professional Development Hours and 1.4 Continuing Education Units administered by Submarine Telecoms Forum, an IACET-accredited continuing education provider. These credits are internationally accepted and can be used to satisfy a wide variety of professional requirements across a range of industries.
- A valid form of photo identification must be presented to claim registration badge and materials.
- Materials may not be picked up for another attendee unless prearranged written authorization from the registrant is received.
- PTC does not accept hotel deposits or reservations. Hotel reservations, deposits, and payment are made directly with the hotel.
