The following sample questions are not inclusive and do not necessarily represent all of the types of questions that comprise the exams. The questions are not designed to assess an individual's readiness to take a certification exam.

Question 1:

Which statement is **FALSE** regarding the loadImages action?

- A. All images are represented in a single table after loading.
- B. Images can be 3-dimensional.
- C. Images from multiple sources can be loaded in a single call.
- D. Encoded images must be decoded prior to loading.

Question 2:

Which statements are **TRUE** regarding the creation of automatic custom concept rules from textual elements in the Concept node? *(Choose two.)*

- A. Text Parsing node must precede a Concept node in the pipeline when creating automatic custom concept rules from textual elements.

Question 7:

A documents data set has a document ID, a text variable, and 3 category variables. There is a total of 13 topics. A unique ID (`__uniqueid__`) has been added to the output data set.

How many columns are in the output data set obtained from the results window of the Topics node??

- A. 29
- B. 32
- C. 19
- D. 16

Question 8:

Question 13:
