



## SachsenEnergie Successfully Adopts SEEBURGER MaKo Cloud Services



### The challenge

On March 31, 2022, the German Federal Network Agency (BNetzA) decreed that, for technical and regulatory reasons, electronic market communications in the electricity sector must start using the Applicability Statement 4 (AS4) transmission path exclusively.

A transition period was set for the implementation of AS4 beginning October 1, 2023, and ending with a mandatory switch to AS4 on March 31, 2024. This meant that all market participants had to be AS4 ready by April 1, 2024.

As a supplier, SachsenEnergie was developing a modular, highly standardized platform for private customer sales. The selection process for a reliable and scalable AS4 solution was part of this process.

In order to find a suitable partner who could implement the project in the shortest possible time to meet legal deadlines, SachsenEnergie launched a selection project to choose between a range of integration service and software providers. Several solution scenarios were developed and evaluated.

SEEBURGER impressed SachsenEnergie with its consulting and expertise based on more than 30 years of project experience in the energy industry. More than 1,000 satisfied utility customers are testament to the company's excellent reputation in the marketplace. In February 2024, just four months after the start of the official transition phase, SachsenEnergie and SEEBURGER jointly started the system configuration and integration of SEEBURGER MaKo Services into the system landscape with a very ambitious delivery date of April 1, 2024. With a planned project duration of less than two months, the focus was on a fast yet thorough implementation.

In addition to implementing the mandatory AS4 communication, the SachsenEnergie project started by migrating the previous email communication to the SEEBURGER MaKo Cloud Service:

- Configuration of the MaKo Service for email and AS4 communication
- Provision of certificates such as AS4 & S/MIME
- Market partner management
- Integration in the SachsenEnergie system landscape

SEEBURGER delivers the AS4 MaKo processes as a comprehensive service, including certificate acquisition, configuration and processing. Services for CONTRL + APER-AK-AHB testing are also available.

SachsenEnergie benefits from the flexibility in processing MaKo data from different backend systems, including Powercloud or Robotron. SEEBURGER processes market communication data in formats such as EDIFACT and offers various ways of connecting to the public cloud service.

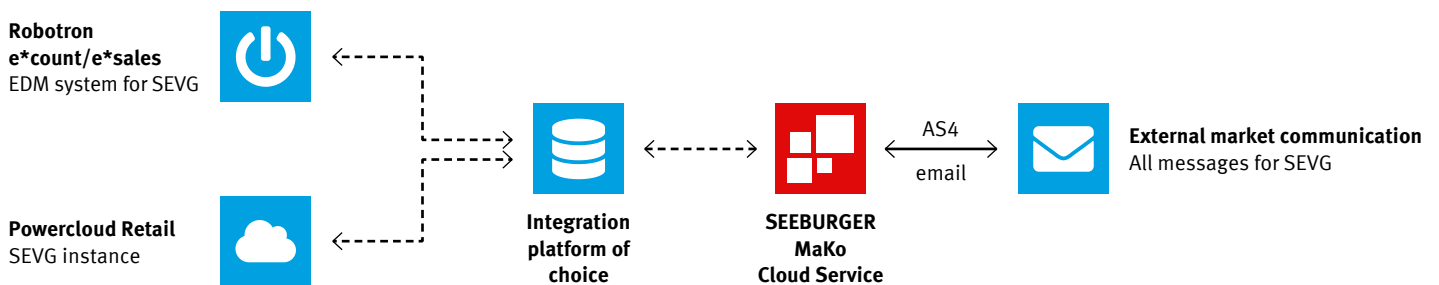
## The project at a glance
